#### I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I ("Chamber") of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rule 77 of the Rules of Procedure and Evidence.

## II. CLASSIFICATION

2. This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

## III. SUBMISSIONS

- 3. On 24 January 2022, the Prosecution disclosed to the Defence two packages of evidence consisting of 20 items (159 pages):
  - Pre-Trial INCRIM package 102, containing 7 items (81 pages), including material related to three witnesses;<sup>1</sup> and
  - Pre-Trial Rule 77 package 57, containing 13 items (78 pages), including material related to six witnesses.<sup>2</sup>
- 4. With respect to redactions, the Prosecution applied "standard" redactions to new items pursuant to the procedure for exceptions to disclosure adopted by the Single Judge of Pre-Trial Chamber II on 17 August 2020.<sup>3</sup>
