#### I. INTRODUCTION

 The Prosecution hereby notifies Trial Chamber I ("Chamber") of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

#### II. CLASSIFICATION

2. This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

### III. SUBMISSIONS

- 3. On 25 and 28 February 2022, the Prosecution disclosed to the Defence three packages of evidence, consisting of 27 items (119 pages):
  - Pre-Trial INCRIM package 105, consisting of 12 items (79 pages), including material related to witnesses DAR-OTP-P-0878 and DAR-OTP-P-0916;
  - Pre-Trial Rule 77 package 64, consisting of 14 items (34 pages), including material related to ten witnesses;<sup>1</sup> and
  - Pre-Trial Rule 77 package 65, containing one item (six pages), including material related to DAR-OTP-P-0584.
- 4. With respect to redactions, the Prosecution re-disclosed items with less redactions and applied "standard" redactions to new items pursuant to the
