Section

I. Procedural history

- 1. On 20 January 2022, Trial Chamber I ('the Chamber') issued its first decision on the Prosecution's request to introduce prior recorded testimonies under Rule 68(3) of the Rules of Procedure and Evidence (the 'Rules'), setting out the general framework for the introduction of prior testimonies pursuant to this provision (the 'First Rule 68(3) Decision').¹
- 2. On 3 February 2022, the Prosecution filed its sixth application to introduce the prior recorded testimonies of 21 witnesses pursuant to Rule 68(3) of the Rules (the 'Sixth Request').² The witnesses concerned are: P-0027, P-0059, P-0060, P-0091, P-0106, P-0119, P-0585, P-0592, P-0607, P-0617, P-0651, P-0697, P-0712, P-0725, P-0726, P-0736, P-0850, P-0894, P-0895, P-0926, and P-0980.
- 3. On 8 February 2022, the Chamber issued its decision on the Prosecution's second and third requests to introduce prior recorded testimonies under Rule 68(3) (the 'Second Rules 68(3) Decision').³
- 4. On 18 February 2022, the Defence filed its response to the Sixth Request (the 'Response').⁴

5. On 21 February 2022, the Chamber issued its decision on the Prosecution's fourth and fifth requests to introduce prior recorded testimonies under Rule 68(3) (the 'Third Rules 68(3) Decision').⁵

II. Analysis

- 6. The Chamber incorporates by reference the general framework applicable to the assessment of requests for introduction of prior recorded statements pursuant to Rule 68(3) of the Rules.⁶
- 7. In the Sixth Request, the Prosecution notes that, after *inter partes* consultation, the Defence did not agree to the introduction of the prior recorded testimonies of any of the witnesses identified in the Sixth Request.⁷ However, in its Response, the Defence stated that it does not oppose the Request in respect of witnesses P-0712 and P-0725.⁸

A. General objections raised by the Defence

- 8. First, with regard to witnesses P-0059, P-0106, P-0119, P-0585, P-0607, P-0617 and P-0651, the Defence submits that little time would be saved if each of them testified under Rule 68(3) of the Rules and that this cannot outweigh the Defence's interest in the witnesses testifying entirely *viva voce*. The Chamber reiterates that admission under Rule 68(3) contributes to the expeditious conduct of the trial.
- 9. Second, incorporating by reference its previous submissions, the Defence repeats its previous submission,¹¹ that all witness statements are inadmissible as a result of the erroneous marking as 'restricted' instead of 'confidential'.¹² This has been ruled upon by this Chamber on multiple occasions.¹³ Equally the Chamber reiterates —it is to be

hoped for the last time—that it is not necessary for the Defence to repeat submissions on which rulings have been made, in order to preserve the appeal rights of the accused.¹⁴

10. Third, for the record and to preserve Mr Abd-Al-Rahman's appeal rights, the Defence incorporates, by reference, its submissions on the absence of a valid special agreement under Article 4(2) of the Rome Statute (the 'Statute') between the Court and non-States Parties, including Sudan, where some of the witnesses in the Sixth Request may have been interviewed. The Defence does not identify any specific witness in the Sixth Request who may be the subject of this objection. The Chamber notes that this issue also has been raised in previous written and oral submissions, and previously been ruled upon. Accordingly, the Chamber will disregard this aspect of the Defence's submissions.

B. Reliability of the prior recorded testimonies

- 11. In respect of all witnesses in the Sixth Request, except for P-0712 and P-0725, the Defence incorporates, by reference, its previous submissions relating to the witness statement-taking process which in its view produces unreliable statements and which, if introduced via Rule 68(3) of the Rules would result in prejudice to the accused.¹⁹
- 12. The Defence also questions the reliability of the prior statements of P-0059, P-0060, P-0106, P-0585, P-0592, P-0607, P-0617, P-0697, P-0736 and P-0894, on the

ground that 'they either did not complete their primary education, or otherwise only received very rudimentary education'.²⁰

- 13. As regards the issues of reliability raised by the Defence, the Chamber recalls its prior rulings on the matter.²¹ In particular, the Chamber emphasises that, as determined by the Appeals Chamber, reliability is to be considered on a case-by-case basis and the Chamber has wide discretion as to whether to take into account only formal requirements, or take into account other factors.²² Moreover, Rule 68(3) of the Rules allows the Defence to cross-examine witnesses regarding their evidence, reliability and credibility.²³
- 14. Accordingly, the Chamber rejects the over-arching objections made by the Defence. This is without prejudice to the Chamber's case-by-case analysis below, particularly bearing in mind the rights of the accused.
- 15. The Chamber emphasises that the only matters it is able to consider, when making its decision on individual witnesses, are those specified in the prosecution application and the Defence Response.

C. The prior recorded testimonies

P-0027

16. P-0027, a Fur civilian, is a witness of alleged incidents in Deleig and surrounding areas, particularly in relation to the charges of torture, outrages upon personal dignity, cruel treatment, and other inhumane acts.²⁴

- As regards the accused, the witness's evidence refers to his alleged presence and actions in Deleig, and particularly outside Deleig police station.²⁵
- The prior recorded testimony of P-0027 includes three witness statements taken by the Prosecution in February 2006, November 2020 and December 2021.²⁶ Additionally, the Prosecution seeks the submission of associated material, namely, photographs and videos of P-0027, as well as P-0027's identification documents, an investigator's report and a medical certificate.²⁷
- The Prosecution requests one hour to conduct a supplementary examination (instead of the 4.5 hours estimated for *viva voce* examination).²⁸
- The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules. First, it submits that parts of the testimony refer to the alleged involvement of 'Ali Koshib' in uncharged incidents, ²⁹ as well as the charged incident in Deleig.³⁰ The Defence also refers to P-0027's evidence on the identification of 'Ali Koshib' purportedly as someone [REDACTED] and describing him as the head of the Militia/Janjaweed in Garsila.31 The Defence refers to P-0027's [REDACTED] and conversations which P-0027 overheard about him, [REDACTED] 'Ali Koshib' apparently spoke with either the President or Vice-President.³²
- The Chamber notes the Prosecution's submission that the evidence of P-0027 is 21. corroborative of, and cumulative to, other witnesses who will testify entirely viva voce on the alleged incidents in Deleig and surrounding areas, particularly the alleged targeting and detention of Fur men who were displaced to Deleig from the surrounding areas;³³ and their alleged detention and mistreatment in the open area near Deleig police station.³⁴ The Chamber further notes that P-0027's evidence in this regard is not unique

or otherwise particularly significant in the body of the expected evidence on this incident. In fact, in paragraphs 48 and 49 of the witness statement,³⁵ P-0027 accepts that he did not actually see the arrival of the Militia/*Janjaweed* in Deleig in the beginning of March 2004, but was told about it by someone else. In paragraph 50 of the witness statement,³⁶ although P-0027 is an eyewitness of the treatment of detainees at Deleig police station, his evidence in this regard is not unique and is, as noted above, corroborative of and cumulative to that of other civilians who will testify *viva voce*.

- 22. As regards the acts and conduct of the accused, and in addition to the conclusions set out previously by the Chamber,³⁷ the Chamber notes the Prosecution's submission that the evidence of P-0027 on the accused's alleged mistreatment of detainees in the open area near Deleig police station;³⁸ his alleged involvement in and supervision of the loading of detainees, including community leaders, onto vehicles, which drove out of Deleig and returned empty, is corroborative of and cumulative to that of other witnesses who will testify *viva voce*.³⁹ Further, the Chamber notes the Prosecution's submission that parts of the testimony relating to the identification and position of 'Ali Koshib' are also corroborative of and cumulative to the evidence of other witnesses who will testify entirely *viva voce*.⁴⁰
- 23. Nonetheless, the Chamber notes in particular those parts of P-0027's testimony referred to by the Defence in which the witness allegedly had direct interaction with 'Ali Koshib'. ⁴¹ P-0027 provides detailed evidence about the accused which is unique, given P-0027's alleged [REDACTED]. ⁴²

24. Although the factors discussed above are not, *per se*, an obstacle to authorising the introduction of evidence under Rule 68(3) of the Rules, in the instant case, P-0027's evidence, which is based on his alleged direct interaction with and proximity to 'Ali Koshib' during the period relevant to the charges, is sufficiently detailed and unique. Accordingly, the Chamber, in this particular circumstance, determines that it is preferable that the entirety of P-0027's evidence is heard *viva voce*.

P-0059

- 25. P-0059, a Fur [REDACTED], provides evidence relating to elements of individual criminal responsibility of the accused, particularly the actions and role of the accused as the Militia/*Janjaweed* commander in Wadi Salih.⁴³
- 26. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, three sketches drawn by P-0059 and 18 photographs of P-0059.⁴⁴
- 27. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).⁴⁵
- 28. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the senior position of 'Ali Kosheb'⁴⁶ in the Militia/*Janjaweed*,⁴⁷ as well as the physical description and nickname of 'Ali Kosheb'. ⁴⁸ The Defence notes that P-0059 describes 'Ali Kosheb' as having both of his ears pierced, whereas neither of Mr Abd-Al-Rahman's ears are pierced. ⁴⁹
- 29. The Chamber notes the Prosecution's submission that the evidence of P-0059 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged leadership position of accused in the Militia/*Janjaweed*;⁵⁰ and the

evidence on the alleged involvement of the accused in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan.⁵¹ The Chamber notes that P-0059's evidence in this regard is not unique or otherwise particularly significant in the body of the expected evidence. In fact, in paragraph 120 of the statement, [REDACTED].⁵² In paragraphs 121 and 130 referred to by the Defence, [REDACTED].⁵³

30. The Chamber notes that P-0059's description of 'Ali Kosheb' as having both of his ears pierced, is in a sense unique, [REDACTED] and allegedly saw the accused at the time. The Chamber notes that, should the Defence desire to cross-examine on this point, which –if the assertion that Mr Abd-Al-Rahman does not in fact have pierced ears be borne out by evidence– is a point which is in their favour, they will have ample opportunity to question the witness regarding the alleged physical description of 'Ali Kosheb' and any purported discrepancies between P-0059's testimony and that of other witnesses, as well as P-0059's evidence on the alleged leadership position of 'Ali Kosheb' in the Militia/*Janjaweed* and his alleged nickname. The Chamber further notes that P-0059's evidence on the nickname of 'Ali Kosheb', has little significance in the body of the expected evidence on the issue of the identity of the accused.

31. The Chamber is satisfied that the introduction of P-0059's prior recorded testimony will not occasion any prejudice to the accused.

P-0060

- 32. P-0060, a Fur [REDACTED], provides testimony on the alleged incidents in Deleig and surrounding areas, and the contextual elements of the crimes.⁵⁷
- 33. As regards the accused, the witness's evidence refers to his identity and background, his alleged position as a senior leader of the Militia/Janjaweed, his alleged

cooperation with Government of Sudan Forces, and his alleged presence and participation in the Deleig operation.⁵⁸

- 34. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, four maps and two sketches drawn by P-0060, an index, four photographs of P-0060 and an investigator's note.⁵⁹
- 35. The Prosecution requests one hour to conduct a supplementary examination (instead of the 4.5 hours estimated for *viva voce* examination).⁶⁰
- 36. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the alleged position and identity of 'Ali Koshib',⁶¹ and the alleged presence, authority and participation of 'Ali Koshib' in the Government of Sudan operation in Deleig.⁶² The Defence notes P-0060's description of the purported involvement of 'Ali Koshib' in weapons distribution and Militia/*Janjaweed* training activities in 2001,⁶³ and observes that the Prosecution does not attempt to show that this evidence is corroborative of the expected testimony of other witnesses who are due to provide *viva voce* evidence.⁶⁴
- 37. The Chamber notes the Prosecution's submission that the evidence of P-0060 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged search and arrest of Fur men displaced to Deleig from the surrounding areas;⁶⁵ the alleged detention and mistreatment of Fur civilian men in the open area near Deleig police station;⁶⁶ the alleged loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the alleged repeating of this process multiple times;⁶⁷ the alleged presence of the accused during and purported supervision of the process of

loading detainees onto vehicles;⁶⁸ the alleged sighting of a group of community leaders in a convoy with the accused in Deleig;⁶⁹ and the alleged identity of the accused.⁷⁰

- 38. As regards the acts and conduct of the accused, and in addition to the conclusions set out previously by the Chamber,⁷¹ the Chamber notes the Prosecution's submission that P-0060's evidence in relation to the accused's alleged involvement and authority in the Government of Sudan operation in Deleig is corroborative of and cumulative to other witnesses who will testify entirely *viva voce*.⁷² The Chamber also notes the Prosecution's submission that P-0060's evidence on the alleged position and identity of the accused is corroborative of and cumulative to other witnesses who will testify entirely *viva voce*.⁷³
- 39. As regards P-0060's evidence on the purported involvement of 'Ali Koshib' in weapons distribution and Militia/*Janjaweed* training activities in 2001,⁷⁴ the Chamber notes that P-0060's account, [REDACTED], constitutes a small part of the expected body of evidence on the accused's alleged role and cooperation with the Government of Sudan, particularly in relation to the distribution of weapons.⁷⁵
- 40. The Chamber is satisfied that the introduction of P-0060's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have adequate opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused. Specifically, the Defence will also have the opportunity to question the witness on the witness's evidence as regards the presence, authority and participation of 'Ali

Koshib' in the Government of Sudan operation in Deleig and his alleged role in the distribution of weapons.

P-0091

- 41. P-0091, who [REDACTED], provides testimony regarding the accused's alleged senior leadership in the Militia/*Janjaweed* and collaboration with Government of Sudan officials, including Ja'afar Abd-Al-Hakam.⁷⁶
- 42. Together with the witness statement, the Prosecution seeks the submission of a sketch drawn by P-0091.⁷⁷
- 43. The Prosecution requests one hour to conduct a supplementary examination (instead of the 4.5 hours estimated for *viva voce* examination).⁷⁸
- 44. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity of 'Ali Kosheib',⁷⁹ his alleged involvement in attacks on Bindisi and Arawalla,⁸⁰ his alleged position as 'Agid Al Oquada',⁸¹ his alleged involvement in the distribution of weapons,⁸² and his alleged involvement in the arrest and killing of approximately 123 detainees mainly from the Fur tribe and the IDP population.⁸³ The Defence also questions the credibility of P-0091, specifically referring to a part of his testimony where he recounts the content of [REDACTED].⁸⁴
- 45. The Chamber notes the Prosecution's submission that the evidence of P-0091 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged detention and mistreatment of Fur civilian men in the open area near the

Deleig police station;⁸⁵ and the alleged leadership position of the accused in the Militia/*Janjaweed*.⁸⁶

- 46. As regards the acts and conduct of the accused, and in addition to the conclusions set out previously by the Chamber,⁸⁷ the Chamber notes that P-0091's evidence on the alleged involvement of 'Ali Kosheib' in the distribution of weapons,⁸⁸ and his alleged involvement in the arrest and killing of approximately 123 detainees mainly from the Fur tribe and the IDP population,⁸⁹ are corroborative of and cumulative to other witnesses who will testify entirely *viva voce*.
- 47. As regards P-0091's testimony on the content of three documents mistakenly left behind by [REDACTED].⁹⁰ The Chamber notes P-0091's evidence in this regard. However, the Defence will have sufficient opportunity to question the witness on this issue identified as core to its case, as little else in the statement appears to be in dispute.
- 48. The Chamber is satisfied that the introduction of P-0091's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination.

P-0106

49. P-0106, a Fur cattle herder and farmer, provides evidence relating to alleged incidents in Deleig and surrounding areas; particularly in relation to the charges of murder, torture, outrages upon personal dignity, cruel treatment, and other inhumane acts. 91 P-0106 also provides information on the contextual elements of the crimes. 92

- 50. As regards the accused, the witness's evidence refers to his alleged actions in Deleig, and his alleged role in the distribution of weapons and other military equipment to the Militia/*Janjaweed*.⁹³
- 51. The Prosecution does not seek the submission of any associated material with the witness statement.⁹⁴
- 52. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination). ⁹⁵
- 53. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity and position of the Ali Kushayb, 96 his physical description, 97 his alleged leadership in the Militia/*Janjaweed*, his recruitment by Ja'far Abd-al-Hakam in the Militia/*Janjaweed*, 98 his alleged involvement in the distribution of weapons, 99 and his alleged involvement in the detention, mistreatment and murder of detainees in Deleig. 100
- 54. The Chamber notes the agreed facts relating to the background of the accused, ¹⁰¹ and the Prosecution's submissions that these facts are corroborated by P-0106. ¹⁰²
- 55. As regards the alleged incidents in Deleig, the Chamber notes the Prosecution's submission that the evidence of P-0106 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged search and arrest of Fur males displaced to Deleig from the surrounding areas; ¹⁰³ the alleged use of derogatory language towards the Fur during the Government of Sudan operation in Deleig; ¹⁰⁴ the alleged detention and mistreatment of male Fur civilians in the open area near Deleig

police station;¹⁰⁵ and the alleged loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the repeating of this process multiple times.¹⁰⁶ The Chamber notes that P-0106's evidence in this regard is not unique or otherwise particularly significant in the body of the expected evidence on this incident.

56. As regards the parts of the witness statement related to the alleged Militia/*Janjaweed* attack on Bindisi, Mara and Arawala, ¹⁰⁷ the Chamber notes these are based on hearsay and contextual information rather that P-0106 directly having witnessed these attacks. The Chamber notes that, [REDACTED] as referred to by the Defence, ¹⁰⁸ the event itself is not directly linked to the charges and only appears to provide context to the allegations that there was a search and arrests of Fur men displaced to Deleig and Mukjar from the surrounding areas. Accordingly, the evidence is not at the core of the Prosecution's case. The relevance and evidentiary weight of these parts of the witness statement will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

57. As regards the acts and conduct of the accused, the Chamber recalls its conclusions in previous decisions.¹⁰⁹ The Chamber notes the Prosecution's submission that the evidence of P-0106 on the accused's alleged presence during and supervision of the process of loading detainees onto vehicles in Deleig, stated in paragraphs 70 to 77 of the witness statement —referred to by the Defence—,¹¹⁰ is corroborative of and cumulative to other witnesses who will testify entirely *viva voce*.¹¹¹ The Chamber notes that the evidence of P-0106 on the accused's alleged involvement in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan,¹¹² is corroborative of and cumulative to other witnesses

who will testify entirely *viva voce*. Furthermore, paragraphs 31 to 33 of the witness statement referred to by the Defence, ¹¹³ which provides evidence on Ali Kushayb's alleged involvement in the distribution of weapons to Arab tribes, is based on hearsay, ¹¹⁴ is not unique, and the evidentiary weight of this assertion will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

- 58. The Chamber also notes the Prosecution's submission that the evidence of P-0106 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the identity and background of the accused, 115 and his alleged leadership position in the Militia/*Janjaweed*. 116 Although, in paragraph 24 referred to by the Defence, P-0106 purportedly claims [REDACTED], 117 the witness did not seem to have any direct interaction with Ali Kushayb and does not provide any information which might be considered unique. Parts of P-0106's evidence on the identity and background of Ali Kushayb cited by the Defence in its Response, 118 such as his physical description, his retirement from the military, and his post-retirement work as a 'medicine trader' in Garsila are not unique and corroborate witnesses who will testify entirely *viva voce* on the identity and background of Ali Kushayb. 119
- 59. As regards the alleged position of Ali Kushayb in the Militia/*Janjaweed*, parts of P-0106's evidence referred to by the Defence, ¹²⁰ such as his appointment as the head of the Militia/*Janjaweed* and his relationship with Ja'far Abd-al-Hakam, is corroborative of and cumulative to other witnesses who will testify entirely *viva voce*. ¹²¹

60. The Chamber is satisfied that the introduction of P-0106's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have adequate opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0106, the witness's evidence as regards the alleged involvement of Ali Kushayb in the Government of Sudan operation in Deleig.

P-0119

- 61. P-0119, a Fur [REDACTED], provides evidence relating to alleged incidents in Deleig and surrounding areas, and on the contextual elements of the crimes, particularly: (i) the background of the armed conflict in Darfur; (ii) armed groups involved; and (iii) Government of Sudan allegedly equipping and funding the Militia/Janjaweed [REDACTED]. 122
- 62. As regards the accused, the P-0119's evidence refers to his identity and background, and his alleged involvement in the executions of civilians in Deleig. 123
- 63. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, a military identification card, [REDACTED] and a copy of a letter.¹²⁴
- 64. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).¹²⁵
- 65. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity and position of Ali Kushayb;¹²⁶ his alleged involvement in the arrest and detention of men in villages surrounding [REDACTED] and Deleig;¹²⁷ his alleged involvement in the execution of detainees;¹²⁸ the alleged links between the Government of Sudan and the

Militia/*Janjaweed*;¹²⁹ as well as P-0119's familiarity and purported interactions with Ali Kushayb.¹³⁰ The Defence furthers argues that P-0119's evidence provides [REDACTED].¹³¹

- 66. The Chamber notes the Prosecution's submission that the evidence of P-0119 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the involvement of the accused in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan. ¹³²
- 67. As regards the identity and position of Ali Kushayb, the Chamber notes the Prosecution's submissions that P-0119's evidence is corroborative of and cumulative to other witnesses who will testify entirely *viva voce*. ¹³³
- 68. The Chamber further notes that P-0119's evidence as regards Ali Kushayb's acts and conduct in Deleig referred to by the Defence is mostly hearsay and of limited significance *vis-à-vis* the body of evidence expected during trial. ¹³⁴ In any event, the evidentiary weight of any indirect evidence of the witness will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.
- 69. As regards the purported unique character of P-0119's evidence on [REDACTED],¹³⁵ the Chamber notes that P-0119's evidence on this issue [REDACTED] ([REDACTED] at the time of the charges).¹³⁶
- 70. As regards P-0119's alleged direct interaction with Ali Kushayb, although P-0119 –in paragraph 121 referred to by the Defence– [REDACTED], his evidence as regards Ali Kushayb is neither unique nor significant, and is corroborative of and cumulative

to the evidence of other witnesses who will testify entirely *viva voce* on the identity and background of Ali Kushayb in much greater detail.¹³⁷

71. The Chamber is satisfied that the introduction of P-0119's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have ample opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0119, the witness's evidence as regards the funding of the Militia/*Janjaweed* and other Government of Sudan forces [REDACTED].

P-0585

- 72. P-0585, a Fur civilian, provides evidence on alleged incidents in Deleig, particularly relating to the charges of murder.
- 73. As regards the accused, the witness's evidence refers to his identity, his alleged senior leadership in the Militia/*Janjaweed*, and his alleged presence, authority and actions during the operation and execution of civilians in Deleig.¹³⁸
- 74. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, a map and five sketches used during the interview.¹³⁹
- 75. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination). ¹⁴⁰
- 76. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the purported identity, description, background and position of Ali Kushayb;¹⁴¹ his role in the Militia/*Janjaweed*;¹⁴² hearsay evidence that Ali Kushayb allegedly supervised the

execution of detainees in Deleig;¹⁴³ and P-0585's purported interactions with Ali Kushayb before the conflict in Darfur. ¹⁴⁴

77. The Chamber notes the agreed facts relating to the background of the accused, ¹⁴⁵ and that these facts are supported by the evidence of P-0585. ¹⁴⁶ The Chamber notes the Prosecution's submission that the evidence of P-0585 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the alleged use of derogatory language towards the Fur during the Government of Sudan operation in Deleig; ¹⁴⁷ the alleged detention and mistreatment of Fur civilian men in the open area near Deleig police station; ¹⁴⁸ the alleged sighting of a group of community leaders in a convoy with the accused in Deleig; ¹⁴⁹ the purported identity and background of the accused; ¹⁵⁰ the alleged leadership position of the accused in the Militia/*Janjaweed*; ¹⁵¹ and the alleged involvement of the accused in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan. ¹⁵²

78. Evidence relating to P-0585's purported personal interactions with Ali Kushayb is corroborative and cumulative to that of other witnesses who will testify entirely *viva voce* on the identity and background of Ali Kushayb, ¹⁵³ and supportive of the facts relating to the background of the accused already agreed by the Parties. ¹⁵⁴ Nonetheless, P-0585's evidence in this regard is sufficiently detailed and unique in relation to the

body of evidence expected during trial. ¹⁵⁵ For example, in paragraphs 58 to 61 referred to by the Defence, P-0585 states that he saw 'Kushayb' many times. ¹⁵⁶

79. Bearing in mind the indirect nature of some of the evidence provided by P-0585, insofar as relevant, the evidentiary weight of any assertion will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

80. Although the factors discussed above are not, *per se*, an obstacle to authorising the introduction of evidence under Rule 68(3) of the Rules, in the instant case, P-0585's evidence emanating from his purported encounters and interactions with Ali Kushayb is sufficiently detailed and unique. Accordingly, the Chamber, in this particular circumstance, determines that it is preferable that the entirety of P-0585's evidence is heard *viva voce*.

P-0592

81. P-0592, a Fur civilian, provides evidence on alleged incidents in Deleig in relation to the charges of murder, persecution and outrages upon personal dignity and the contextual elements of the crimes.¹⁵⁷

82. As regards the accused, the witness's evidence refers to his physical description and his alleged leadership in the Militia/*Janjaweed*. 158

83. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, a map and a drawn outline of a compound used during the interview.¹⁵⁹

84. The Prosecution requests one hour to conduct a supplementary examination (instead of the 4.5 hours estimated for *viva voce* examination). ¹⁶⁰

85. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer the identity, description and senior position of Ali Kushayb in the Militia/*Janjaweed*. ¹⁶¹

86. The Chamber notes the Prosecution's submission that the evidence of P-0592 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the alleged search and arrest of Fur men displaced to Deleig from the surrounding areas; ¹⁶² the alleged use of derogatory language towards the Fur during the Government of Sudan operation in Deleig; ¹⁶³ the survival of several persons who were allegedly taken to execution sites; ¹⁶⁴ and the alleged detention of a group of community leaders in Deleig. ¹⁶⁵ As regards the accused's alleged leadership position in the Militia/*Janjaweed*, the Chamber notes the Prosecution's submission that P-0592's evidence is also corroborative and cumulative. ¹⁶⁶

87. The Chamber notes the Defence's observation that the evidence provided by P-0592 is mostly general knowledge and hearsay. The Chamber further notes, as referred to by the Defence, that P-0592 mentions seeing Ali Kushayb once 8 months after the attack on Deleig, which is outside the period of the charged crimes and therefore has limited significance. Moreover, P-0592 states in his statement that he did not see Ali Kushayb on the day of the attack in Deleig. Thus, P-0592's evidence does not directly bear upon the core of the case for the Prosecution. The evidentiary weight of any assertion will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

88. The Chamber is satisfied that the introduction of P-0592's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules

allows for cross-examination. The Defence will have adequate opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and any other part of P-0592's evidence relevant to the Defence case.

P-0607

- 89. P-0607, a Fur civilian, provides evidence on the alleged incidents in Deleig, particularly in relation to charges of persecution, torture and cruel treatment; and the contextual elements of the crimes.¹⁷⁰
- 90. As regards the accused, the witness's evidence refers to his alleged actions near Deleig police station during the period of the charged crimes, his alleged senior leadership in the Militia/*Janjaweed*, and his alleged authority during the Government of Sudan operation in Deleig.¹⁷¹
- 91. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, two sketches and a map drawn by P-0607.¹⁷²
- 92. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).¹⁷³
- 93. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3), noting parts of the statement which refer the alleged identity and position of Ali Kushayb;¹⁷⁴ his alleged inspection of detained men at Deleig police station;¹⁷⁵ Ali Kushayb allegedly walking on the backs of detainees;¹⁷⁶ the alleged loading of groups of detainees into vehicles;¹⁷⁷ as well as Ali Kushayb's alleged role as head of the Militia/*Janjaweed*.¹⁷⁸
- 94. As regards the alleged incidents in Deleig, the Chamber notes the Prosecution's submission that the evidence of P-0607 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the alleged search and arrest of

Fur males displaced to Deleig from the surrounding areas;¹⁷⁹ the alleged detention and mistreatment of male Fur civilians in the open area near Deleig police station;¹⁸⁰ and the alleged loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the repeating of this process multiple times.¹⁸¹ The Chamber further notes that the evidence of P-0607 on the alleged incidents in Deleig is lacking in specificity about the events at Deleig police station where [REDACTED] and could therefore not fully see what was happening.¹⁸²

95. As regards the accused, the Chamber notes the Prosecution's submission that the evidence of P-0607 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged leadership position of the accused in the Militia/*Janjaweed*;¹⁸³ and the alleged mistreatment of detainees by the accused in the open area near Deleig police station.¹⁸⁴ The Chamber notes, as submitted by the Defence, that P-0607's knowledge of Ali Kushayb appears to be limited.¹⁸⁵ Furthermore, the Chamber notes that in paragraphs 47 to 57 and 60, referred to by the Defence, P-0607 prefaces his evidence by stating that at the time of the encounter he did not know Ali Kushayb, he had never seen or heard of Ali Kushayb before, did not see Ali Kushayb again after this encounter, he could not give an accurate description of Ali Kushayb, and only heard about Ali Kushayb's alleged leadership position in the Militia/*Janjaweed* from others.¹⁸⁶ The evidentiary weight of evidence of the witness will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

96. The Chamber is satisfied that the introduction of P-0607's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules

allows for cross-examination. The Defence will have ample opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0607, the witness's evidence as regards the alleged events and actions of Ali Kushayb in Deleig.

P-0617

- 97. P-0617, a Fur civilian, provides evidence on the alleged incidents in Deleig, particularly in relation to the charges of murder, persecution, and cruel treatment and contextual elements of the crimes.¹⁸⁷
- 98. As regards the accused, the witness's evidence refers to his identity, his senior leadership in the Militia/*Janjaweed*, and his alleged presence and role during the alleged incidents in Deleig.¹⁸⁸
- 99. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, five maps drawn by P-0617. 189
- 100. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination). ¹⁹⁰
- 101. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity and position of Ali Kushayb,¹⁹¹ the building of his reputation as a potential militia leader,¹⁹² and his actions and authority during the Government of Sudan operation in Deleig.¹⁹³
- 102. The Chamber notes the Prosecution's submission that the evidence of P-0617 is corroborative of and cumulative to other witnesses who will testify entirely *viva voce* on the alleged detention and mistreatment of male Fur civilians in the open area near Deleig police station;¹⁹⁴ the alleged mistreatment of detainees by the accused in the

open area near Deleig police station;¹⁹⁵ the alleged loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the repeating of this process multiple times;¹⁹⁶ the alleged killing of a group of detainees in an area outside of Deleig near Fere;¹⁹⁷ and the alleged senior leadership position of the accused in the Militia/*Janjaweed*.¹⁹⁸

103. The Chamber notes that parts of the witness statement referred to by the Defence are not unique, as regards the alleged identity and position of Ali Kushayb, ¹⁹⁹ and his alleged actions and authority during the Government of Sudan operation in Deleig. ²⁰⁰ The Chamber notes that the evidence in this regard is mostly hearsay as it emanates from what P-0617 learnt from others allegedly detained and thus limited to his position as a civilian living in Deleig at the time of the alleged incident. ²⁰¹

104. The Chamber is satisfied that the introduction of P-0617's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have sufficient opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0617, the witness's evidence as regards the building of Ali Kushayb's reputation as a potential militia leader, and Ali Kushayb's actions and authority during the Government of Sudan operation in Deleig.

P-0651

105. P-0651, a Fur civilian, provides evidence on the alleged Militia/*Janjaweed* attacks on areas surrounding Deleig as well as the alleged incidents in Deleig, particularly in relation to the charges of murder and persecution.²⁰²

- 106. As regards the accused, the witness's evidence indirectly refers to his presence in Deleig and surrounding areas.²⁰³
- 107. Together with the witness statement, the Prosecution seeks the submission of associated material, namely, three sketches drawn by P-0651.²⁰⁴
- 108. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).²⁰⁵
- 109. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3), noting parts of the statement which refer to the identity and position of Ali Kushayb;²⁰⁶ Ali Kushayb's involvement in the attacks around Mukjar and Bindisi,²⁰⁷ and on Fere,²⁰⁸ Taringa²⁰⁹ and Burbur;²¹⁰ the alleged arrest, detention and mistreatment of men in Deleig;²¹¹ and Ali Kushayb's alleged involvement in the loading of men into vehicles at Deleig police station bound for execution sites.²¹²

111. The Chamber also notes that the witness does not provide direct evidence on Ali Kushayb's alleged involvement in the attacks around Mukjar and Bindisi,²¹⁸ nor his presence during the alleged incidents in Deleig.²¹⁹ In fact, the Chamber notes that P-0651 provides no direct evidence on the accused's alleged presence or actions relating to the charges. His evidence in this regard is mostly hearsay and limited to his position as a civilian and a teenager at the time of the alleged events.²²⁰ Bearing in mind the indirect nature of the evidence provided by P-0651, insofar as relevant, the evidentiary weight of any assertion will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

112. The Chamber is satisfied that the introduction of P-0651's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have ample opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0651, the witness's evidence as regards Ali Kushayb's involvement in the attacks around Mukjar and Bindisi, and the presence of Ali Kushayb during the alleged incidents in Deleig.

P-0697

113. P-0697, a Fur civilian, provides evidence on the identity and background of the accused; the contextual elements of the crimes; the alleged Government of Sudan operation in Deleig, including by arming the Militia/*Janjaweed*, and particularly relating to the charges of murder and persecution.²²¹

114. As regards the accused, the witness's evidence refers to his identity, physical description and ownership of a pharmacy in Garsila; as well as his alleged presence during the search and arrest of men in Deleig in March 2004.²²²

115. Together with the witness statement, the Prosecution seeks the submission of a chart used during the interview.²²³

The Defence notes that the witness's knowledge about the identity and position of authority of Ali Kushayb [REDACTED] and '[REDACTED] during encounters with that man'.²⁵¹ The Defence submits that the information about Ali Kushayb's alleged presence at Deleig police station [REDACTED].²⁵² The Defence also observes that the witness's evidence on the physical appearance of Ali Kushayb is based [REDACTED].²⁵³

138. As regards the accused, the Chamber notes the Prosecution's submission that the evidence of P-0726 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the accused's identity and physical appearance, ²⁵⁸ his alleged position of authority, ²⁵⁹ and individual criminal responsibility. ²⁶⁰ The Chamber notes in particular that in paragraph 71 of the statement referred to by the Defence, ²⁶¹ P-0726 recognises that his knowledge about Ali Kushayb's alleged authority in the Militia/*Janjaweed* and during the alleged incidents in Deleig is based on what others told him. ²⁶² The Chamber further notes that in paragraphs 76 to 79 of the witness

The Defence will still have sufficient opportunity to question the witness on issues identified as core to its case, particularly the identity and alleged individual criminal responsibility of the accused.

Kushayb.²⁶⁹ The Defence notes the witness's testimony regarding Ali Kushayb's ownership of a veterinary pharmacy in Garsila,²⁷⁰ [REDACTED],²⁷¹ [REDACTED],²⁷² on the alleged leadership position and role of Ali Kushayb in the Militia/*Janjaweed*,²⁷³ and [REDACTED].²⁷⁴

146. As regards the alleged incidents in Deleig, the Chamber notes the Prosecution's submission that the evidence of P-0736 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the detention and mistreatment of Fur civilian men in the open area near Deleig police station;²⁷⁵ and the loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the repeating of this process multiple times.²⁷⁶

147. As regards the accused, the Chamber notes that the evidence of P-0736 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the identity and physical appearance, ²⁷⁷ position of authority, ²⁷⁸ and individual criminal responsibility of Ali Kushayb. ²⁷⁹ The Chamber further notes that P-0736 acknowledges that his evidence on the alleged position of Ali Kushayb in the Militia/*Janjaweed* is based on what he heard from others. ²⁸⁰ P-0736 acknowledges that his encounters with Ali Kushayb were brief and the evidence emanating therefrom, such as Ali Kushayb's ownership of a veterinary pharmacy in Garsila and Ali Kushayb using a government vehicle, is neither unique nor significant, as the witness never

interacted directly with him.²⁸¹ P-0736's evidence on Ali Kushayb's alleged role in the distribution of salary to the Militia/*Janjaweed*, is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the involvement of the accused in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan.²⁸² Furthermore, P-0736's evidence on Ali Kushayb allegedly escorting an individual to Deleig police station,²⁸³ although specific to this witness, lacks context and is not particularly significant in the expected body of evidence on the accused's alleged role and authority during the Government of Sudan operation in Deleig.²⁸⁴ In fact, P-0736 admits he could not see the premises from where he was sitting but based his account on 'common knowledge amongst all villagers'.²⁸⁵

148. Furthermore, bearing in mind the indirect nature of some of the evidence provided by P-0736, insofar as relevant, the evidentiary weight of any assertion will be considered by the Chamber in its assessment in the context of the judgment under Article 74 of the Statute.

149. The Chamber is satisfied that the introduction of P-0736's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have ample opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0736, the witness's evidence and his basis of knowledge as regards Ali Kushayb's alleged leadership position and role in the Militia/*Janjaweed* as well as his alleged encounters with Ali Kushayb.

P-0850

- 150. P-0850, a Fur civilian, provides evidence on the alleged incidents in Deleig and surrounding areas, particularly relating to the charges of murder, persecution and outrages upon personal dignity.²⁸⁶
- 151. As regards the accused, the witness's evidence refers to his identity, physical description and that he sold medicine for animals.²⁸⁷
- 152. Together with the witness statement, the Prosecution seeks the submission of associated material, namely a headdress board.²⁸⁸
- 153. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).²⁸⁹
- 154. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to Ali Kushayb and his role in the alleged incidents in Deleig.²⁹⁰ The Defence observes that witness's testimony is unclear as to how he became familiar with the name Ali Kushayb.²⁹¹ The Defence notes parts of P-0850's evidence where he [REDACTED];²⁹² [REDACTED].²⁹³ [REDACTED].²⁹⁴
- 155. As regards the identity and background of the accused, the Chamber notes the agreed facts relating to the background of the accused,²⁹⁵ and that these facts are supported by P-0850.²⁹⁶ The Chamber further notes that P-0850's evidence on the identity and background of Ali Kushayb as referred to by the Defence,²⁹⁷ is not unique nor detailed, and is corroborative of and cumulative to other witnesses who will testify

entirely *viva voce* on the identity, physical appearance and background of the accused.²⁹⁸ P-0850, in fact, accepts he never had a conversation with Ali Kushayb.²⁹⁹

156. As regards the alleged incidents in Deleig, the Chamber notes the Prosecution's submission that the evidence of P-0850 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the search and arrest of Fur men displaced to Deleig from the surrounding areas;³⁰⁰ the use of derogatory language towards the Fur during the Government of Sudan operation in Deleig;³⁰¹ the survival of several persons who were taken to execution sites;³⁰² and the killing of a group of detainees in an area outside of Deleig near Fere.³⁰³

157. As regards the accused, the Chamber notes that the evidence of P-0850 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the individual criminal responsibility of Ali Kushayb. 304 P-0850's evidence on [REDACTED], is not unique nor significant, that of a bystander, and are corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the presence of Ali Kushayb in Deleig during the period of the charged crimes. 305 In fact, P-0850 accepts that much of the information related to the context of what he saw was based [REDACTED], as she was with him at the time. 306

158. The Chamber notes that in paragraph 85 of P-0850's statement referred to by the Defence, he provided clarifications about a prior phone call conversation that he had with investigators, recorded in a screening note.³⁰⁷ The Chamber notes that clarifications made by P-0850 relate to minor parts of his evidence on the alleged attack

on [REDACTED].³⁰⁸ His evidence is also not unique or otherwise particularly significant in the body of the expected evidence on the contextual elements of the crimes.³⁰⁹

159. The Chamber is satisfied that the introduction of P-0850's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have adequate opportunity to question the witness on issues identified as core to its case, particularly the identity of the accused, and in relation to P-0850, the witness's evidence as regards his two sightings of Ali Kushayb and connected events, and the information contained in the aforesaid screening note.

P-0894

160. P-0894, a Fur civilian, provides evidence relating to the Government of Sudan Forces' alleged attack on Tanako.³¹⁰

161. As regards the accused, the witness's evidence refers to his physical description, his ownership of a pharmacy in Garsila, and his alleged role during the attack on Tanako.³¹¹

162. Together with the witness statement, the Prosecution seeks the submission of associated material, namely [REDACTED].³¹²

163. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).³¹³

164. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity, physical description, background and alleged position of authority of Ali Kushayb. The Defence notes parts of P-0894's prior recorded testimony where P-0894

[REDACTED];³¹⁴ [REDACTED];³¹⁵ and heard that Ali Kushayb was providing weapons to the Arab tribes.³¹⁶ The Defence also observes [REDACTED].³¹⁷ The Defence further claims that P-0894's evidence on Ali Kushayb leading an attack by the Militia/*Janjaweed* on Tanako falls outside the scope of the charges.³¹⁸

and that these facts are supported by P-0894.³²⁰ The Chamber also notes the Prosecution's submission that the evidence of P-0894 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the identity and background of the accused.³²¹ The Chamber further notes that the evidence of P-0894 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the alleged authority of Ali Kushayb in the Militia/*Janjaweed*.³²²

166. The Chamber notes that P-0894 allegedly had close interactions with Ali Kushayb on multiple occasions between 2000 and 2002 in Garsila,³²³ which forms the basis of his evidence on the identity and description of Ali Kushayb. P-0894 also provides hearsay evidence on Ali Kushayb's alleged role in the provision of weapons to Arab tribes, although this information is corroborative of the testimonies of witnesses who will testify entirely *viva voce*.³²⁴

167. Although [REDACTED],³²⁵ which appears to refer to the same individual. In fact, the Chamber notes that the name 'Ali Kushayb' has been used in the witness statement in connection to the same alleged events described in the screening note.³²⁶

168. As regards P-0894's evidence on the alleged attack on Tanako, although outside the scope of the charges, the Chamber notes that this evidence may still be relevant for the purpose of indirectly establishing the accused's individual criminal responsibility for the alleged incidents in Deleig. Furthermore, the Chamber notes that P-0894's evidence, as regards accused's individual criminal responsibility, corroborates the testimony of witnesses who will testify entirely *viva voce* and provide direct evidence on the accused's individual criminal responsibility for the alleged incidents in Deleig. ³²⁷ The Chamber notes P-0894's evidence as regard's Ali Kushayb allegedly beating women and raping a woman in Tanako, although not within the scope of the charges, is unique and, as stated above, may be of relevance to establish the accused's individual criminal responsibility. ³²⁸ The Chamber will assess the relevance of this aspect of P-0894's testimony in the context of the judgment under Article 74 of the Statute.

169. Although the factors discussed above are not, *per se*, an obstacle to authorising the introduction of evidence under Rule 68(3) of the Rules, in the instant case, P-0894's evidence on Ali Kushayb's alleged actions during and alleged involvement in the attack on Tanako,³²⁹ and purported description of Ali Kushayb based their multiple encounters,³³⁰ are direct, sufficiently detailed and unique. Accordingly, the Chamber, in this particular circumstance, determines that it is preferable that the entirety of P-0894's evidence is heard *viva voce*.

P-0895

170. P-0895, a Fur civilian, provides evidence on the contextual elements of the crimes.³³¹

- 171. As regards the accused, the witness's evidence refers to his background, including his place of residence and pharmacy in Garsila; his senior leadership in the Militia/*Janjaweed* and his role in the Central Reserve Forces; and his actions in Garsila and Deleig during the period of the charges crimes.³³²
- 172. Together with the witness statement, the Prosecution seeks the submission of associated material, namely one document related to the witness's remote interview.³³³
- 173. The Prosecution requests one hour to conduct a supplementary examination (instead of the 4.5 hours estimated for *viva voce* examination).³³⁴
- 174. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity, family, background, and position of authority of Ali Kushayb. The Defence submits that the evidence of P-0895 is unique since the witness [REDACTED]; and provides information on Ali Kushayb's identity, physical description, tribal affiliation, and family; Ali Kushayb's military service, background and opening of a veterinary pharmacy post-retirement; hearsay information about Ali Kushayb being shot in the arm during an incident in Nyala market; Ali Kushayb's position of authority in the Militia/*Janjaweed* and relationship with the Government of Sudan; hearsay information about Ali Kushayb beating and killing a Fur man in Deleig in 2004; and hearsay information about Ali Kushayb's involvement in the transportation of men detained in Garsila, their alleged killing in Deleig in 2004, and the murder of 83 persons in Mukjar.

175. The Chamber notes the agreed facts relating to the background of the accused,³⁴³ and that these facts are supported by P-0895.³⁴⁴ The Chamber also notes the Prosecution's submission that the evidence of P-0895 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the alleged arrest of civilians in Garsila by the accused and his men;³⁴⁵ the alleged killing of a group of detainees in an area outside of Deleig near Fere.³⁴⁶

176. As regards the acts and conduct of the accused, and in addition to the conclusions set out previously by the Chamber,³⁴⁷ the Chamber notes the Prosecution's submission that the evidence of P-0895 on the alleged leadership position of the accused in the Militia/*Janjaweed*,³⁴⁸ and his alleged recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan,³⁴⁹ is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce*.

177. Although parts of P-0895's evidence on the identity and background of the accused are corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce*, P-0895 does seem to provide information that is detailed and sufficiently unique in character relating to Ali Kushayb's pharmacy in Garsila; his purported military background; and his alleged identity, physical description, tribal affiliation and family; owing to his [REDACTED]. 354

178. The aforesaid factors are not, *per se*, an obstacle to authorising the introduction of evidence under Rule 68(3) of the Rules, in the instant case, P-0895's evidence appears to be in this aspect unique and different to that of other witnesses expected to testify about the accused and his identity. Accordingly, the Chamber, in this particular circumstance, determines that it is preferable that the entirety of P-0895's evidence is heard *viva voce*.

P-0926

179. P-0926, a Fur civilian [REDACTED], provides evidence relating to the contextual elements of the crimes.³⁵⁵

180. As regards the accused, the witness's evidence refers to his identity and background; his alleged leadership in the Militia/*Janjaweed*; cooperation with the Government of Sudan; and role in the execution of two civilians and the Garsila Popular Defence Forces coordinator in and around Deleig.³⁵⁶

181. The Prosecution submits that it also seeks introduction of P-0926's prior recorded testimony pursuant to Rule 68(3) of the Rules to prevent potential re-traumatisation of the witness, who is a victim of rape (although not within the scope of the charges).³⁵⁷

182. Together with the witness statement, the Prosecution seeks the submission of associated material, namely a sketch drawn by P-0926.³⁵⁸

183. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for *viva voce* examination).³⁵⁹

184. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity, background, position of authority of the accused in the Militia/*Janjaweed*, and his individual criminal responsibility.³⁶⁰ The Defence notes that P-0926 [REDACTED] Garsila in 2002.³⁶¹

185. The Defence submits that P-0926's description of Ali Kushayb's role and actions as the leader of the Militia/*Janjaweed* is essentially based on hearsay information.³⁶² The Defence notes that P-0926's evidence relating to the alleged responsibility of Ali Kushayb for the attack on Sindu is based on hearsay and overheard conversation of Ali Kushayb,³⁶³ and evidence on Ali Kushayb's role in the murder or persons detained in Garsila is based on hearsay.³⁶⁴

186. The Chamber notes the agreed facts relating to the background of the accused, ³⁶⁵ and that these facts are supported by P-0926. ³⁶⁶

187. As regards the alleged incidents in Deleig, the Chamber notes the Prosecution's submission that the evidence of P-0926 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on: the arrest of civilians in Garsila by the accused and his men;³⁶⁷ the killing of a group of detainees in an area outside of Deleig near Fere;³⁶⁸ the identity and background of the accused;³⁶⁹ the senior leadership position of the accused in the Militia/*Janjaweed*.³⁷⁰

188. As regards the identity and background of the accused, the Chamber notes the Prosecution's submission that the evidence of P-0926 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the identity and background of the accused.³⁷¹ The Chamber further notes that in paragraphs 16 to

35, as referred to by the Defence, P-0926 provides detailed information about the identity and background of Ali Kushayb [REDACTED].³⁷²

189. As regards the acts and conduct of the accused, and in addition to the conclusions set out previously by the Chamber, 373 the Chamber notes the Prosecution's submission that the evidence of P-0926 on the involvement of the accused in the recruitment, training, arming, funding and distribution of other resources to the Militia/*Janjaweed* by the Government of Sudan, 374 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce*. The Chamber notes that P-0926 on one occasion saw and heard Ali Kushayb instructing the Militia/*Janjaweed* [REDACTED]. 375 This evidence seems unique and significant. Other than the aforesaid evidence, the Chamber notes that P-0926's evidence on Ali Kushayb's role in the Militia/*Janjaweed* and the distribution of weapons to the Militia/*Janjaweed* is essentially based on hearsay. 376 Furthermore, P-0926's evidence on the attack on Sindu allegedly led by Ali Kushayb is based on an overheard conversation. 377

190. As regards the alleged arrests in Garsila prior to the alleged events at Deleig, the Chamber notes that, with the exception of witnessing the alleged arrest of two individuals by Ali Kushayb,³⁷⁸ the witness's evidence is based on hearsay information and assumption.³⁷⁹

191. The Chamber notes that P-0926 was raped [REDACTED].³⁸⁰ The Prosecution submits that these acts are uncharged in this case and that the introduction of P-0926's evidence under Rule 68(3) of the Rules would prevent the potential re-traumatisation of the witness if she had to repeat her full account in the courtroom.³⁸¹ The Defence submits that this argument is devoid of merit since her rape is not charged in the present

case and it does not need to be addressed at all during P-0926's examination-in-chief. 382 The Chamber recalls that it may authorise introduction of witness statement under Rule 68(3) of the Rules if it could prevent potential re-traumatisation of a vulnerable witness.383

192. Although the factors discussed above are not, per se, an obstacle to authorising the introduction of evidence under Rule 68(3) of the Rules, in the instant case, P-0926's evidence on the identity of the accused and the alleged arrests in Garsila prior to the alleged events at Deleig appear to be sufficiently detailed and unique.

193. As regards the issue of re-traumatisation, there is no reason why P-0926 should be asked to recount the event of her rape nor be made to rehearse the full content of the prior statement in court, given the fact that her rape does not form part of the charges. Accordingly, the Chamber, in this particular circumstance, is satisfied that her evidence should be heard viva voce.

P-0980

194. P-0980, a Fur civilian, provides evidence on the alleged incidents in Deleig and surrounding areas, particularly in relation to the charges of murder, torture and persecution.³⁸⁴

195. As regards the accused, the witness's evidence refers to him allegedly beating detainees while they were lying face down in front of Deleig police station and directly killing two of them.³⁸⁵

196. Together with the witness statement, the Prosecution seeks the submission of associated material, namely a document showing illustrations of different types of aircraft, a document showing Sudanese military ranks and insignia, and a sketch drawn by P-0980.³⁸⁶

197. The Prosecution requests one hour to conduct a supplementary examination (instead of the three hours estimated for viva voce examination).³⁸⁷

198. The Defence objects to the introduction of this prior recorded testimony pursuant to Rule 68(3) of the Rules, noting parts of the statement which refer to the identity, background, position of authority in the Militia/*Janjaweed*, and individual criminal responsibility of Ali Kushayb for the charged crimes in Deleig. The Defence refers to P-0980's evidence on individuals being referred to as belonging/working for Ali Kushayb, Ali Kushayb beating two detainees at Deleig police station on 5 March 2004, Ali Kushayb's conversation with Ahmad Harun in Deleig after the said beatings, and issuance of orders by Ali Kushayb following his discussion with Ahmad Harun. The Defence also notes the clarification provided by P-0980 in relation to information contained in a screening note.

199. The Chamber notes the Prosecution's submission that the evidence of P-0980 is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the search and arrest of Fur men displaced to Deleig from the surrounding areas;³⁹³ the detention and mistreatment of Fur civilian men in the open area near Deleig police station;³⁹⁴ the mistreatment of detainees by the accused in the open area near Deleig police station;³⁹⁵ the loading of detainees onto vehicles, which drove out of Deleig and returned empty, and the repeating of this process multiple times;³⁹⁶ the survival of several persons who were taken to execution sites;³⁹⁷ and the sighting of a group of community leaders in a convoy with the accused in Deleig;³⁹⁸

200. The Chamber notes that P-0980's evidence on the alleged incidents in Deleig is not unique or otherwise particularly significant in the body of the expected evidence on this incident. As such, P-0980's evidence on Ali Kushayb allegedly beating two

detainees at Deleig police station,³⁹⁹ –highlighted by the Defence in its Response– is also not unique, and is corroborative of and cumulative to that of other witnesses who will testify entirely *viva voce* on the mistreatment of detainees by the accused in the open area near Deleig police station.⁴⁰⁰

201. As regards P-0980's evidence on Ali Kushayb's alleged conversation with Ahmad Harun in Deleig after the abovementioned beatings and Ali Kushayb issuing orders to the Militia/*Janjaweed* and soldiers following this conversation,⁴⁰¹ the Chamber notes that P-0980's evidence is direct. However, the Chamber also notes P-0984's evidence is cumulative to that of other witnesses and not particularly significant in light of the larger body of evidence on the accused's senior leadership position in the Militia/*Janjaweed*,⁴⁰² and his cooperation with the Government of Sudan.⁴⁰³ Specifically, the Chamber notes that because of his status [REDACTED].⁴⁰⁴

202. The Chamber is satisfied that the introduction of P-0980's prior recorded testimony will not occasion any prejudice to the accused since Rule 68(3) of the Rules allows for cross-examination. The Defence will have ample opportunity to question the witness on issues identified as core to its case, particularly in relation to P-0980, the witness's evidence as regards the accused's alleged actions at Deleig police station.

D. Timing and scope of supplementary examination and cross-examination

203. As regards the timing of supplementary examination, and bearing in mind the object and purpose of Rule 68(3) of the Rules, the Prosecution must streamline its examination in order to complete the formalities under this provision and conduct any supplementary questioning of each witness within the estimated hour requested.

204. As anticipated in the Directions on the conduct of proceedings, ⁴⁰⁵ the Chamber will issue, in due course, a decision on the overall length and timing of the presentation of evidence by the Prosecution, and consequently the overall length and timing for the Defence's cross-examination of witnesses to be called by the Prosecution.

205. For the reasons above, and given the nature and content of the witness statements and associated material, the Chamber rejects the request in respect of P-0027, P-0585, P-0894, P-0895 and P-0926, and authorises the introduction of the prior recorded testimonies of witnesses: P-0059, P-0060, P-0091, P-0106, P-0119, P-0592, P-0607, P-0617, P-0651, P-0697, P-0712, P-0725, P-0726, P-0736, P-0850 and P-0980, identified in the Sixth Request and its annex, pursuant to Rule 68(3) of the Rules. The Chamber's preliminary ruling is subject to witnesses' appearance before the Chamber and their consent to the introduction of their testimony pursuant to this provision.
