**Judge Kimberly Prost**, acting as Single Judge of Trial Chamber X of the International Criminal Court, in the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud*, having regard to Regulation 23bis(3) of the Regulations of the Court (the ‘Regulations’), issues the present order.

1. To ensure the publicity of the record, the Single Judge finds it appropriate to issue a public redacted version of ‘Deuxième décision relative aux requêtes du Procureur aux fins de prendre des mesures nécessaires en application de l’article 56-2 du Statut pour les témoins MLI-OTP-P-0066, MLI-OTP-P-0004, MLI-OTP-P-0605, MLI-OTP-P-0582 et MLI-OTP-P-0537’ (ICC-01/12-01/18-235-Secret-Exp) and to reclassify to ‘public’ the redacted versions of ‘Décision relative aux requêtes du Procureur aux fins de prendre des mesures nécessaires en application de l’article 56-2 du Statut pour les témoins MLI-OTP-P-0066, MLI-OTP-P-0004, MLI-OTP-P-0605, MLI-OTP-P-0582 et MLI-OTP-P-0537’ (ICC-01/12-01/18-204-Secret-Exp-Red) and ‘Décision relative à la requête du Procureur aux fins de prendre des mesures nécessaires en application de l’article 56-2 du Statut pour le témoin MLI-OTP-P-0065’ (ICC-01/12-01/18-232-Secret-Exp-Red). The Single Judge also considers it unnecessary to maintain the ‘secret’ classification of these three decisions issued by Pre-Trial Chamber I.


**THE SINGLE JUDGE HEREBY**

**ORDERS** the Registry to reclassify to 'public' ICC-01/12-01/18-204-Secret-Exp-Red and ICC-01/12-01/18-232-Secret-Exp-Red; and

**REVOKES** the 'secret' classification of all versions of the three abovementioned decisions.
