Judge Kimberly Prost, acting as Single Judge of Trial Chamber X ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Al Hassan Ag Abdoul Aziz Ag Mohamed Ag Mahmoud*, issues the present order.

- The Single Judge recalls that, on 12 December 2019, it instructed the Registry to file two successive reports on the security situation in Mali. These were filed on 31 January 2020¹ and 3 July 2020.²
- 2. Noting that the Defence case is to start on Monday 9 May 2022,³ the Single Judge considers it useful to receive from the Registry updated information on the security situation in Mali.

FOR THESE REASONS, THE SINGLE JUDGE HEREBY

ORDERS the Registry to file a third report on the security situation in Mali at the latest by 6 May 2022.
