### I. INTRODUCTION

1. The Prosecution hereby notifies Trial Chamber I ("Chamber") of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a) and (b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

#### II. CLASSIFICATION

 This filing is classified as public with one confidential annex, comprising the list of evidence disclosed to the Defence. This annex is classified as confidential since it contains confidential information.

#### III. SUBMISSIONS

- 3. Between 25 May and 6 June 2022, the Prosecution disclosed to the Defence 10 packages of evidence and re-issued the metadata of two packages, consisting of 87 items (634 pages):
  - Trial INCRIM package 126, consisting of 31 items (247 pages), including material related to 6 witnesses;<sup>1</sup>
  - Trial INCRIM package 127, consisting of 4 items (37 pages), including material related to 2 witnesses;<sup>2</sup>
  - Trial INCRIM package 128, consisting of 8 items (37 pages), including material related to 3 witnesses;<sup>3</sup>
  - Trial INCRIM package 129, consisting of 5 items (9 pages), including material related to 2 witnesses;<sup>4</sup>
  - Trial Rule 77 package 85, consisting of 3 items (18 pages), including material related to 3 witnesses;<sup>5</sup>

- Trial Rule 77 package 86, consisting of 7 items (12 pages), including material related to DAR-OTP-P-0547;
- Trial Rule 77 package 87, consisting of 7 items (175 pages), including material related to 5 witnesses;<sup>6</sup>
- Trial Rule 77 package 88, consisting of 3 items (12 pages), including material related to 2 witnesses;<sup>7</sup>
- Trial Metadata Re-issue package 26, consisting of 2 items (9 pages), after re-issuing one metadata field;<sup>8</sup> and
- Trial Metadata Re-issue package 27, consisting of 17 items (78 pages), after re-issuing two metadata fields.<sup>9</sup>
- 4. With respect to redactions, the Prosecution applied "standard" redactions to new items pursuant to the procedure for exceptions to disclosure adopted by the Single Judge of Pre-Trial Chamber II on 17 August 2020.<sup>10</sup>
