#### I. INTRODUCTION

1. The Office of the Prosecutor ("Prosecution") submits this communication regarding the disclosure of evidence.

### II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

#### III. SUBMISSIONS

- 3. On 9 June 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani "Pre-Trial INCRIM package 075" containing 15 items, "Pre-Trial Rule 77 package 039" containing 383 items, "Pre-Trial Rule 77 package 039" containing 132 items and "Pre-Trial Reclassification to Rule 77 package 001" containing 21 items.
- 4. The disclosure of "Pre-Trial INCRIM package 075" consists of consists of materials which are relevant to the OCRB as well as aspects of the chapeau elements of article 7 and 8 of the Rome Statute that are classified as incriminatory evidence. This package includes witness documents, investigation reports and a corrected attribution and CST Annex<sup>1</sup> for SAID Telecommunications Report which replaces CAR-OTP-2136-0683.
- 5. The disclosure of "Pre-Trial Rule 77 package 039" consists of witness documents that are deemed material to the preparation of the Defence. This package includes photographs taken by witness P-0342.
- 6. The disclosure of "Pre-Trial Rule 77 package 040" consists of witness documents that are deemed material to the preparation of the Defence. This package includes
