- 1. The Defence for Mr Ali Muhammad Ali Abd-Al-Rahman ("Defence") responds to the Prosecution's second request for in-court protective measures ("Request")¹, which concerns seven witnesses: (i) one insider, and (ii) six crime-base witnesses. ² Pursuant to Regulation 23*bis*-2 of the Regulations of the Court, its response is filed publicly, mirroring the public redacted version of the Request, as it makes no reference to confidential information redacted therefrom.
- 2. The Defence does not oppose the relief requested by the Prosecution in its Request. The Defence further points out that the Prosecution, once again, motivates its request by referring to the ongoing precarious security situation in Darfur.³ In this regard, the Defence reiterates its full support for requests of the kind and incorporates by reference its submissions on the Court's mandate of protecting witnesses in Sudan, as laid out and recalled in its Response to the First Prosecution's request for in-court protective and special measures⁴, which militate in favour of granting the relief sought by the Prosecution.⁵
- 3. Finally, the Defence reiterates that its support for the Request should not be construed as an admission that any of the risks bearing on the witnesses can be attributable to Mr. Ali Muhammad Ali Abd-Al-Rahman or any of his purported supporters should it be suggested in the Request nor as an acceptance of the admissibility of the evidence the Prosecution may wish to introduce through these witnesses.
