I. NOTIFICATION

1. Pursuant to Pre-Trial Chamber II's ("Chamber") 27 June 2022 "Order on the conduct of the confirmation of charges proceedings", and in compliance therewith, the Prosecution confirms that it has disclosed to the Defence of Maxime MOKOM all of the evidence underlying its Application for a Warrant of Arrest ("AWA").

III. DISCLOSURE OF EVIDENCE
