## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 7 July 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 079” containing 1 item, “Pre-Trial Rule 77 package 044” containing 15 items and “Pre-Trial Other package 013” containing 200 items and “Pre-Trial Metadata Update package 011” containing 1 item.

4. The disclosure of “Pre-Trial INCRIM package 079” consists of the English translation of P-2280’s statement.

5. The disclosure of “Pre-Trial Rule 77 package 044” consists of witness documents that are deemed material to the preparation of the Defence. This package includes victim applications, documents related to witnesses P-1883 and P-3033 and a request for information or assistance document and its annex.

6. The disclosure of “Pre-Trial Other package 013” consists of documents related to witnesses P-1578, P-1875, P-1962, P-2028, P-2035, P-2125, P-2133, P-2203, P-2207, P-2230, P-2299, P-2389, P-2390, P-2420, P-2450, P-2452, P-2453, P-2471, P-2525, P-3065, P-3080 and P-3086. The Prosecution provides these items for the sake of completeness as part of its ongoing review of the evidence and under the legal classification of

“Other” as they do not obviously include information material to the preparation of the Defence under rule 77 of the Rules of Procedure and Evidence.

7. The disclosure of “Pre-Trial Metadata Update package 011” consist of a French translation of an audio-video re-disclosed with a correction in metadata field language of item.
