## I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

## II. CONFIDENTIALITY

2. The Annexes, appended to this filing, are classified as confidential as they relate to evidence disclosed *inter partes* that should not be released to the public.

## III. SUBMISSIONS

3. On 4 August 2022, the Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Pre-Trial INCRIM package 082” containing 254 items, “Pre-Trial Rule 77 package 048” containing 28 items and “Pre-Trial Rule 77 package 049” containing 95 items.

4. The disclosure of “Pre-Trial INCRIM package 082” consists of the re-disclosure of items previously disclosed, now with lesser redactions.

5. The disclosure of “Pre-Trial Rule 77 package 048” consists of items that are deemed material to the preparation of the Defence.<sup>1</sup> This package includes photos, media articles, an investigator report, and email exchanges from Yahoo email accounts.<sup>2</sup>
