PRE-TRIAL CHAMBER I (the 'Chamber') of the International Criminal Court issues this decision on the 'Prosecution request for leave to reply to "OPCD Observations on the Prosecution's Request to Hold a Hearing on the Confirmation of Charges against Joseph Kony in his Absence" (ICC-02/04-01/05-458)' (the 'Leave to Reply Request').¹

I. PROCEDURAL HISTORY AND SUBMISSIONS

- 1. On 8 July 2005, the Chamber (in a previous composition) issued the 'Warrant of Arrest for Joseph Kony', which was amended on 27 September 2005 (the 'Arrest Warrant').
- 2. On 24 November 2022, the Prosecution requested to hold a confirmation of charges hearing in the absence of Mr Kony (the 'Prosecution Request').⁴
- 3. On 7 February 2023, the Chamber invited observations from the Registry and the Office of Public Counsel for the Defence (the 'OPCD'), as well as views and concerns of victims in relation to the Prosecution Request.⁵
- 4. On 30 March 2023, the OPCD filed its observations (the 'OPCD Observations').⁶ On the same day, the OPCV transmitted to the Chamber the views and concerns of the victims,⁷ and the Registry submitted a report on the measures taken to locate Mr Kony.⁸
- 5. On 3 April 2023, the Prosecution sought the Chamber's leave to respond to 'a specific issue' raised in the OPCD Observations. The Prosecution submits that it could not have reasonably anticipated that the OPCD would put into question the

Prosecution's ability to expand the factual basis of the charges beyond that for which a warrant of arrest was issued,⁹ and it wishes to file a reply of no more than five pages.

- 6. On 5 April 2023, the OPCD responded to the Leave to Reply Request, indicating that it is not clear what the Prosecution seeks to reply to, but deferring to the Chamber's discretion to determine if further submissions are necessary.¹⁰
- 7. As part of the proceedings following the Prosecution Request, the Chamber instructed the Registry on 6 April 2023, via email, to submit an amended report on the measures taken to find Mr Kony, inform him of the charges and secure his appearance before the Court, by 26 April 2023, at the latest.

II. DETERMINATION BY THE CHAMBER

8. The Chamber emphasises that it does not need to receive submissions, or observations as the case maybe, on the correct interpretation of the law. Moreover, the matter the Prosecution wishes to reply to is neither a new issue raised in the OPCD Observations that the Prosecution could not have reasonably anticipated, nor does the Chamber consider that the proposed reply would assist the Chamber in its determination of the Prosecution's Request.
