**Trial Chamber II** of the International Criminal Court, in the case of *The Prosecutor v. Bosco Ntaganda* (the ‘Ntaganda case’), having regard to article 75(2) of the Rome Statute and Rule 144(1) of the Rules of Procedure and Evidence, issues this Order Scheduling a Hearing for the Delivery of the Addendum to the Reparations Order of 8 March 2021, ICC-01/04-02/06-2659.

**THE CHAMBER HEREBY**

**ANNOUNCES** that it will hold a public hearing on Friday, 14 July 2023 at 16:00 pm, in a Courtroom to be determined, to deliver its Addendum to the Reparations Order of 8 March 2021, ICC-01/04-02/06-2659, in the presence, live or remotely, of the Mr Bosco Ntaganda, his defence team, and the Legal Representatives of Victims;

**INSTRUCTS** the Registry to assess the possibilities of securing the attendance of the convicted person either physically at the seat of the Court or through the use of video technology and report back to the Chamber by Wednesday, 12 July 2023, at the latest; and

**INVITES** the Trust Fund for Victims and the Office of the Prosecutor to attend this hearing.
