In accordance with the communication dated 2 March 2022 submitted by the United Kingdom of Great Britain and Northern Ireland on behalf of 38 States Parties to the Rome Statute, the Republic of Poland has the honour to confirm that, acting pursuant to Article 13, paragraph a, and the Article 14, paragraph 1 of the Rome Statute, it decides to refer the Situation in Ukraine to the Prosecutor of the International Criminal Court for the purpose of requesting the Prosecutor to investigate any acts of war crimes, crimes against humanity and genocide alleged to have occurred on the territory of Ukraine from 21 November 2013 onwards, including any allegations of current and ongoing crimes occurring throughout the territory of Ukraine, thereby requesting the Court to exercise its jurisdiction with respect to the jurisdictional scope accepted by Ukraine.
