The information is rather general and the Defence has redacted more specific examples of the same kind of information elsewhere in the filing. Therefore, for the sake of consistency, it would make sense to redact this last sentence.

If the Trial Chamber considers that this information is identifying, then the Defence requests reclassification of ICC-01/14-01/18-1377-Red to confidential and will re-file the public redacted version with redactions applied.
