Honourable Trial Chamber x,
Dear Colleagues,

In its Annexes to the Prosecution's Third Request for the Admission of Documentary Evidence from the Bar Table (ICC-01/12-01/18-2079-Conf-AnxA and ICC-01/12-01/18-2079-Conf-AnxB), the Prosecution has provided substantive argument in table format. As with its previous submissions, this approach facilitates understanding of the arguments relating to each of the 30 tendered items.

Consistent with this, and in order to avoid importing undue confusion or additional labour on the part of the reader, the Defence has again prepared its Response in part by providing an additional column such that each submission can be read in its context. For both Annexes together, this amounts to c. 2,850 additional words, equivalent to approximately 8 pages in filing format. The substantive filing is 11 pages long, so, taken together, the Defence submissions fall within the 20 page limit.

For all the reasons herein, the Defence respectfully requests permission exceptionally to include arguments in the Annexes.
