On 19 October 2022, the Defence responded that, as discussed with the Prosecution, it did not object to the submission of the annexes, under the sole condition that the sentence '[REDACTED]' is redacted from Annex B, p. 4 - DAR-OTP-00000367-000004 (see attached email of 19 October at 9:20).
