I regret to inform the Chamber, Parties and Participants that Ms Guissé and myself have tested positive to COVID 19 yesterday and today, respectively, and as such will be unable to attend next week's scheduled hearings until Thursday at earliest.

Further, and contrary to previous occasions, neither Yekatom Defence counsel will be able to attend next week's hearings remotely, given the importance of the anticipated evidence from the witnesses scheduled during this current evidentiary Block for Mr. Yekatom. As the Chamber is aware, the Defence had anticipated 6 to 8 and 16 hours of examination for P-0954 and P-1839, respectively. Even assuming either myself or Ms Guisse would be well enough to appear and examine, remote attendance would impede Defence Counsel's ability to properly hear the evidence, intervene if and when necessary, and communicate with Mr. Yekatom and other team members. Indeed, I also note that remote attendance does not allow Defence counsel to view the witness at all times, nor does it permit to view the items of evidence presented. In the circumstances, I respectfully submit that we not be in a position to effectively represent Mr Yekatom over the next week.

I would like to convey that every alternative option has been explored, with the aim of finding workable solutions to avoid disruption of the schedule. However, other team members with rights of audience have been preparing for other witnesses, and have not been closely involved in the preparation of P-0954 or P-1839, which rules out the possibility for them to examine this witness in the absence of both Counsels, especially on such short notice. Further, given that these team members have been in close contact with Counsel over the past week, there is also the possibility that they also test positive over the coming days.

However, conscious of the fact that arrangements have been made for the short appearance of P-2625 with his assigned Counsel in order to administer the solemn declaration and instruct the witness to refrain from contact, in order to avoid disrupting this specific schedule, both Ms Dimitri and Ms Guissé would be ready, with the Chamber's leave, to appear remotely via video-link for that short period of time.

We sincerely apologise for the disruption caused.
