 Dear Defence,

With regard to filing ICC-01/09-01/20-314 (Prosecution's notice of completion of its presentation of evidence), the Chamber notes that in paragraph 6 of the motion the Prosecution 'requests leave to file the anticipated Bar Table Motion and any ancillary requests by 8 April 2022'.

The Chamber hereby informs the parties that all decisions on items requested for formal submission in relation to witnesses having testified before the Chamber will be rendered before the end of the week, COB Friday, 1 April 2022.

Since this was the argument of the Prosecution why it had to wait filing a further request to submit evidence other than through a witness (para. 2 of the motion), the Chamber instructs the Prosecution to file its request by **Tuesday, 5 April 2022**.

This will provide sufficient time for the Defence to file a response before the spring recess.

The Chamber instructs the Defence to file a response to any request made by the Prosecution by **Thursday, 13 April 2022**.
