Associates	Individuals associated with the activities of the Common Plan, who played greater or lesser roles in the events surrounding the corrupt influencing of the eight Prosecution Witnesses, but whose contributions to the Common Plan were not essential to its execution. These include Elisha Kipkorir BUSIENEI (“BUSIENEI”); Corrupted Witnesses P-0397, P-0800, P-0495 P-0516, and P-0341; Sammy Kiptanui KOSGEI (“KOSGEI”); P-0015; P-0017; and KOGO
Bribes	Financial benefits, including cash payments, land and houses, vehicles, educational support and employment opportunities
Charged Offences	The offences charged in Counts 1 to 8 under Section C of the DCC
Charges	Including all material facts and their legal qualification (under both article 70 and article 25), and precise form of participation
Common Plan	The Common Plan encompassed the identification, location and contacting of Prosecution Witnesses, and offering and/or paying them financial benefits, and/or threatening or intimidating them, in order to induce them to withdraw as Prosecution Witnesses, refuse to or cease cooperating with the Prosecution and/or the Court, and/or recant the evidence which they had provided to the Prosecution
Common Plan Members or Common Plan Group	Members of the Common Plan, including Managers, and Intermediaries
Common Purpose and Common Purpose Members	Group of persons acting pursuant to a common purpose to corruptly influence Prosecution Witnesses by committing the types of offences charged in Counts 1 to 8 , including Managers, Intermediaries and Associates.
Co-perpetration	Direct co-perpetration , unless otherwise specified
Corrupted Witnesses	P-0397, P-0800, P-0495 P-0516, and P-0341
Direct Perpetrators	Intermediaries Walter Osipiri BARASA (“BARASA”), Philip Kipkoech BETT (“BETT”), and Meshack YEBEI (“YEBEI”); and Associates/Corrupted Witnesses BUSIENEI, KOSGEI, KOGO, P-0397, P-0800, P-0516, P-0495 and P-0341.

Intermediaries	Persons acting as intermediaries between the Managers and Prosecution Witnesses, including BARASA , BETT and YEBEI.
