Dear Trial Chamber VI,

The Prosecution respectfully requests the Trial Chamber, to allow it to add a map of the Central African Republic ("CAR") (CAR-OTP-2070-0268), to the Prosecution's List of Evidence, pursuant to paragraph 26 of the Decision Setting the Commencement Date of the Trial and Related Deadlines (ICC-01/14-01/21-243). The map was produced on 20 December 2013, it offers a more comprehensive and fuller details of areas where evidence shall be elicited from several prosecution witnesses during its presentation of evidence. In particular that of the Seleka advance into Bangui in early 2013. The Prosecution submits that the use of this map will greatly assist the Chamber, Parties and Participants to understand better the testimony of witnesses. While the Prosecution has included other maps on its List of Evidence, the requested map is more comprehensive, detailed and close to the period relevant in the present case, which allows the Chamber, Parties and Participants to better follow the witnesses' testimonies.

The Defence will suffer no undue prejudice. The map was disclosed to the Defence on 28 June 2021 in the "Pre-Confirmation INCRIM package 026". The item is a one-page single document produced by a neutral third-party (Logistics Cluster), which contains no information about the acts and conduct of the Accused. If leave to add the map is granted, the Prosecution intends to rely on the map for the first time on 24 October 2022, during the testimony of P-2105 providing more than one weeks' notice for the Defence to review the item.
