The Chamber has reviewed the exhibits mentioned by the Court Officer and notes the following:

CAR-REG-0002-0040: The Chamber observes that, although the bottom part of the picture is blackened out, the annotations made by the witness are still visible.

CAR-REG-0002-0041: The Chamber observes that, although the bottom part of the picture is blackened out, the annotations made by the witness are still visible.

CAR-REG-0002-0042: The Chamber observes that this exhibit appears unaffected.

CAR-REG-0002-0043: The Chamber observes that this exhibit appears unaffected.

CAR-REG-0002-0044: The Chamber has reviewed today's transcript (T-024-ENG, p. 75, lines 6-20) and notes that the witness made reference to six numbers, however, numbers 3, 4, 5 are the only numbers visible on the exhibit.

CAR-REG-0002-0045: The Chamber observes that this exhibit appears unaffected.

The Chamber notes that all the annotations made on CAR-REG-0002-0040, CAR-REG-0002-0041, CAR-REG-0002-0042, CAR-REG-0002-0043 and CAR-REG-0002-0045 are clear when read in line with the transcript and do not require any further action.

However, in respect of CAR-REG-0002-0044, as several annotations are now missing, the record is incomplete.

Accordingly, should the Prosecution wish to repeat the exercise with the witness in respect of this item at the start of this morning's session, it will be provided an opportunity to do so.
