On 18 August 2023, the Common Legal Representative of the former child soldiers (the "CLR1") submitted to the Victims and Witnesses Section (the "VWS") [REDACTED] Witnesses CAR-V45-P-0001 and CAR-V45-P-0002.

On 21 and 22 September 2023, Witness CAR-V45-P-0001 testified at the seat of the Court. On 26 and 27 September 2023, Witness CAR-V45-P-0002 also testified at the seat of the Court.
