Dear Pre- Trial Chamber II,


The Defence by way of this email would like to offer an update regarding the disclosure of material from the migration and to seek the Chamber's leave to file a corrigendum reflecting the recent change in the ERNs of items disclosed from the migration.

As instructed by The Chamber, the Defence was required to re-disclose any material it wishes to rely upon from the migration (email 3 July 2023 at 16:52). For this purpose, the Defence sought guidance from CMS (email 13 July 2023 13:07) and CMS in turn advised to "re-import (recreate) the documents [...] and assign them the defence ERN" (email 13 July 2023 at 15:50) as the original migrated items did not exist in Defence JEM and were only available through Registry JEM.

In accordance with this guidance, the Defence then proceeded to re-stamp and disclose 34 items from the migration that initially bore OTP ERNs in disclosure packages "Pre- Confirmation Rule 78 D34 package 004 14 July 2023" and "Pre- Confirmation Rule 78 D34 package 005 31 July 2023". The Prosecution (emails 31 July 2023 12:50 & 01 August 2023 12:33) conveyed its concerns to the Defence and CMS regarding re-stamping documents. Subsequently, the Defence engaged in a series of consultations with Court Officers and E-Courts to find an alternative to re-stamping.

Last week, E- Courts finally facilitated access of the original migrated items bearing OTP ERNs within Defence JEM. As a result, the Defence was able to re-disclose them yesterday, 6 September via a metadata update "Package 005"; maintaining a single OTP stamp and changing the metadata field "Participant" from OTP to D34. Furthermore, CMS has also removed the double stamped items from Registry JEM.

The Defence respectfully seeks the leave of the Chamber to file a corrigendum to its List of Evidence to reflect the change in the ERNs to the 34 items.
