Dear counsel,

At the outset, the Chamber recalls that, in accordance with regulation 53 of the Regulations of the Court, its decision on the Prosecution's request to confirm the charges against Mr Mokom will be issued in written form only. The Chamber's decision may be issued at any time up until the expiry of the 60-day time limit contained in this regulation.

Furthermore, the Chamber considers that, in the circumstances of the present case, the time limit set by the Chamber for the final written submissions constitutes 'the date the confirmation hearing ends' under regulation 53 of the Regulations of the Court. Accordingly, the Chamber's decision shall be issued, at the latest, 60 days after 20 October 2023 irrespective of the actual date of submission of the Defence's reply.

Given the start of the judicial recess on 15 December, we would be grateful if the Pre-Trial Chamber could clarify whether the 60-day time limit for the issuance of the confirmation decision will start running following the expiry of the deadline for the Defence reply, being 20 October 2023, or from the date of submission of the Defence reply, should we file before the deadline.

The Defence also respectfully asks to be provided with notice of the date for delivery of the confirmation decision 30 days in advance, to allow for the Defence to make the arrangements necessary for presence in The Hague.

Dear Counsel,

On 21 September 2023, Pre-Trial Chamber II granted the parties' requests to vary the time limits pertaining to the responses to be submitted by the Prosecution and Defence to the submissions provided following the confirmation of charges hearing to 29 September 2023, and the reply to be submitted by the Defence to the Prosecution's response to 5 October 2023.

In light of the fact that technical issues continue to affect the Court's operations and with a view to ensuring that the parties have adequate time and facilities to provide meaningful submissions, Pre-Trial Chamber II, acting proprio motu, further varies these time limits under regulation 34 of the Regulations of the Court.

Accordingly, the Prosecution and the Defence shall submit their responses to the submissions provided following the confirmation of charges hearing by no later than 16:00 hours on 13 October 2023. Furthermore, the Defence shall submit its reply to the Prosecution's response by no later than 16:00 hours on 20 October 2023. The Prosecution and the Defence shall submit public redacted versions of their responses and reply, as applicable, as soon as possible.
