Dear Counsel, dear colleagues from the Registry,

The Chamber takes note of the Prosecution emails from 23 August 2023, at 18:36; 13 November 2023, at 10:50; and 14 November 2023, at 13:24 (*attached herewith*).

First, the Chamber notes that CAR-OTP-2106-0563 and CAR-OTP-2106-0570 were discussed by P-2416 in his prior recorded testimony (*see* ICC-01/14-01/18-1833-Conf-Corr, para. 195). In this regard, the Chamber clarifies that Annexes 35 to 38 (CAR-OTP-2106-0563 to CAR-OTP-2106-0564) and Annexes 46 to 51 (CAR-OTP-2106-0569 to CAR-OTP-2106-0571) should have been recognised as formally submitted pursuant to Rule 68(2)(b) of the Rules, but were inadvertently omitted from paragraph 199 and in the disposition section of the aforementioned decision. A corrigendum will be filed shortly.

<u>Second</u>, with regard to CAR-OTP-2000-0634, the Chamber recalls that it recognised as submitted the French portion, from 00:00:00 to 00:11:23, deferring its decision on the Sango portion of the item until the Prosecution disclosed the corresponding transcript and translation into a working language of the Court (*see* ICC-01/14-01/18-2179, para. 23, pp. 10-11). Having now reviewed the French translation of the transcript (CAR-OTP-00002015), and in the absence of any procedural bars and objections from the rest of participants, the Chamber recognises as formally submitted the remainder of CAR-OTP-2000-0634, from 00:11:23 to 00:22:43, together with CAR-OTP-00002015.

<u>Third</u>, with regard to CAR-OTP-2008-0892, the Chamber recalls that it rejected its submission without prejudice, unless the Prosecution provides a readable version thereof (*see* ICC-01/14-01/18-2199-Conf, para. 30). Having now reviewed this version, together with a courtesy transcription provided by the Prosecution, the Chamber, in the absence of any procedural bars and objections from the rest of participants, recognises CAR-OTP-2008-0892 as formally submitted.
