ICC-02/04-01/05 - KONY Disclosure Plan

The table below outlines the Prosecution's proposed Disclosure Plan, with items contained in thematic disclosure packages specific to Mr Kony's criminal responsibility, contextual evidence, and charged attacks, including systemic charges and gender-based crimes directly perpetrated by Mr Kony.

Disclosure of the evidence is planned to commence on 15 April through JWP, and thereafter, every Thursday, until 6 June 2024. While items have been tagged to relevant thematic packages, the Prosecution still has further work to do to finalise the packages to be disclosed, as such the figures outlined below are preliminary and approximate.

The packages to be disclosed on a weekly basis may vary in size and number. However, the Prosecution expects that the Defence will be better able to navigate the evidence to be disclosed, where each thematic disclosure package will include the complete classification of items which falls under INCRIM, Rule 77 and PEXO. If PEXO is identified within an item that is to be disclosed as INCRIM, this will be highlighted in the external disclosure note for the benefit of the Defence.
