Dear Trial Chamber VI,

I hope this e-mail finds you well.

On 26 October 2022 the first session of the trial hearing was conducted in closed session due to a technical issue in the courtroom. The second and third session on that day were conducted in open session, with private sessions where necessary. The witness appearing before the Chamber on that hearing day was P-2105 who was granted full in-court protective measures and had Mr. Raimondo as their Rule 74 Counsel.

Due to the first session having taken place in closed session, we are reaching out to you to offer our assistance with the re-classification of the transcript and the AV recording. Therefore, we would like to propose the following process to pursue this task. Registry/Court Management (CMS) proposes to provide the most up to date CT version of the transcript of that day, in English and French, to the parties and participants for them to review and indicate by highlighting the relevant portions what they would request to be redacted from the transcript, before that portion of the transcript could be reclassified as public. In order to assist the parties and participants with the review of this session, CMS can temporarily provide them with a copy of the AV material (LIVE version including protective measures) to review, as well.

Once the Chamber has reviewed the proposed redactions and ruled on them, CMS would then undertake the implementation of those redactions in the transcripts, as well as on the AV material for the hearing. For the implementation of the redactions on the AV material, the Court Officer would prepare a Post-Facto redaction request that would also be filed on the case record.

The Registry minutes of the hearing on that day would also be updated to reflect the agreed-upon process and re-classification of the transcript and AV material.
