Dear Common Legal Representatives,

I am writing to you further to the "Order in relation to the Prosecution's 'Notice of Withdrawal of the Charges against Maxime Jeoffroy Eli Mokom Gawaka'" (ICC-01/14-01/22-276), dated 17 October 2023 ("Order"), in the case of the *Prosecutor v. Maxime Jeoffroy Eli Mokom Gawaka*, as well as a meeting we had together with VPRS colleagues two weeks ago.

Noting that the Order was rendered one month ago, the Registry expects that the LRV have commenced, by now, to duly inform their clients if not already done so. Noting further that your mandate will have formally ended upon having informed your clients of the Order, the Registry has nonetheless continued to remunerate you, to finalise any pending matters pertaining to the case of the *Prosecutor v. Maxime Jeoffroy Eli Mokom Gawaka*.

As indicated previously, the Registry is amenable to provide you with the necessary resources for a transition period of three months, from the Order; that is, from 17 October 2023, to finalise pending matters as above.

Having said that, unless a substantiated request is submitted by Wednesday 22 November 2023 explaining why the remuneration should continue thereafter, remuneration for your activities pertaining to the case of the *Prosecutor v. Maxime Jeoffroy Eli Mokom Gawaka* will cease by Friday 24 November 2023.
