Dear Counsel,
Dear colleagues from the Registry,

The Single Judge takes note of the (i) Prosecution's proposed lesser redacted versions of transcript T-210; (ii) Yekatom Defence's objections to some of the redactions which the Prosecution proposes to maintain in T-210; and (iii) Common Legal Representatives of Victims of Other Crimes' support to the Prosecution's proposal (see emails attached and below).

Having assessed these redactions in line with paragraph 72 of the Initial Directions, ICC-01/14-01/18-631, the Single Judge considers that it is necessary to maintain redactions to information that could potentially reveal the witness's identity, including, *inter alia*, the roles he held and his family details. However, the Single Judge does not consider that it is justified to maintain redactions to information that is more general in nature or that does not risk revealing the witness's identity.

The Single Judge notes that the transcript references below are to the corrected versions of the transcript, to the extent available.

Accordingly, the Single Judge rules as follows:

The Yekatom Defence ("Defence") respectfully objects to some of the suggested Prosecution's redactions to P-2354's transcripts. In the table below, the Defence has indicated the redactions it objects to in bold, and has kept highlighted in red the suggested Prosecution redactions it agrees with for each relevant excerpt. Please note that the Defence's objections equally apply to the English version of the transcripts.
