The Defence acknowledges receipt of your email and has the following comments:

First, the Defence notes that as per the information provided to the Defence by the Registry in relation to last week's Pre-Trial Chamber Ex Parte Order #294, the Court cannot impose conditions on Mr. Mokom regarding his conditions of stay in The Netherlands which were not agreed by him. Mr. Mokom consented to the conditions laid out by the Chamber in its Order #294 and did not consent that more restrictions be imposed on him. As stated in the Registry report dated 24 November 2023 (Filing #298), one of the conditions laid out by the Chamber and to which Mr. Mokom consented is that [REDACTED] (para. 5). [REDACTED] Mr. Mokom, as a free man, sees his freedom of movement drastically restricted, in contradiction with the conditions laid out by the Chamber in its Order #294 and with the conditions to which Mr. Mokom consented on 22 November 2023.
