As indicated in my letter dated 25 January 2012 (2011/ NV/1397/ab/ak/SA), Pre-Trial Chamber II confirmed the charges against Mr. Muigai Kenyatta and Kirimi Muthaura in the case ICC-01/09-02/11.

As a result, the request for identification, tracing, freezing or seizing any and all property and assets held directly and/or indirectly on behalf of Mr. Hussein Ali is therefore not valid anymore. However, the request for the identification remains valid against Mr. Muigai Kenyatta and Kirimi Muthaura for the time being.

In order to inform the Chamber of the status of the execution of the above mentioned request for assistance, I would like to ask you to kindly provide me with any relevant information in your possession.
