## ANNEX 3

## **PROCEDURAL HISTORY**

- 1. On 14 March 2012, Trial Chamber I rendered the Conviction Decision<sup>1</sup> in the case of the *Prosecutor v. Thomas Lubanga Dyilo*, appending the Separate Opinion of Judge Adrian Fulford<sup>2</sup> and the Separate and Dissenting Opinion of Judge Odio Benito.<sup>3</sup> In the Conviction Decision Trial Chamber I, *inter alia*, found Mr Lubanga guilty of the crimes of conscripting and enlisting children under the age of fifteen years into the FPLC<sup>4</sup> and using them to participate actively in hostilities within the meaning of articles 8 (2) (e) (vii) and 25 (3) (a) of the Statute from early September 2002 to 13 August 2003.<sup>5</sup>
- 2. On 10 July 2012, the Trial Chamber rendered, by majority, the Sentencing Decision, Judge Odio Benito dissenting, in which the Majority sentenced Mr Lubanga to a total period of 14 years of imprisonment.
- 3. On 3 October 2012, pursuant to article 81 (1) (b) of the Statute, rule 150 of the Rules of Procedure and Evidence, and regulation 57 of the Regulations of the Court, Mr Lubanga filed the Notice of Appeal<sup>9</sup> in which he requested that the Appeals Chamber set aside the Conviction Decision and acquit him.<sup>10</sup>

- 4. On 24 October 2012, the Appeals Chamber designated Judge Erkki Kourula as the Presiding Judge.<sup>11</sup>
- 5. On 26 November 2012, Mr Lubanga filed the First Additional Evidence Request. 12
- 6. On 3 December 2012, Mr Lubanga filed the Document in Support of the Appeal. 13
- 7. On 13 December 2012, the Appeals Chamber rendered the Victim Participation Decision, <sup>14</sup> in which it, *inter alia*, authorised the 120 victims who participated in the trial

proceedings and whose right to participate in the proceedings was not withdrawn to participate in the appeal proceedings against the Conviction Decision.<sup>15</sup>

8. On 4 February 2013, the Prosecutor filed her Response to the Document in Support of the Appeal, <sup>16</sup> in which she also addressed Mr Lubanga's First Additional Evidence Request <sup>17</sup> and adduced one item of rebuttal evidence. <sup>18</sup>

- 9. Also on 4 February 2013, the Legal Representatives of Victims V01 filed their Observations of Legal Representatives of Victims V01.<sup>19</sup> On 7 February 2013, the Legal Representatives of Victims V02 filed their Observations of Legal Representatives of Victims V02.<sup>20</sup>

- 11. On 20 February 2013, Mr Lubanga filed with the Presidency a request for the recusal of Judge Sang-Hyun Song from all of the final appeals stemming from the case against Mr Lubanga,<sup>24</sup> namely the *Lubanga* A,<sup>25</sup> A 2,<sup>26</sup> A 3,<sup>27</sup> A 4,<sup>28</sup> A 5,<sup>29</sup> and A 6 appeals.<sup>30</sup> On 11 June 2013, the Presidency notified the parties that the plenary of judges, by absolute majority of thirteen, with one judge dissenting, dismissed Mr Lubanga's request for disqualification of Judge Sang-Hyun Song.<sup>31</sup>
