**Summary of victim applications and other personal accounts
received**

1. Overall, the Prosecution has reviewed and taken into consideration the accounts of 324 persons who were passengers aboard the *Mavi Marmara*, and 28 persons who were passengers aboard vessels other than the *Mavi Marmara*.
2. To date, the Prosecution has now received and reviewed applications from 304 persons and 2 organisations to participate in proceedings before the Court as a victim, part of the list of 341 names originally provided by the Comoros to the Prosecution on 28 January 2016.¹ One additional application has been provided to the Prosecution concerning a person who was not listed by the Comoros.²
3. Applications in respect of 36 persons named by the Comoros have yet to be provided to the Prosecution.³ In 35 instances the Prosecution had no other account by the applicant in its possession.⁴
4. Having reviewed these applications, the Prosecution notes the following:
 - 282 applications concern persons who were aboard the *Mavi Marmara* at the material times.⁵

- 24 applications concern persons who were aboard vessels other than the *Mavi Marmara* at the material times.⁶
- 63 applications were not signed by the applicant, or a person expressly nominated in the application as their representative, or omitted the page containing the applicant's signature.⁷ This did not, however, prevent the Prosecution from reviewing and considering the content of these applications nonetheless.
- 46 applications referred to other documents which were not provided to the Prosecution, although those documents may already have been in the Prosecution's possession.⁸ In only 3 instances did the Prosecution have absolutely no account by the applicant in its possession.⁹
- 3 applications or documents were not in a working language of the Court. However, in only 2 instances did the Prosecution have absolutely no account by the applicant in its possession.¹⁰

5. The persons who applied to be victims do not represent the entirety of the persons whose accounts are in the possession of the Prosecution. In addition, to date, the Prosecution has taken into consideration the accounts (in various formats)
