Dear TFV, Counsel and Registry,

By way of an email, the TFV requests unredacted versions of the three expert reports in this case (Email from the TFV, 29 August 2017 at 09:34). The reason given for the request was to have access to the names and details regarding organisations which may be relevant during the implementation phase. The Prosecution responded to indicate that, although it had no objection to these names and contact details being provided, it considered providing the full unredacted reports to be unnecessary (Email from the Prosecution, 29 August 2017 at 11:20).

From the TFV's justification for its request, it appears that the Prosecution's proposal would sufficiently resolve it. Unless any further objection to proceeding in this manner is raised by 16:00 on 4 September 2017, the Registry is to liaise with the TFV as needed and provide them with the names and details of any relevant organisations discussed in ICC-01/12-01/15-214-Conf-Exp-AnxI, ICC-01/12-01/15-214-Conf-Exp-AnxII-Corr, and ICC-01/12-01/15-214-Conf-Exp-AnxIII-Corr.

Dear Trial Chamber VIII,

In order to prepare the draft implementation plan in the *Al Mahdi* case, the Trust Fund is planning to conduct consultations “with all relevant stakeholders”, as required by the Trial Chamber in its reparations order (para 148). Since the Trust Fund aims to design consultations in the most inclusive way possible, we are currently collecting information about civil society and victims organizations in Mali. The Trust Fund notes that, in the versions available to it, the expert reports submitted to the Trial Chamber in preparation of the reparations order mention a sample of relevant organizations and explicitly recommend to consult these organizations concerning the implementation of reparations. However, the names and details regarding these organizations are currently redacted from the Trust Fund’s view.

The Trust Fund therefore respectfully requests access to the unredacted versions of the expert reports (ICC-01/12-01/15-214-Conf-AnxII, ICC-01/12-01/15-214-conf-AnxI and ICC-01/12-01/15-214-conf-AnxIII) to obtain the relevant information. Please let me know if the Chamber would prefer that the Trust Fund file a formal request.
