Having reviewed the papers, and heard the pleadings, and reviewed articles 210-211-224-277/-2 -287 -293/2 312/1-215-345 of criminal procedure code, and articles 19-21-28-29-34-39-59-60-76/1-2-100-101-169-202-203-205-211-407-428-450- of the penal code , and articles 1-2-34/1 item 1- 35/1 item 1 of Law No.7 of 1990 concerning drugs and psychotropic substances amended by Law No 19 of 1996, and article 1-2-4-5 of law No 19 of 2010 concerning illegal immigration contract and article 9-27-35 of Law No.2 of 1979 concerning economic crimes amended by law No. 14 of 2001, and articles 166-167-224-225- of the civil law,

The court decided in absentia with regard to the 1^{st} , 23^{th} , 30^{th} , 35^{th} , 36^{th} , and 37^{th} , and in presence with respect to the remaining culprits

First: Pronounce as guilty the first culprit Saif Alislam Mummar AlGadafi, the second culprit Abdallah Mohamed Al sanousi , the third culprit the AlBagdadi Ali Al Mahmoudi , the fourth culprit Mansour Daw Ibrahim , the fifeth culprit Midad Salem Daman , the tenth culprit Munzer Mukhtar Gunemi , the fifeteenth Abdulhameed Amar Ohida , and the thirty-oneth Awaidat Ghamdor Nabi Abosoufa , for their alleged conduct, and sentence all of them to death by being shot down.
