Goal of the specified activities	To provide a holistic response to the needs of victims within the jurisdiction of the Court in Central African Republic through: - Medical assistance including curative and preventive care, clinical care and treatment of victims with serious physical harms such as gynaecological injuries, including surgery if necessary; - Psychological support through individual support, group therapy and group sociotherapy; - Socio-economic assistance, such as literacy, small business management and microcredit programmes, aimed not only at empowerment but also at transformation and resilience.
