Dear Trial Chamber X,

The Defence for Mr. Al Hassan notes that in its '[REDACTED]' '[REDACTED]', which was reclassified and made available to the Defence today, the Prosecution has proposed new procedures as concerns the disclosure of [REDACTED]'s identity. Specifically, the Prosecution has proposed that:

1. The disclosure of [REDACTED]'s identity should be restricted to Defence Counsel; and that
2. The Prosecution should first contact [REDACTED] to establish whether [REDACTED] would consent to the disclosure of his or her name to Defence Counsel.

These proposals deviate from the procedure suggested by the Single Judge, and were not raised at a prior point of the proceedings. The Defence has therefore had no opportunity to comment on the extent to which these procedures are necessary or feasible, and the likely prejudice that would ensue from their implementation.

The Defence therefore seeks leave to address this proposal, through a filing of no more than 3 pages.
