The Single Judge takes note of the below Prosecution request to use, for its direct examination of P-1577, [REDACTED] and relevant information from P-1577's prior statement (the 'Request').

Noting the Prosecution's submissions that this approach would streamline its questioning of the witness, is subject to the fulfilment of the Rule 68(3) conditions, and that the other participants have agreed on the approach and format of [REDACTED] the Single Judge grants the Request.

Dear Trial Chamber V,

To enhance the efficiency of the proceedings, and provided that the rule 68(3) conditions are fulfilled, the Prosecution proposes to use a document compiling [REDACTED] and relevant information from P-1577's prior statement in his direct examination (*i.e.* [REDACTED])

Proceeding in this way would avoid printing the 700+ pages of material comprising the selected [REDACTED] and their corresponding meta-data, and further has the advantage of locating the relevant material in a single approximately 50-page document, for ease of reference during the proceedings. The Prosecution anticipates that this would further and helpfully streamline the presentation of the witness's evidence.

We attach a sample of the intended format of [REDACTED] and will provide the Chamber and the Parties and Participants at the latest tonight with the totality of [REDACTED] to be used with the witness.

Accordingly, the Prosecution seeks the Chamber's authorisation to proceed as proposed, noting that, in anticipation of this request, we have sought and obtained the agreement of the Parties and Participants on the suggested approach and format of [REDACTED] itself.
