| <b>Bribes</b>                                    | Financial and other benefits, including cash payments, land and houses, vehicles, educational support and employment opportunities  |
| <b>Charged Offences</b>                          | The offences charged in Counts <b>1 to 8</b> under Section C of the DCC   |
| <b>Charges</b>                                   | Including all material facts and their legal qualification (under both article 70 and article 25), and precise form of participation  |
| <b>Common Plan</b>                               | The Common Plan encompassed the identification, location and contacting of Prosecution Witnesses, and offering and/or paying them financial benefits, and/or threatening or intimidating them, in order to induce them to withdraw as Prosecution Witnesses, refuse to or cease cooperating with the Prosecution and/or the Court, and/or recant the evidence which they had provided to the Prosecution                                  |
| <b>Common Plan Members or Common Plan Group</b>  | Members of the Common Plan, including <b>Managers</b> , and <b>Intermediaries</b>   |
| <b>Common Purpose and Common Purpose Members</b> | Group of persons acting pursuant to a common purpose to corruptly influence Prosecution Witnesses by committing the types of offences charged in Counts <b>1 to 8</b> , including <b>Managers, Intermediaries and Associates</b> .  |
| <b>Co-perpetration</b>                           | <b>Direct co-perpetration</b> , unless otherwise specified  |
| <b>Corrupted Witnesses</b>                       | Successfully corrupted witnesses P-0397, P-0800, P-0495, P-0516, P-0739 and P-0341  |
| <b>Corruption Targets</b>                        | The targets of corrupt influence.   |
| <b>Direct Perpetrators</b>                       | Intermediaries Walter Osipiri BARASA (“BARASA”), Philip Kipkoech BETT (“BETT”), and Meshack YEBEI (“YEBEI”); and Associates/Corrupted Witnesses BUSIENEI, KOSGEI, ██████████ P-0397, P-0800, P-0495 and P-0341  |
| <b>Intermediaries</b>                            | Persons acting as intermediaries between the Managers and Prosecution Witnesses, including BARASA, BETT and YEBEI   |
| <b>Kenya</b>                                     | Kenyan authorities  |
