15 And can we call the case, please.  
16 THE COURT OFFICER: [9:34:21] Good morning, Madam President, your Honours.  
17 This is the situation in Darfur, Sudan, in the case of The Prosecutor versus  
18 Ali Muhammad Ali Abd-Al-Rahman, case reference ICC-02/05-01/20.  
19 And for the record, we're in open session.  
20 PRESIDING JUDGE KORNER: [9:34:39] Yes, thank you.  
21 Appearances by the Prosecution, please.  
22 MR NICHOLLS: [9:34:43] Good morning, Madam President. Good morning,  
23 your Honours. Good morning, everyone. Julian Nicholls with  
24 Pubudu Sachithanandan, Laura Morris and Claire Sabatini. Thank you.

2 MR LAUCCI: [9:34:55] (Interpretation) Good morning, your Honour. Good  
3 morning, colleagues. Beside Mr Abd-Al-Rahman, who is present in the courtroom  
4 today, on the Defence team we have Camille Divet, who is assistant evidence  
5 reviewer; Mr Ahmad Issa, case manager; my colleague Iain Edwards; and myself,  
6 Cyril Laucci, lead counsel.

7 PRESIDING JUDGE KORNER: [9:35:26] Yes, thank you.

8 And finally, the representatives of the victims.

9 MR SHAH: [9:35:32] Good morning, Madam President. Good morning,  
10 your Honours. Good morning, colleagues. The participating victims are  
11 represented today by Idriss Anbari, case manager, and myself, Anand Shah, associate  
12 counsel.

13 And I also want to advise your Honours that Ms von Wistinghausen will be joining  
14 us tomorrow, likely for the afternoon session. Thank you.

15 PRESIDING JUDGE KORNER: [9:35:52] Yes. Thank you very much.

16 All right. Before the witness comes in there are a couple of matters. First of all, I  
17 think you've all been informed, but this Friday, just so that it's clear, the sitting times  
18 are slightly different. We will start at 9.15, sorry, and then break at 10.45, and then  
19 we are sitting from half past 2 only. Is that right?

20 Sorry, only as I'm reading out the times, I thought it was somewhat different.

21 Yes, I thought we were sitting at 2, but because of the Fur -- the Fur interpretation, I  
22 gather we can't do a two-hour session. So we will be sitting from 2.30 till 4 o'clock as  
23 normal. But the morning session will be slightly truncated. I hope everybody has  
24 been told about that so that -- from the point of view of witnesses.

25 The second matter really, Mr Laucci, arises from your putting your case last Friday,

1 and you put to the witness from last Friday what I can only call is a reversion to part  
2 of your original defence, namely that nobody called Ali Kushayb actually exists and  
3 that he was an invention to cover up the crimes committed by others. But you've not  
4 put that to any of the witnesses, if I can put it that way, the crime-base witnesses who  
5 have been talking about a man they know as Ali Kushayb. It's not been put to them  
6 that no such person exists and nobody gave that name. And I'm raising it now  
7 because this is another witness who's going to talk about a man that he calls  
8 "Ali Kushayb". So I'm a bit unclear at the moment what -- what that part of your  
9 defence is.

10 MR LAUCCI: [9:38:31] Madam President, I will try to answer to the best of my  
11 capacity to that question. From -- I mean, the -- the position of the Defence has  
12 always been that Ali Kushayb either does not exist or is not Mr Ali Muhammad Ali  
13 Abd-Al-Rahman. That's the position.  
14 Maybe, but I would like to -- to double-check that, but I fully rely on your recollection.  
15 For other witnesses, the case that was put was that they were misled in their  
16 identification of Ali Kushayb and this was not Mr Ali Muhammad Ali  
17 Abd-Al-Rahman.  
18 For this witness, I'm talking about P-643, and I'm cautious because we are in open  
19 session, it appeared from his evidence that he had testified, really, and to my  
20 recollection that's the first such witness who has testified about -- if Ali Kushayb is an  
21 invention, about the making of Ali Kushayb. And that is the fact that he became at  
22 some point *agid al-ogada*. First witness explaining how this becoming Ali -- *agid*  
23 *al-ogada* took place and existed. Which led me, because of that and because we are at  
24 the -- really at the initial, I will say creation, but you can take apparition of  
25 Ali Kushayb, which, because of that, that's the reason why the case that I put to that

1 witness was more about the existence rather than whether Ali Kushayb was  
2 Mr Ali Muhammad Ali Abd-Al-Rahman.  
3 That's maybe the nuance that I had to make for this specific witness. Because, once  
4 again, the evidence of that witness went to really the -- the -- yeah, how Ali Kushayb  
5 became Ali Kushayb.  
6 PRESIDING JUDGE KORNER: [9:40:36] I perfectly understand that. You're saying  
7 that this -- the committee that he talked about didn't exist at all and that, as you said,  
8 Ali Kushayb was a -- was an invention to cover up the crimes committed by others,  
9 possibly including himself. I mean that was very clear and very proper.  
10 But, if that is your case, if that is, as it were, strand number one of your case, then each  
11 of the earlier witnesses, the people who were -- witnessed the attacks or were locked  
12 up in Mukjar, according to them, have said that a man calling himself "Ali Kushayb"  
13 was present and -- and ordering things. Well, the two are not compatible. In other  
14 words, you should have been putting to these witnesses that -- that there is no such  
15 person called Ali Kushayb at all, that the -- the name never happened at the time.  
16 MR LAUCCI: [9:41:50] I will need to -- to double-check that, but in my recollection,  
17 the two alternatives have always been presented. Maybe because  
18 the witness -- the other witnesses were speaking more about a specific event over  
19 the course of the events of the charges, saying there was a person called Ali Kushayb  
20 doing that and that, we said, well, your basis for identification or recognition of  
21 Ali Kushayb is not there and this is -- we say that you were mistaken. Because these  
22 other witness did not speak specifically about the apparition of Ali Kushayb, we focus  
23 more on that aspect, it's the wrong person, than Ali Kushayb did not exist. That's  
24 the nuance that we have been making, but I'm --

1 interrupting, Mr Laucci. But what I want to be quite clear about is, because  
2 obviously when we're thinking about writing the judgment, as we are throughout, we  
3 have to look at what evidence is challenged and what evidence is not challenged and  
4 make -- and when it's not challenged that a man giving the name Ali Kushayb, who  
5 we fully appreciate you say is not your client, and -- and you said to the witness who  
6 said that he went back to check at the pharmacy that -- that that simply wasn't true,  
7 all of that's very clear, but what you're not challenging is that somebody at various  
8 locations during the period, really, mid-2003 to mid-2004 is going around committing  
9 crimes, in the sense of leading attacks or looting or being present at meetings. I  
10 mean, that's not the crime, but -- and so at the moment it's all very unclear.

11 MR LAUCCI: [9:43:50] Yes. Madam President, what I can propose is that I -- I look  
12 more at what has been done with the other witness and we can revert to -- to you on  
13 that specific point.

14 PRESIDING JUDGE KORNER: [9:44:03] Well --

15 MR LAUCCI: [9:44:03] If -- I mean, maybe we have been too specific in  
16 the -- the case that we were making for the previous witnesses, and we will be more  
17 careful about that in the future. But, I mean, as I said, from the beginning, the case of  
18 the Defence on this specific aspect is Ali Kushayb either does not exist or is not  
19 Mr Ali Muhammad Ali Abd-Al-Rahman.

20 PRESIDING JUDGE KORNER: [9:44:32] Yes, all right. And appreciating  
21 that -- that this is really exploring matters rather than putting a positive case, because  
22 your positive case is that if anybody says it was your client, they're either mistaken or  
23 lying. I mean that -- that's very clear. Can I make -- but it's because you  
24 resuscitated what I thought had disappeared from your defence that I'm raising it.

25 MR LAUCCI: [9:44:58] Actually, the reason why this was more obviously put to

2 the head of the Mujahidin subcommittee. That's the only reason why we insisted  
3 specifically with that witness more than with others on that aspect.

4 PRESIDING JUDGE KORNER: [9:45:18] All right. Well, I thought I'd raise it before  
5 the witness comes.

6 Are you cross-examining this witness, Mr Edwards, or -- yeah, all right. Well, we'll  
7 see how we go.

8 Just a reminder to everybody -- oh, Mr Nicholls -- but a reminder to everybody,  
9 before I forget, and it's going to be more difficult for me than for almost everybody  
10 else, I think, is we're going to have to leave massive pauses between questions and  
11 answers. I don't know how the interpretation is being done this morning, but it's  
12 obviously going to be trial and error.

13 Yes, sorry, Mr Nicholls, you wanted to raise something.

14 MR NICHOLLS: [9:46:01] Thank you, your Honour, just very briefly. I mean, this  
15 was all brought up, the nature of the Defence, with the very -- with the second  
16 witness, following the expert, the first fact witness. I put it that the case appears to  
17 be that he does not exist. And what our understanding was after that was that not  
18 the case, that we were put to the proof of everything, you know, that Sudan -- well,  
19 everything that's not in an agreed fact. So I had thought we were over that until  
20 the last witness.

21 PRESIDING JUDGE KORNER: [9:46:31] As I say, that's what I thought as well and  
22 that's why I raised it, because, as I say, it's really important, both for the Prosecution  
23 and for us as the judges, to know what evidence is in dispute and what is not, aside  
24 from agreed facts.

3 point during the war?

4 A. [10:05:47] Yes, it was attacked once.

5 Q. [10:05:53] Without mentioning the name of your village or your family members,  
6 please describe to the Court, briefly, this attack.

7 A. [10:06:53] We were sitting in our town and then we were attacked. It was in  
8 the morning. People were on horseback and camelback and in vehicles.

9 Q. [10:07:08] Please continue, but pause every two or three sentences.

10 A. [10:07:46] Following the attack, I fled with my mother and my grandmother,  
11 and (Redacted), and (Redacted) to the *wadi*, or the valley. The *wadi* is called  
12 Karara.

13 And my grandmother was blind, so she could not walk, so I was helping her. We  
14 fled until we got to Mount Karara, and at that time ... after we got to Mount Karara,  
15 we stayed there.

16 THE INTERPRETER: [10:09:20] Note from the Fur interpreter: We ask the witness  
17 to just give us a break between sentences so we have enough time to interpret.

18 MR SACHITHANANDAN: [10:09:36]

19 Q. [10:09:36] Where did you go from Karara?

20 A. [10:09:48] After Karara we went to the mountain.

21 Q. [10:09:58] Where did you go after going to the mountain?

22 A. [10:10:12] We stayed there.

23 Q. [10:10:18] From the mountain, did you at any point go back to your village?

24 A. [10:10:49] We spent the whole day there and then we returned to the village at  
25 night. We could see the village being attacked and fire being set to the village.

2 A. [10:11:44] We spent the whole day in the mountain and we could see our village  
3 being set on fire. When we went back, we were also able to see in another village  
4 called Segederra, we could see the smoke fumes coming out of the village.

5 Q. [10:12:05] Did you at any point head to Mukjar?

6 A. [10:12:51] After having spent the day in the mountain watching our village  
7 being attacked by the Janjaweed on horseback and camelback, we came back at night.  
8 We saw that the village had been burnt down and so this is when we head to Mukjar.

9 Q. [10:13:12] Thank you, Mr Witness. I notice you're following my hand signals to  
10 stop, and that's very helpful.

11 It's because it takes a bit of time for the interpreter to tell me in English what you are  
12 saying in Fur.

13 A. [10:13:48] That's good.

14 Q. [10:13:49] Can you tell us, please, what happened when you got to Mukjar.

15 A. [10:14:26] After we went back to the village, we found an old woman called  
16 Totoyi dead, and another person called Adam Zakaria, also dead.

17 Q. [10:14:45] Right. But I want to talk about Mukjar now. Can you tell us what  
18 happened when you arrived at Mukjar.

19 A. [10:15:17] When we arrived to Mukjar, we found a police checkpoint headed by  
20 Haroun Bashir.

21 Q. [10:15:33] What unit or organisation did Haroun Bashir belong to?

22 A. [10:16:11] He was a policeman. When we arrived to Mukjar, he was with other  
23 10 policemen at an entry point. At that place, they divided us -- they separated us.  
24 My mum and my grandmother, they allowed them to go to Mukjar. Myself, Hassan  
25 Abdalla and Adam Jabber (phon), we were taken to the Mukjar police station.

2 Adam who was arrested?

3 A. [10:17:13] His name was Adam Adam.

4 Q. [10:17:25] Do you know Imam Adam Saleh?

5 A. [10:17:45] Yes, I know him. He is the one I went with to the police station,  
6 where we met Hassan Carter, who registered our names.

7 Q. [10:18:01] To which group or organisation did Hassan Carter belong to?

8 A. [10:18:28] Adam Saleh was the imam and he was from Abirla. He was  
9 a former -- farmer, sorry, and we used to live in the same town.

10 Q. [10:18:39] Right. But I'm talking about Hassan Carter. You mentioned  
11 Hassan Carter. Which unit or organisation did he belong to?

12 A. [10:19:11] Hassan Carter was a policeman from the security force. He was  
13 wearing a *jallabiya*. When we arrived, he took us into prison.

14 Q. [10:19:27] Was Hassan Carter ordinary or unified police, or was he Popular  
15 Police?

16 A. [10:19:49] He was from the Popular Police.

17 Q. [10:19:56] Please tell the Court how Hassan Carter registered you.

18 A. [10:20:31] He was asking us, "What is your name?" And when you tell him  
19 your name, he would register it and write it down. He asked all three of us our  
20 names, he wrote down our names, and then we were taken into a prison cell.

21 Q. [10:20:49] Was it only the three of you that he asked, or was he also asking other  
22 people who were detained?

23 A. [10:21:24] When we arrived, we were only three. The rest of the detainees,  
24 I don't know anything about them.

25 Q. [10:21:40] You -- you said you were put in a prison cell. Can you tell us

1 roughly how many people were in this prison cell.

2 A. [10:22:22] There were two rooms in the prison, with one gate. I estimate that  
3 there were more than a hundred persons there.

4 Q. [10:22:45] Can you tell us, please, the names of any people you recognised in  
5 the prison cell.

6 A. [10:23:26] The persons that I recognised were Mohammed Abdelkarim,  
7 Mohamed Zakaria and Abdu Mini.

8 Q. [10:23:39] Please go on, Mr Witness.

9 A. [10:24:12] I remember also Mohammed Abdelkarim and Mohamed Zakaria,  
10 there was *Umdah* Yahya, *Umdah* Doren and *Umdah* Issa.

11 Q. [10:24:26] Please go on, Mr Witness.

12 A. [10:24:56] I also recognised *Sheikh* Jobbor, Abdu Saleh and the son of someone  
13 called Abdalla Ibrahim.

14 Q. [10:25:17] Does Abdalla Ibrahim have any other names?

15 A. [10:25:45] All I know is that his name is Abdalla Ibrahim \*Singel and that  
16 he is from the village of Kodo -- Kodoom, apologies. Kodoom.

17 Q. [10:26:07] Were there any windows in this room?

18 A. [10:26:23] There were no windows.

19 Q. [10:26:27] Did you have enough to eat or drink while detained?

20 A. [10:26:51] There was no food. They were not giving us any food.

21 Q. [10:27:01] Did you have a place to urinate or defecate?

22 A. [10:27:21] We would defecate inside the cell.

23 Q. [10:27:35] Was it easy to breathe in the cell or was it not easy?

24 A. [10:28:05] We didn't have a choice. We didn't have a place to go to and we  
25 were overcrowded. Some were standing up, some were sitting.

3 you find a place to stretch your leg, that would be too much. That's more than you  
4 can ask for.

5 Q. [10:29:06] What did it feel like to you to be detained in such a place?

6 A. [10:29:31] I didn't have anything to do. I had to be there, and this is where I  
7 spent my time.

8 Q. [10:29:42] Did you spend that night in the prison or did you not?

9 A. [10:30:02] Yes, the same night when we arrived, we spent it in prison.

10 Q. [10:30:11] Did you manage to sleep or did you not?

11 A. [10:30:47] There was no place to sleep. We were crowded. We were leaning  
12 on each other. If anyone wanted to sleep, they would sleep on top of the others.

13 Q. [10:31:04] The next day, the day after your detention, what happened on that  
14 day?

15 A. [10:31:34] The next day, in the afternoon we were sitting inside the prison,  
16 Ali Kushayb arrived and he entered into the cell, into the prison.

17 Q. [10:31:48] How did you know that this person was called Ali Kushayb?

18 A. [10:32:10] When the door was opened, Ali Kushayb entered and he said, "I am  
19 the head of the Janjaweed and my name is Ali Kushayb."

20 Q. [10:32:30] What language was Ali Kushayb speaking when he said this?

21 A. [10:32:59] He was speaking in Arabic, saying that he was Ali Kushayb, the head  
22 of the Janjaweed.

23 Q. [10:33:13] Just a note to the interpreter, the Arabic interpreter. I'm going to ask  
24 the witness to say the words in Arabic. And if the Arabic interpreter could just say  
25 out the words phonetically in Arabic.

14 you were. Were you further than I am to you regarding Ali Kushayb, or were you  
15 closer than I am to you in the -- with -- in respect of Ali Kushayb?

16 A. [10:36:08] It was around half a metre between him and I.

17 Q. [10:36:22] What did *Umdah* Yahya do when Ali Kushayb said this to him?

18 A. [10:36:53] *Umdah* Yahya said, "I will die as a martyr, but you will suffer." And  
19 then Ali Kushayb hit *Umdah* Yahya on the shoulder and he broke his arm.

20 Q. [10:37:11] With what, if anything, did Ali Kushayb hit *Umdah* Yahya?

21 A. [10:37:44] He hit him with his axe. And some of the men of Ali Kushayb, 10 of  
22 the men of Ali Kushayb hit the -- and beat the detainees. They shaved their heads.

23 Q. [10:38:06] Ali Kushayb's axe, please describe to us Ali Kushayb's axe.

24 A. [10:38:40] The axe of Ali Kushayb was made of steel. It had steel in it. It has  
25 a handle of steel. And he was holding the axe in his right arm. He was holding

- 8 A. [10:40:30] I was sitting next to *Umdah* Yahya. I was close to him.
- 9 Q. [10:40:43] When *Umdah* Yahya said he will die as a martyr, what, if anything,
- 10 did Kushayb say?
- 11 A. [10:41:21] He told him, "How can you say that?" And Ali Kushayb hit him on
- 12 the shoulder. He broke his arm. And then Ali Kushayb start whipping the rest of
- 13 the detainees. Ali Kushayb was hitting, beating and whipping the *umdahs*.
- 14 Q. [10:41:45] Was Ali Kushayb the only person who was speaking, or did
- 15 the others with him say anything?
- 16 A. [10:42:19] We were listening to Ali Kushayb. The other men didn't say
- 17 anything at first, but then they were saying to the detainees, "You are *abid*" and
- 18 "*tora bora*."
- 19 Q. [10:42:39] Please tell the Court what is meant by *abid*.
- 20 A. [10:43:04] I do not know the meaning of the word. He was saying it to us and
- 21 he was beating us.
- 22 Q. [10:43:15] Do you know the meaning of the word "*tora bora*"?
- 23 A. [10:43:32] No, I don't know what *tora bora* means. I heard it from the people.
- 24 Q. [10:43:42] Mr Witness, about *abid*, you said "He was -- he was saying it to us and

- 16 A. [11:46:01] Ali Kushayb was standing there. He was watching while *Umdah*  
17 Issa, Yahya, Jobbor and Doren were being beaten.

15 Jobbor. How was *Sheikh* Jobbor treated?

16 A. [11:51:22] *Sheikh* Jobbor was hit by the men of Ali Kushayb, the Janjaweed.  
17 And because the place was very tight, there wasn't enough room. That is why he  
18 was being beaten in the other part of the body, I mean the head and the shoulders.

19 Q. [11:51:45] Mr Witness, you use the term "men of Ali Kushayb". Why -- why do  
20 you say they were the men of Ali Kushayb?

21 A. [11:52:20] I say Ali Kushayb's men because when Ali Kushayb came into the cell,  
22 he was surrounded by about 10 of those that I called his men. They were armed and  
23 they were beating people.

24 Q. [11:52:40] You mentioned that Kushayb hit *Umdah* Yahya. Which part of

1 Q. [12:03:20] You said they were burning people with an iron. Please describe to  
2 the Court how they were doing this.

3 A. [12:03:58] They would come to us and ask us, "Are you *tora bora*?" If you say  
4 no, then they would burn you, or fix the iron on your body for around 10 minutes.  
5 People were shouting. And sometimes they would slap us on our faces.

6 Q. [12:04:26] Did this only happen to other people or did it happen to you as well?

7 A. [12:04:52] They burnt many people. I was among those who were burnt.  
8 Until now I have three scars on my body as a result of being burnt by the iron.

9 Q. [12:05:12] I'd like to call up a photograph at this point.

10 Again, as -- similar to the previous photograph, can this please be not for the public.  
11 It's 0217-0445.

12 Mr Witness, can you see a photograph in front of you?

13 A. [12:06:10] Yes. This picture shows what happened as a result of being burnt by  
14 the iron.

15 Q. [12:06:19] Which part of your body is this?

16 A. [12:06:39] Under the knee and above the knee on my right leg.

17 PRESIDING JUDGE KORNER: [12:06:48] You really, really, Mr Sachithanandan,  
18 must -- must apply some common sense to this. How on earth could a photograph  
19 of his knee possibly identify him to anybody?

20 MR SACHITHANANDAN: [12:07:02] Well, your Honour, it's a combination of  
21 things. Not everyone in a village walks around with such injuries. And we are  
22 covering all his injuries, as well as a particular narrative related to those injuries. I  
23 agree with Mr Nicholls that we should be cautious here considering the profile of  
24 the witness.

25 Can we pull up another photograph, please, and take this down. It's 0217-0446.

21 Were you silent or did you talk amongst yourselves?

22 A. [12:12:26] They were shouting, they were crying, and some of them were  
23 reading.

24 Q. [12:12:45] Did you say "reading"? Could you tell us what they were reading.

25 A. [12:13:25] Some were reading quotes and verses from the Koran, some were

8 "whining as a result of their suffering". I'm not at all sure that that English word  
9 encapsulates what he was trying to say, and it may be important.

11 Q. [12:14:54] Mr Witness, we have written down that you said people were crying,  
12 shouting and whining. Can you explain what you meant by "whining".

13 A. [12:15:47] People were insulted. We were not provided with food or water.  
14 We were beaten. We were burnt with iron. So we were hurting. I meant that  
15 people were crying.

16 Q. [12:16:08] Mr Witness, the -- the detainees whose ears were cut off, did they

18 A. [12:16:30] Kushayb came. He took them. And I -- the second day, and I never  
19 saw them again.

21 the burnings. What happened in the morning of that day?

23 Ali Kushayb entered where we were.
