- 19 [10:11:24] I would like to show you some telephone records from 2012 and 2013, Q. 20 which we obtained from the Malian authorities. And I'll start with what's under tab 21 40 of the Court binder, MLI-OTP-0031-1197 and this should not be broadcast to the
- 22 public.
- 23 Now this document shows records of phone calls and text messages with a phone
- 24 number (Redacted) had made or received during the period of June -- on the 1st of
- 25 June 2012 and 31st of July 2012.

1 A. [10:13:29] Yes, I can see the document. I can see the document in front of me. 2 Q. [10:13:39] When we look at (Redacted), we see a phone call that was received from 3 this number, (Redacted), from a number listed in (Redacted) on 3rd of June 2012 at (Redacted) 4 (Redacted). Now this number in (Redacted), that's the phone number that you used in 2012, 5 correct? 6 A. [10:15:03] Yes, that is my number. 7 Q. [10:15:06] According to our evidence, number (Redacted) was used by Adama. 8 At in (Redacted), we can see another phone call received by Adama's number from your 9 number on the 4th of June 2012 at (Redacted). So you had Adama's phone number, at 10 least from June 2012 and had phone contacts with him, isn't that correct?

A. [10:17:26] Yes, I was receiving calls, I was selling call credit, so someone could call me up to sell an item or to top up their telephone credit. So I received calls from everywhere. People could send other people to me and ask me to send credit for their mobile phones. So -- otherwise, there were no other types of calls between us, except those calls for the purpose of purchasing items of phone credit.

Q. [10:18:23] Well, Mr Witness, the two phone calls we looked at in this Excel sheet,
they indicate that it was Adama's number who received a call from your number, not
the other way around. Isn't it correct that you did call him yourself?

A. [10:19:21] Yes, I call him -- if I spend one or two days without seeing him, I can
call him to find out what is not going on -- what is going on. I call him. Yes,

21 because this is someone who was very close to us and who reported everything to us

22 and if there were problems in the town, he would inform us so that we should not

23 open the shop, and even when there were issues, he kept us up to date.
