14 Do you recall being shown a number of videos during your interview in June 2017?
- 15 A. [9:35:19] Thank you. I remember, yes, indeed, that I looked at some video footage,
16 but I no longer remember the date.
- 17 Q. [9:35:51] That's fine. Thank you. I am going to show you some of those videos
18 again today, and I will ask you a few follow-up questions after. All right?
- 19 MS BERDENNIKOVA: [9:36:07] So we're going to start from a video which is at tab 6,
20 and the reference number is CAR-OTP-2012-0523. I will read in the transcript
21 references just for the record, but the videos will mostly be shown for identification
22 purposes, so I don't think interpretation is necessarily necessary here.
23 Nevertheless, the transcript is at tab 6 at CAR-OTP-2118-5507, and the translation is at
24 tab 7, CAR-OTP-2118-5547. And we will start by playing an excerpt from minute 09:02
25 until 09:07.

2 MS BERDENNIKOVA: [9:37:23]

3 Q. [9:37:23] Madam Witness, did you see the footage that was played to you, first of
4 all?

5 A. [9:37:29] Yes, I've seen it.

6 Q. [9:37:41] Now, I understand that it's been a long time. It's nine years, in fact, since
7 the events that you described during your testimony, and another five and a half years
8 since your interview with the OTP, but did you recognise anyone in the footage that
9 was just played?

10 A. [9:38:01] It's true that this footage was shown to me, and I recognise one of the
11 people who's in the footage. Thanks to this footage I was able to recognise him merely
12 because at the time of those events I had a video that I looked at -- well, I had an
13 opportunity to view some footage in which the person shown was one of the Anti-
14 Balaka commanders. And I saw him. He was in front of a classroom or in front of a
15 school. He was surrounded by several other people, but I recognised him.

16 So when the video was shown to me, that refreshed my memory and I was able to
17 make the connection with the other video which I had had an opportunity to view.

18 Q. [9:39:59] So who is it, the individual that you're referring to?

19 A. [9:40:02] This person that I'm referring to who I recognised on the footage is called
20 Alfred Rombhot. I identified him. He had grown a beard and he had grown his hair
21 out as well, and I identified him within the Anti-Balaka group. If I remember correctly,
22 thanks to the video footage, I believe it was during -- when foodstuffs was being
23 distributed. He was giving a speech. Supplies were being distributed. And thanks to
24 that video, I was able to identify him and confirm that it was him.

- 12 Q. [11:31:43] Madam Witness, we are now in open session, so please be careful when
- 13 you answer my questions. Please don't give any information that would allow people
- 14 to identify you. And if you have the impression that one of my questions might be
- 15 problematic, let me know. But I think these are general questions about the situation in
- 16 Bangui, so it should be fine. And for the rest of my questioning, I'll be asking us to go
- 17 back into private session.
- 18 Now, my first question to you, Madam Witness, is this: Would you agree with me that
- 19 late December 2013, there was a great deal of tension in Bangui between Seleka groups
- 20 and Anti-Balaka groups and there were clashes, and sometimes you could hear gunfire
- 21 in the city? Would you agree with that statement?
- 22 A. [11:32:43] Yes, that's right.
- 23 Q. [11:33:02] Yesterday, after 11:46, you said on 24 December the Seleka were still in
- 24 the town -- the city, rather, in Bangui. Am I correct in saying that there were many
- 25 Seleka elements at PK5?

2 Q. [11:33:34] Would I also be correct in saying that after 5 December, from the 24th,
3 the areas around PK5 were protected by Seleka members or by armed members of
4 civilians, Muslim civilians, and that's why many Muslims sought refuge in that
5 particular neighbourhood, PK5? Would that be a correct statement?

6 A. [11:34:02] Yes, that's right.

7 Q. [11:34:23] Would I also be correct in saying that for a person who was not a
8 member of the Seleka and not a Muslim either at that time, that there would be no
9 particular reason to go to PK5, no reason to venture into that area? It was dangerous.

10 A. [11:34:53] It is true that people were afraid.

11 MS GUISSÉ: [11:35:07](Interpretation) My five minutes of open session questioning are
12 now over. I know it was quite short.

13 PRESIDING JUDGE SCHMITT: [11:35:12] I am not even sure if it was five minutes.
