15 First, the Chamber considers that the witness is unlikely to be able to provide any

16 meaningful comment on the substance of the documents. He was not involved in

17 their production, is not mentioned therein and was also not otherwise in a position at

18 the relevant time which would enable him to comment meaningfully. Therefore,

19 showing the documents to the witness is highly unlikely to advance the questioning

20 by the CLRV1 in any way.

Second, and bearing in mind the witness's testimony so far, the Chamber's of the view
that the CLRV1 may draw information from the documents and use such information
in its questioning of the witness without having to actually show the documents to
him.
