3 MR ODONGO: Yes, good morning, your Honour. Your Honour, we don't have

5 brief observation by way of oral addendum to our filing.

16 it would appear it would be very oppressive on the Defence to hurry through what

17 has been disclosed now.

2 Prosecution had, whilst carrying out its disclosure, invited the Defence to 3 communicate the themes or key words that they consider helpful for their preparation. 4 So we had actually offered to assist in terms of going through some of these materials 5 because we know the volume that is involved, and we are still awaiting from the 6 Defence what the themes are that they would require in order to help them carry our 7 searches that they need for their preparation. That's what we're prepared to add. 8 SINGLE JUDGE TARFUSSER: Mr Obhof. 9 MR OBHOF: We do admit that the Prosecution did ask us about the themes, but 10 requesting us to hand over themes is asking us to show our hand before we're legally 11 required. It requires us to at least put forth some type of -- I wouldn't say evidence, 12 especially in areas where the Rome Statute doesn't require you in the Rules of 13 Procedure and Evidence anywhere between 15 to 3 days before the hearing. It 14 would essentially be saying: Dear Prosecution, this is what we're going to present 15 nine months in advance before the confirmation of hearing happens. 16 It's just not something they can require from the Defence. 17 Thank you, your Honour. 18 SINGLE JUDGE TARFUSSER: Well, I --19 MS ADEBOYEJO: Your Honours -- I'm sorry, your Honour. I just -- I think that the 20 important thing to point out is that this was done in good faith because the 21 Prosecution took cognizance of the fact that there was a large volume.
