- 17 This is the situation in Darfur, Sudan, in the case of The Prosecutor versus
- 18 Ali Muhammad Ali Abd-Al-Rahman ("Ali Kushayb"), case reference ICC-02/05-01/20.
- 19 And for the record, we are in open session.
- 20 PRESIDING JUDGE KORNER: [9:33:23] Thank you very much.
- 21 Yes, appearances. Prosecution first, please.
- 22 MR NICHOLLS: [9:33:29] Good morning, Madam President. Good morning,
- 23 your Honours, everybody in the courtroom and watching. I'm Julian Nicholls. I'm
- 24 joined today with Claire Sabatini, Pubudu Sachithanandan, Laura Morris and
- 25 Mohanad Elkholy. Thank you.

1 PRESIDING JUDGE KORNER: [9:33:45] Defence.

- 2 MR LAUCCI: [9:33:49](Interpretation) Good morning, your Honour, your Honours,
- 3 dear colleagues. This morning, alongside Mr Abd-Al-Rahman, present in
- 4 the courtroom, Camille Divet, assistant responsible for evidence analysis; Ahmad Issa,
- 5 case manager; my colleague, Iain Edwards, associate counsel; and myself,
- 6 Cyril Laucci, lead counsel.
- 7 PRESIDING JUDGE KORNER: [9:34:12] And finally, victims' represents.
- 8 MS VON WISTINGHAUSEN: [9:34:15] Good morning, Madam President,
- 9 your Honours. Good morning to everyone in and around the courtroom.
- 10 The victims are represented this morning by my colleague Nasser Amin Abdalla; to
- 11 my right, associate counsel Anand Shah; behind me, our case manager Idriss Anbari;
- 12 and myself, Natalie von Wistinghausen. Thank you.
- 13 PRESIDING JUDGE KORNER: [9:34:38] Yes.
- 14 Now, Mr Sachithanandan, I think you're calling the next witness and you wanted to15 raise something.
- 16 I've got one matter arising out of yesterday that I just want to deal with very quickly,
- 17 and that relates to Mr Choudhry suggested at the end of cross-examination,
- 18 Mr -- because you were there, I don't know whether Mr Sachithanandan was, that

- 21 such person as Ali Kushayb exists had not been put.
- 22 But I went back and checked what Mr Laucci said yesterday when I raised that, and
- 23 what Mr Laucci said then was, whether a person named Ali Kushayb did exist at
- 24 some point in time or not, we have no position.
- 25 So I'm taking it from that, that that part of the Pre-Trial Brief, which seemed to

1 suggest to all of us this part of the case, is no longer being pursued. 2 And for the last time - and I'm not going to raise this again, Mr Laucci - that is right, is 3 it? You have no positive case to put that no such person with the name 4 "Ali Kushayb" actually existed? 5 MR LAUCCI: [9:36:20](Interpretation) I think that it was clear in the brief, and I 6 confirm it, yes. 7 PRESIDING JUDGE KORNER: [9:36:26] I hope that clears the matter. 8 MR NICHOLLS: [9:36:28] Thank you. 9 PRESIDING JUDGE KORNER: [9:36:29] Because I wanted to double-check that 10 myself. 11 Yes. Now, yes, Mr Sachithanandan, I gather you want to raise something in respect 12 of the witness. 13 MR SACHITHANANDAN: [9:36:38] Nothing substantive, your Honour. Just to 14 say that, considering the level of literacy, I'll be adopting extremely simple language 15 during questioning, and I invite the interpreters and the parties, et cetera, to take 16 a similar approach with regard to simplicity of language. 17 The other point, which is a very minor point, is that we are using a -- we passed 18 around some binders with a glossary and some annexes from the Trial Brief, so I will 19 attempt, whenever possible, to mention which number in the glossary I'm using for 20 purposes of clarity of transcript. 21 PRESIDING JUDGE KORNER: [9:37:15] Thank you very much. That's very 22 helpful. 23 Is that what I raised with the Prosecution last week? Is that -- is that the list of terms, 24 as it were? 25 MR NICHOLLS: [9:37:27] No, your Honour, not the complete list, because we are

- 1 still working on that and we were going to consult with the Defence as well on those
- 2 terms. So there's a broader list coming.

3 PRESIDING JUDGE KORNER: [9:37:38] I see. All right.

4 On the question of language, I was going to mention something. I think it's

5 incumbent on all sides to use simple language, particularly for witnesses whose

6 second language is in fact Arabic and who are the only witnesses that the Prosecution

7 can call at the moment. And I think questions containing double negatives, and the

8 like, should be avoided. It really becomes difficult.

9 Also, and this comes from previous experience, reminding witnesses of what they

10 have said before as a lead-in to the actual question you want to put also contains an

11 inbuilt risk that the witness is going to start thinking that he's got to repeat everything

12 that he's already said. So I know it's classical advocacy to -- to start with "you told

13 the Court yesterday or the day before this, now I want to put this to you", but all it

14 does is confuse the witness.

15 And finally, before I -- can I also thank the interpreters, and indeed the people who

16 are taking the note of what's being said, because there's been a dramatic improvement,

17 I think we all feel this week, from what happened last week.

18 Yes, Mr Nicholls.

19 MR NICHOLLS: [9:39:26] We'd just join in that thanks, your Honour, and meant to

20 say so at the end of the hearing yesterday and I forgot. But thank you.

- 8 THE INTERPRETER: [9:54:19] The interpreter is saying not I'm sure what masiq is,
- 9 the word that he used.
- 10 THE WITNESS: [9:54:25] But I would go there and I would come back.
- 11 MR SACHITHANANDAN: [9:54:28]
- 12 Q. [9:54:29] Did you ever hear of an attack that took place on Tendy?
- 13 A. [9:54:39] The first time or some other time? The first time I was inside. It was
- 14 in August when the attack took place.
- 15 Q. [9:54:51] Okay. Was that the only time -- the attack in August, was that
- 16 the only time it was attacked or was there another attack?
- 17 A. [9:55:05] The first attack was in August and then the next one was in March.
- 18 Q. [9:55:15] So focusing on the March attack, do you remember which year that
- 19 took place?
- 20 A. [9:55:28] The last one in March?
- 21 Q. [9:55:32] Correct.
- A. [9:55:39] Maris (phon), March, which month is this? Which month is March?
- 23 Q. [9:55:50] The third month of the year. I'm referring to the third month of
- 24 the year. The attack that took place on the third month of the year, do you
- 25 remember which year it was?

A. [9:56:05] I cannot remember, but it may have been March, the third month of
 2004.

3 Q. [9:56:19] Could you please describe to the Court the attack that took place in4 March.

5 A. [9:56:33] In the third month, on 25th or 24th.

Q. [9:56:53] Please keep going, Mr Witness. Just tell us what happened at the
attack, like a story, and then I will ask you some questions about it.

8 A. [9:57:04] Okay. We were at the village and the -- there was an attack in

9 the third month. It was either the 24th or the 25th. And our friends from

10 the mountain Nabga and Soru went -- our friends went to this -- to the mountains and

11 at the time there were four hours of attacks and bombings by plane. And then after

12 that the vehicles arrived and the Janjaweed came on the backs of camels and horses,

13 so we went to the mountains and we stayed there. The vehicles arrived close to

14 the Nabga mountain. And we were up in the mountain, we could see the cars from

15 up there, and the soldiers got out of the cars. Ali Kushayb also got out of the car and

16 he gave instructions to the soldiers and he was pointing with his hands. The army

17 would go in the directions that he pointed to.

After that we went to Sindu, and when he got out of the car he had a black stick in his
hand. So we went to Sindu. They were the whole of Wednesday and Thursday in
Tendy. And on Friday they moved and went to Sindu as well.

And when they arrived in Sindu we left Sindu, we went to Tendy, and from Tendy toMukjar.

2 Q. [9:59:35] Once in a while you will see me raise my hand like this and I just mean

3 stop for a second and I just want to ask you some questions.

4 So you mentioned that the attack took place on 25 March.

5 Can you tell us how do you know it was the 25th.

6 A. [10:00:02] On that day I wanted to go to Mukjar and the attack took place on that

7 day. That's why I could remember the date.

8 Q. [10:00:18] And is this something you knew yourself, or is this something you

9 learned from somebody else, the date?

10 A. [10:00:34] I remember that I was planning to go to Mukjar to get my nationality

ID and I remember that the official told me to come on a specific date and that's why Iremember that date.

13 Q. [10:00:52] Okay. So you said you were watching the attack from the mountain.

14 Can you tell us how far from Tendy you were walking to the -- sorry, let me rephrase

15 that question.

16 The place where you were watching the attack from, how far was it from Tendy17 village?

A. [10:01:22] From where I was watching the attack it wasn't too far, but I can't
really tell exactly how many metres or kilometres, but maximum 1 kilometre. I was
on the top of the mountain and they were underneath. It's a very high mountain.
Q. [10:01:48] Were you watching there alone, or were you with other people?

22 A. [10:01:56] I was with other people, Adam Nahid Numan, Ahmad Issa and

23 Abakar. And there is somebody else that I forgot his name, but I -- there was

24 somebody else with us.

25 Q. [10:02:17] That's fine. And it's very helpful for us when you say you can't

1 remember. So whenever you don't remember something, just say that.

2 A. [10:02:34] (Speaks English) Okay.

3 Q. [10:02:34] You said that you saw Ali Kushayb. How do you know

4 Ali Kushayb?

5 A. [10:02:42] I saw him before and that's why I knew him at that time. And when

6 he came he got out of the car. I immediately knew it was him.

7 Q. [10:02:59] Can you tell us where did you see him before this attack?

8 A. [10:03:07] Before the attack I met him in Garsila. I used to carry oil on my

9 donkeys and transport it to Garsila.

10 Q. [10:03:23] Could you describe to the Court, like a story, how you saw

11 Ali Kushayb in Garsila.

12 A. [10:03:37] When I go to the market I used to see him there. He used to sit and

13 drink tea with his friends and I remember the people calling him "Ali Kushayb".

14 And I heard that he's got a pharmacy in Garsila. I didn't see that pharmacy myself,

15 but that's what I heard from other people.

16 Q. [10:04:08] When you saw him in Garsila, how far away from him were you?

17 A. [10:04:18] He was very close, not far at all. Maybe 15 to 20 metres.

18 Q. [10:04:30] Do you remember who told you that this was Ali Kushayb?

19 A. [10:04:38] No, I don't remember, but people used to call him this is "Ali Kushayb,

20 Ali Kushayb". But I can't remember exactly who told me that this is Ali Kushayb,

21 but I remember that this is what I was told in the market.

22 Q. [10:05:03] And just so we understand, is it that somebody told you this was

23 Ali Kushayb, or somebody called him Ali Kushayb?

A. [10:05:18] No, somebody called him Ali Kushayb and another person told me

25 that this is Ali Kushayb. Because he was quite a famous person. He had this

1 pharmacy and also he was a civilian defence coordinator, so he had a position in

2 the government. That's why people knew him.

3 Q. [10:05:46] And is it only one time that you saw him in Garsila, or more than one4 time?

5 A. [10:05:56] No, after the war I met him again in the hospital of Garsila. That was

6 in October. Oh, no, I'm sorry, I mean 2010.

7 Q. [10:06:11] Right. And we'll definitely come to that point, Mr Witness, but I

8 want to take things one by one. So let's finish discussing the attack on Tendy on

9 the third month of 2004 first.

10 A. [10:06:32] That's fine.

11 Q. [10:06:42] (Microphone not activated) Sorry, sorry, is my mic working? Okay,
12 very good.

13 I just want to go back to Garsila for a second.

14 When you say you saw Ali Kushayb in Garsila, could you indicate, for example, using

15 this courtroom, how far Ali Kushayb was from you.

16 A. [10:07:09] The distance was very close, about 10 metres or 15 metres.

17 Q. [10:07:16] Okay. So, for example, if we take where the judges are sitting in

18 relation to you, was it closer than the judges or further than the judges?

19 A. [10:07:30] Almost the same distance.

20 Q. [10:07:38] Okay. So now I want to go back to Tendy. You said you saw

21 Ali Kushayb in Tendy. Could you please explain to us what he was doing.

A. [10:07:55] Well, exactly, I saw him when he arrived. We were at the top of

23 the mountain. He got out of the car and he was holding a black stick. And -- and

24 he was pointing, stretching his arm to different directions. When he points to

25 a certain direction, the army go in that direction. So he was giving commands to

1 the forces, either this is the army or the Janjaweed. 2 Q. [10:08:35] And when you saw him, was he facing -- which direction was he 3 facing? Was he facing towards you, away from you, some other direction? 4 A. [10:08:55] In -- in all directions. We were all towards the east, and then he was 5 pointing to the right and to the left. 6 [10:09:10] Okay. Please continue. So when -- so he was pointing, people were Q. 7 moving. How long did you stay there watching this? 8 A. [10:09:29] I am not really sure how long. I'm not sure.

9 Q. [10:09:39] At some point you said you started moving. Why did you leave

10 the mountain?

A. [10:09:53] Because of the attacks. It was getting heavier and heavier. So that'swhy we left.

Q. [10:10:04] So the attack, was it only on Tendy village or was it also were youwere?

15 A. [10:10:20] Yes, they attacked the area where we were there. They went out --

16 THE INTERPRETER: [10:10:36] Apologies, the witness is using a word karakir, and

17 interpreter is not sure what he means by that.

18 MR SACHITHANANDAN: [10:10:45]

19 Q. [10:10:46] Mr Witness, you used the word *karakir*, could you explain to us what20 that word means.

A. [10:11:06] In our language it means -- it means a *khor*. We usually use the word *khor* for it. But in modern standard Arabic I can't tell you exactly what it means, but
this is what we call it, a *khor*.

We don't need to deal in metres or kilometres. 8 Can you tell me how long it would take for you to walk, just so that we know. Is it 9 a few minutes, 10 minutes? You know, how long would it take you to walk from 10 where you were watching this attack to Tendy village? 11 A. [10:15:07] From the foot of the mountain, maybe 15 or 20 minutes to go up 12 the mountain. From the village to the top of the mountain. 13 Q. [10:15:30] You mentioned that Mr Kushayb was pointing in certain directions 14 and then people were moving. Can you describe what were the attackers wearing, 15 what clothes were they wearing? 16 A. [10:15:55] Military, military and police, and Abu Tera and Janjaweed. 17 The government -- the government forces were -- were wearing khaki uniforms and 18 then the rest were wearing different clothes. 19 THE INTERPRETER: [10:16:21] The interpreter didn't get the last part. And 20 the witness is using "Abu Tera", a term called "Abu Tera" that I don't understand. 21 MR SACHITHANANDAN: [10:16:34] For the benefit of the persons in 22 the courtroom, Abu Tera can be found at entry 54 of the glossary. And I'll make sure 23 that the interpreters get it as soon as we break.

- 17 All these people I met in prison and all were known to me.
- 18 Q. [10:54:35] Who is *Umdah* Yahya?
- 19 A. [10:54:45] *Umdah* Yahya, he was the mayor of Tendy.
- 20 Q. [10:54:59] Which area was Umdah Adam Husayn in charge of?
- 21 A. [10:55:12] He was the mayor of the Kirarow village.
- 22 Q. [10:55:22] Which area was *Sheikh* Abdallah in charge of?
- 23 A. [10:55:31] He was also from Tendy.
- 24 MR SACHITHANANDAN: [10:55:46] Your Honour, I'm at a logical stopping point.
- 25 Perhaps we take the break now.

A. [11:35:54] The father of Muhammad Umar Zarruq, he was not an officer, he was
a *shartay*.

- 8 Q. [11:36:11] The -- the people that you saw in -- in prison with you, do you know
- 9 which villages they came from?
- 10 A. [11:36:25] You mean Muhammad Umar?
- 11 Q. [11:36:31] No. Let me -- let me rephrase. Okay.
- 12 A. [11:36:37] Muhammad Umar is from Sindu.

13 Q. [11:36:39] Just one point, Mr Witness. Because the interpreters are interpreting

14 between you and me, just give a few seconds of a break between me asking a question

2 A. [11:38:40] Most of them were Fur, but some of them were Tama, Borgo and

3 Masalit, and some from Zaghawa as well.

4 Q. [11:38:56] On the day that you were taken to prison, how did the police treat

5 you and other prisoners?

6 A. [11:39:12] It was really bad treatment.

7 Q. [11:39:20] Now, Mr Witness, as I mentioned earlier, it's very important to have

8 detail, so could you please tell us in detail how the police treated you and your fellow

9 prisoners on the first day of your arrest.

10 A. [11:39:40] On the first day they -- there was a lot of beating up. They beat up

11 people and kicked them. That's what happened on the first day.

A. [11:40:52] The police was treating all the prisoners really badly and beatingthem up.

Q. [11:41:06] Right. But let's -- let's go back to *Umdah* Yahya. How was *Umdah*Yahya treated in the prison?

A. [11:41:23] I can't tell because there was a lot of people, so I can't tell how he was

25 treated. But I -- I saw that the treatment with all the prisoners was really bad, and all

- 1 of them were beaten up and kicked.
- 2 Q. [11:41:49] And how were the prisoners behaving when they were being beaten
- 3 and kicked?
- 4 A. [11:42:09] People were just falling underneath each other and trying to escape
- 5 from the beating.
- 6 Q. [11:42:22] And how were you treated when you were in the prison on your first7 day?
- 8 A. [11:42:29] Very bad treatment. Very bad treatment.
- 9 After they let some people out, it was -- it got much worse. They cut my hands and
- 10 my right leg and my back with -- and they throw hot plastic on me as well.
- 11 Q. [11:43:04] Okay. And I just want to understand when this happened. Did this
- 12 happen on the day you were arrested or later?
- 13 A. [11:43:17] No, later. Later.
- 14 Q. [11:43:27] How were you treated on the first day of your arrest?
- 15 A. [11:43:37] On the first day they just put me in prison. That was it. But then
- 16 the next day they started beating people up and kicking them.
- 17 Q. [11:43:49] Okay. So the day after you were put in prison, can you tell us who18 was beaten.
- 19 A. [11:44:06] I don't know the names.
- Q. [11:44:13] You mentioned earlier that Hassan Juma was near where you werearrested.
- 22 A. [11:44:26] That was outside. But that --
- Q. [11:44:33] One minute, Mr Witness. Let me just finish my question and I'll
  definitely give you time to answer.
- 25 At the time that you were in prison, do you know where Hassan Juma was?

1 A. [11:44:53] He was the one who held me on the gate and put me in prison.

2 Q. [11:45:01] Right. But when you were in prison, do you know where

3 Hassan Juma was?

4 A. [11:45:18] He was outside, not inside.

5 Q. [11:45:31] You mentioned someone called Korin, who was in the popular police.

6 At the time you were in prison, where was Korin?

7 A. [11:45:50] He was outside as well. He takes people from the gate and put them8 in prison.

9 Q. [11:46:01] Do you know the names of any of the persons who were carrying out10 these beatings?

11 A. [11:46:16] No, I don't know that. Because there are so many people in

12 the police and in the military, and they were not from the village, they were from

13 outside our village, but I don't know. They are from different areas.

14 Q. [11:46:34] The people who were beating you, please describe their uniforms for15 us.

16 A. [11:46:46] Military uniform and police uniform.

17 Q. [11:46:57] You mentioned *Umdah* Adam Husayn. Can you please tell us how
18 *Umdah* Adam Husayn was treated.

19 A. [11:47:15] The same treatment, same treatment that all the prisoners had.

20 Q. [11:47:28] You mentioned that other people were beaten. When you say "same

21 treatment", do you mean that *Umdah* Adam Husayn was beaten, or not?

A. [11:47:48] Yes, he was beaten. All the prisoners got beaten in prison.

23 Q. [11:47:58] You mentioned Adam Nahid Numan -- and I'm sorry that this sounds

24 a bit repetitive, but how was Adam Nahid Numan treated in prison?

25 A. [11:48:11] The same treatment again. No one escaped this treatment. All

- 1 the prisoners treated the -- were treated the same.
- 2 Q. [11:48:23] And what was the result of this -- these beatings and kickings? Did
- 3 people remain healthy, or were they injured in some way?
- 4 A. [11:48:36] Some people got injured, yes.
- 5 Q. [11:48:42] Please tell us who got injured.
- 6 A. [11:48:50] I don't know the names, but I remember there was somebody called
- 7 Hassan. After we went out of prison, I met him a couple of times.
- 8 Q. [11:49:06] The injuries that you suffered, can you tell us roughly which day it
- 9 was that you suffered these injuries.
- 10 A. [11:49:24] I can't tell really. I can't tell exactly, because people -- I was very ill,
- 11 so I can't tell. I can't tell.
- 12 Q. [11:49:39] I understand, Mr Witness. But just because we were not there, can
- 13 you explain to us what you mean by you were "very ill".
- 14 A. [11:49:54] I was tortured a lot, and that's why I was very ill.
- 15 Q. [11:50:07] Mr Witness, you mentioned being injured on your back. Could you
- 16 tell us how you were injured on your back.
- A. [11:50:17] Because of all the beating and the hot plastic. And that's why I gotinjured on my back.
- 19 Q. [11:50:28] What happened with the hot plastic? What did people do to you20 with the hot plastic?
- 21 A. [11:50:43] To torture us. To torture us.
- Q. [11:50:52] And did they ask you anything while you were being tortured, ornot?
- A. [11:51:03] No, they didn't ask me about anything.
- 25 Q. [11:51:13] Can you explain to us -- and I'm sorry, I understand that this is not

1	very easy for you. Can you explain to us how the hot plastic was used on your
2	body.
3	A. [11:51:31] They were beating me up. I don't know what happened exactly, but
4	they used hot plastic. I don't know how they used it exactly. I don't know what's
5	the reason exact reason for my injury.
6	Q. [11:51:57] Could I please ask the court officer to pull up a document. It's
7	DAR-OTP-0219-5104. Confidential, please, not to the public.
8	Mr Witness, can you please look at the screen in front of you. Do you see
9	a photograph on the screen in front of you?
10	A. [11:52:59] Yes, I can see it.
11	Q. [11:53:04] Can you please tell us what this photograph is.
12	A. [11:53:13] This is my right leg.
13	Q. [11:53:25] Please explain to the Court
14	A. [11:53:40] (No interpretation)
15	Q. [11:53:41] Please explain to the Court how you got this injury.
16	A. [11:53:50] I was beaten with hot plastic.
17	PRESIDING JUDGE KORNER: [11:54:00] Could we have the date of
18	the photograph.
19	MR SACHITHANANDAN: [11:54:04] Yes.
20	Q. [11:54:07] Mr Witness, do you remember when this photograph was taken?
21	A. [11:54:21] I remember this photo being taken, but I don't remember the date.
22	Q. [11:54:28] Yeah. You remember people from the Office of the Prosecutor
23	interviewing you?
24	PRESIDING JUDGE KORNER: [11:54:35] I'm assuming that they took
25	the photograph, or is this a photograph that he handed over?

- 1 MR SACHITHANANDAN: [11:54:43] We took this photo, your Honour.
- 2 PRESIDING JUDGE KORNER: [11:54:46] Yes. Well, then don't ask him for the date.
- 3 You just give the date.
- 4 MR SACHITHANANDAN: [11:54:50] Very well, your Honour.
- 5 MR LAUCCI: [11:54:56] Madam President and dear colleagues, if that can save you
- 6 time, I want to say that we do not dispute the date.
- 7 PRESIDING JUDGE KORNER: [11:55:03] I rather assumed you didn't, that's what I
- 8 said go ahead and give the date.
- 9 I assume, Mr Laucci, you would object if there was something to object to.
- 10 MR SACHITHANANDAN: [11:55:17] Yes. The photograph was taken on
- 11 13 August 2021, as -- and is mentioned in the statement.
- 12 If the court officer could pull up another photograph. It's DAR-OTP-0219-5103.
- 13 Q. [11:56:17] Mr Witness, do you see this photo in front of you?
- 14 A. [11:56:23] Yes, I can see it.
- 15 Q. [11:56:26] Can you tell us what this photo is.
- 16 A. [11:56:33] This is my back. My back here.
- 17 Q. [11:56:38] Can you tell us how you got this injury.
- 18 A. [11:56:46] In the same way, hot plastic.
- 19 MR SACHITHANANDAN: [11:56:55] Your Honour, just a correction. The photo
- 20 was taken on 17 August 2021. Prior photo and this photo as well. Thank you.
- 21 This can be -- this can be taken down.
- Q. [11:57:17] Mr Witness, when you were in prison, do you recall any attack takingplace on Mukjar?
- A. [11:57:34] Attack on Mukjar happened approximately on the 1st, 1 April, I -- I
- 25 think, in the afternoon.

1 Q. [11:57:51] And why do you think it was 1 April?

2 A. [11:58:07] After I went out of prison, I knew or I learnt about that.

3 Q. [11:58:13] Please describe what you heard -- sorry, please describe what you

4 know of this attack on Mukjar.

5 A. [11:58:26] People in the market talked about this attack. They said that it was

6 a Tuesday, 1 April. A lot of people were talking about it. But during the time of

7 the attack itself, I was in prison.

8 PRESIDING JUDGE KORNER: [11:58:44] Mr Sachithanandan, I think this is

9 a witness where you really need to help with questions. It's the opposite of

10 the witness we had yesterday.

11 MR SACHITHANANDAN: [11:58:53] Indeed, your Honour. I'm trying to fight

12 a lifetime of training in not leading, so -- but, yeah, I take the point.

13 PRESIDING JUDGE KORNER: [11:59:01] Well, no, it isn't leading, but just I think

14 you're going to have to ask more questions than -- I think he's probably a witness who

15 finds questions more helpful than being asked to tell his story.

16 MR SACHITHANANDAN: [11:59:12] Indeed, your Honour. Point taken.

17 Q. [11:59:18] Mr Witness, when you were in the prison - and you said you were in

18 prison when the Mukjar attack happened - could can you see or hear anything of this

19 attack?

20 A. [11:59:38] I was in prison, but I could hear the ammunition, heavy ammunition.

21 Q. [11:59:52] Do you mean shooting, Mr Witness?

22 A. [11:59:58] Yes, firing bullets.

Q. [12:00:04] Now, you mentioned earlier that some people were taken to Garsilaand killed.

25 A. [12:00:14] Yes.

- 1 Q. [12:00:16] Do you remember how long it took from the -- from the attack on
- 2 Mukjar, after the attack, how long it took from the attack on Mukjar until these people

3 were taken?

4 A. [12:00:39] The attack was on the 1st and the people were taken and killed on

5 the 2nd.

- 6 Q. [12:00:55] So I want to now talk about the day on which people were taken and
- 7 killed. On that day, how were people treated --
- 8 A. [12:01:08] That was the second of the fourth month.
- 9 Q. [12:01:14] Okay. And I will come to that in detail.
- 10 On that day, on the day that people were taken out to be killed, how were
- 11 the prisoners treated by the people running the prison?
- 12 A. [12:01:40] The treatment, as I told you, was very bad.
- 13 THE INTERPRETER: [12:01:48] And a note from the interpreter: Can the witness
- 14 please repeat the last sentence after he's saying -- after saying that the treatment was
- 15 very bad.
- 16 MR SACHITHANANDAN: [12:01:57]
- 17 Q. [12:01:57] Mr Witness, the interpreter didn't hear what you said after you said
- 18 the treatment was very bad. Could you repeat.
- 19 A. [12:02:08] The treatment that we all received was very bad.
- Q. [12:02:18] Please describe to us how the prisoners were taken out of the prisonto go to Garsila.
- 22 A. [12:02:34] The prisoners were taken by the people of Ali Kushayb and
- 23 Abdullah Torshein, and other officers. They came and stood in front of the prison
- 24 and said, "These prisoners are to be taken to Garsila."
- 25 Q. [12:03:09] How is it that you could see Ali Kushayb?

- 1 A. [12:03:20] What do you mean?
- 2 Q. [12:03:23] Sorry, that was a bad question.

3 How do you know that it was Ali Kushayb who came to take the prisoners?

- 4 A. [12:03:40] I could see that people were taken out of prison and loaded on
- 5 vehicles.
- 6 Q. [12:03:54] Right. But how do you know that Ali Kushayb was there?
- 7 A. [12:04:04] He was there because he was standing in front of the prison's gate.
- 8 And we could see him with our own eyes.
- 9 Q. [12:04:16] Now, in the same way we did earlier, using this courtroom, can you
- 10 tell us, roughly speaking, was Ali Kushayb, let's say, where the judges are
- 11 sitting -- one second -- where the judges are sitting, beyond them, or closer than
- 12 where the judges are sitting?
- 13 A. [12:04:45] He was closer to me than the judges. He was in the middle, standing14 in the middle.
- 15 PRESIDING JUDGE KORNER: [12:04:54] Do you want to give an estimate? I mean,
- 16 you have got the measurements of the court.
- 17 MR SACHITHANANDAN: [12:04:59] For the record, the witness indicates the very
- 18 middle of the courtroom. I'm sure we can -- we have -- we have the measurements
- 19 of the courtroom, so ...
- 20 PRESIDING JUDGE KORNER: [12:05:08] (Microphone not activated)
- 21 MR SACHITHANANDAN: [12:05:14] The mic, your Honour.
- 22 PRESIDING JUDGE KORNER: [12:05:16] Sorry. As a guess, I'd say that was about
- 23 roughly a metre.
- 24 MR LAUCCI: [12:05:28] According -- if I can assist. According to the
- 25 measurements that we received, there should be 10 metres between the witness and

1 yourself, Madam President, which means that the middle should be about 5 metres.

6 A. [12:05:59] Do you mean what he was wearing, or do you want me to describe

7 his character?

8 Q. [12:06:05] Okay. Let's start with his height. Was he a short man, a tall man,

9 a medium height man?

10 A. [12:06:17] He is in the middle. He is not too tall or too short. He's middle

11 height.

12 Q. [12:06:29] Yes. And keep describing. What I want to know is what he looked

13 like physically. If you can keep describing.

14 A. [12:06:46] He is a slim man. He is not fat.

15 Q. [12:06:55] Right. And what was he wearing?

16 A. [12:07:01] He was wearing civilian clothes.

17 Q. [12:07:09] Okay. Let's describe -- what about his head? Did he have -- was he

18 wearing anything on his head or was he not?

19 A. [12:07:24] No, he did not have any headwear.

20 Q. [12:07:30] Let's focus on his hands. Was he holding anything in his hands, or

21 not?

22 A. [12:07:42] He was holding an axe.

23 Q. [12:07:50] Okay. Can you tell us what this axe looked like.

A. [12:08:00] It was a very regular axe made of wood and metal.

25 Q. [12:08:10] You said he was wearing civilian clothes. Can you tell us what

- 1 civilian clothes he was wearing.
- 2 A. [12:08:25] He was wearing grey clothes.
- 3 Q. [12:08:31] Okay. So the top he was wearing, is there a name you have for
- 4 the top he was wearing?
- 5 A. [12:08:46] What do you mean?
- 6 Q. [12:08:50] Okay. So the -- the clothing he was wearing on the top of his body,
- 7 what word -- do you have any word that describes the clothing that he was wearing
- 8 on the upper part of his body?
- 9 A. [12:09:08] He was wearing a *lapsa* (phon).
- 10 Q. [12:09:14] Now I want you to focus on the lower part of his body, that is, the
- 11 waist downwards. What was he wearing on his body, waist downwards.
- 12 A. [12:09:32] I'm not sure I understood.
- 13 Q. [12:09:35] Okay. Now, you said he was wearing a *lapsa* on his upper part of the
- 14 body. So that's useful. That's a name for an item of clothing.
- 15 Do you have a name for what he was wearing, the clothing he was wearing on
- 16 the lower part of his body?
- 17 A. [12:10:02] Do you mean that you want me to describe his -- his body, if he was18 tall or short?
- 19 Q. [12:10:11] No, the clothing, clothing. Right. What clothing, like a trousers --
- 20 A. [12:10:20] As I said, he was wearing a regular grey *lapsa*.
- 21 Q. [12:10:27] That's helpful. I'll move on.
- When you could see him at the distance that you mentioned, what was Ali Kushaybdoing?
- A. [12:10:44] He was giving instructions with his hands and people were moving
- 25 according to the directions he was giving.

1 Q. [12:10:57] Can you tell us what instructions he was giving. 2 A. [12:11:12] I could see him talking and pointing, and I could not hear exactly 3 what he was saying. But I could see him talking and giving directions with his 4 hands. 5 Q. [12:11:26] And when he was giving directions with his hands, what did 6 the people do -- did the people around him do in response to that? 7 A. [12:11:42] They were calling names of people and getting them out of prison. 8 Q. [12:11:51] Okay. Who was calling out the names? 9 A. [12:12:03] I am not sure, but there was somebody calling the names. And there 10 was somebody called Sheikh Muhammad Turgo (phon), he was signing the names of 11 people. 12 [12:12:22] Okay. Do you know someone called Torshein? Q. 13 Entry 4 on the glossary. 14 A. [12:12:33] Abdullah Torshein, he was in Mukjar, and I --15 THE INTERPRETER: [12:12:42] A note from the interpreter: I did not hear 16 the description that he gave to Torshein. 17 MR SACHITHANANDAN: [12:12:48] 18 Q. [12:12:50] Mr Witness, the interpreter didn't hear you. Could you please repeat 19 your answer. 20 A. [12:12:58] Abdullah Al-Tayyib Torshein, he was a governor in the Mukjar 21 municipality or locality. 22 Q. [12:13:09] And at the time that Kushayb was in front of you giving instructions 23 with his hands, where was Abdullah Torshein? 24 A. [12:13:27] Torshein was next to him. They were standing together. 25 Q. [12:13:32] And how do you know that it was Torshein?

- 1 A. [12:13:45] Torshein was a governor at the Mukjar locality, and he was a leader in
- 2 that area, and anybody would know him.
- 3 Q. [12:13:57] You mentioned a person calling out names. Please tell us which
- 4 names were called out.
- 5 A. [12:14:17] The names are *Umdah* Yahya, Adam Yahya Sharaf Al-Din, Ibrahim,
- 6 Adam Issa, Ishaq Adam Isa, Haroun Adam, Sheikh Abdallah, Adam Husayn, Umdah
- 7 Issa Harun Nour, Muhammad Umar. These are the names that I heard him calling.
- 8 Q. [12:15:02] You mentioned that Adam Nahid Numan was with you in the prison.
- 9 Did he remain in the prison, or did he not remain in the prison?
- 10 A. [12:15:21] You mean Adam Nahid?
- 11 Q. [12:15:24] Yes.
- 12 A. [12:15:26] No, Adam Nahid did not stay in prison. He was taken out.
- 13 Q. [12:15:34] Okay. So you mentioned that these people's names were called out.
- 14 What happened when these names were called out?
- 15 A. [12:15:52] I'm not really sure exactly what happened.
- 16 Q. [12:16:01] Okay. So, for example, they called out *Umdah* Yahya's name. What
- 17 did *Umdah* Yahya do when his name was called out?
- 18 A. [12:16:16] He didn't do anything. He -- he just heard his name being called.
- 19 Q. [12:16:25] Okay. So you said that at some point people were taken away
- 20 towards Garsila to be killed. At what point did that happen?
- 21 A. [12:16:41] They took them out of prison, loaded them on cars and on vehicles,
- 22 and they said that they will bring them to Garsila, but they never really made it to
- 23 Garsila. They were killed at a brook, a *khor*.
- 24 Q. [12:16:57] Okay. Now, again, because we were not there, please describe to us
- 25 how they were taken out of prison, these prisoners.

1 A. [12:17:12] They took them out of prison and they loaded them on vehicles.

2 People at the prison said to them, "Get out", and they loaded them on vehicles.

3 Q. [12:17:28] When these prisoners were being taken out of the prison, where was

4 Ali Kushayb?

5 A. [12:17:39] Ali Kushayb was standing in front of the prison.

6 Q. [12:17:44] And when these prisoners were being taken out, what was

7 Ali Kushayb doing?

8 A. [12:17:54] He hit *Umdah* Yahya with an axe on the head and threw him on

9 the ground.

10 Q. [12:18:08] And how do you know -- sorry, I know that some of these questions

11 will sound repetitive, but it's just because it's very important for us to understand

12 the truth of what happened.

13 A. [12:18:18] That is not a problem.

14 Q. [12:18:20] How -- very good. How do you know that Ali Kushayb struck
15 *Umdah* Yahya?

A. [12:18:34] The prison's gate is right in front of me, and the minute that *Umdah*Yahya left through the gate, he -- he hit him.

18 Q. [12:18:47] Okay. Just so I understand, is this something you saw, or is this
19 something -- is this something you saw, or not?

20 A. [12:18:59] I was inside the prison, but I could see him through the gate.

21 PRESIDING JUDGE KORNER: [12:19:17] I'm sorry to repeat myself, but is there

a reason why we can't use the photograph? Is it that it's completely different now?

23 I mean, the photograph was taken. I appreciate it's not a -- an exhibit with an ERN

24 because it's an annex, but would it not be simpler for the witness to be shown it and

25 indicate what he's talking about?

2 PRESIDING JUDGE KORNER: [12:19:44] I mean, I don't know what gate he -- I

3 mean, he's referring to a gate. What gate is he actually talking about?

5 the court officer. Perhaps the court officer could pull up the clean image of that

6 annex. The image of the prison that we are talking about.

7 THE COURT OFFICER: [12:20:04] I have not received any -- any image that I can

8 pull up. I don't have the clean version that you would like me to pull up. So if you

9 provide that to us, then we can do that.

10 MR SACHITHANANDAN: [12:20:15] Right. I'll ask -- (Overlapping speakers)

11 PRESIDING JUDGE KORNER: [12:20:16] All right. Why don't you -- you're

12 obviously going to go past the adjournment. Can we try and sort this out over

13 the adjournment. Yes.

14 MR SACHITHANANDAN: [12:20:24] But I will ask some clarifying questions about

15 the -- the gate, et cetera, because I think it's useful to get on the record.

16 Q. [12:20:34] Mr Witness, when you say you saw Ali Kushayb, was he at this time

17 inside the police station, or was he standing outside the police station, just so we

18 understand?

19 A. [12:20:54] He was inside the police station.

20 Q. [12:21:07] Right. So when you say you could see him past the gate, am I correct

- 21 in understanding that this gate is inside the police station?
- A. [12:21:24] He was standing at the gate or the door to the prison.
- 23 Q. [12:21:31] And inside the prison; is that correct?

A. [12:21:44] Yes, that was inside the prison's gate, and there was also the head

25 office of the police.

1 Q. [12:21:56] When Umdah Yahya was struck by Ali Kushayb, what did Umdah

2 Yahya do?

3 A. [12:22:13] I don't know what Umdah Yahya did, but what I know is that he was

4 in the prison, he was taken out of prison, he was hit on the head and he fell.

5 Q. [12:22:26] Okay. So what did anyone else do to *Umdah* Yahya when he was on6 the ground?

7 A. [12:22:44] The soldiers took him and loaded him on the vehicle.

8 Q. [12:22:57] And is this something you could see, or -- or how do you know that

9 happened?

10 A. [12:23:09] I could see that with my own eyes. I was inside and they were

11 outside, and I could see through the prison door. It had openings and I could see

12 through them.

13 Q. [12:23:25] Was Umdah Yahya the only person who was loaded on to a vehicle, or

14 was anyone else loaded on to a vehicle?

15 A. [12:23:40] There were many more people.

16 Q. [12:23:46] And was it only one vehicle, or was there more than one vehicle?

17 A. [12:23:53] There were many vehicles, not just one.

18 Q. [12:24:01] While these prisoners were being loaded on to the vehicle, what was

19 Ali Kushayb doing?

20 A. [12:24:17] He -- he just hit some of them -- sorry, he just hit Umdah Yahya. And

21 then after that he didn't do anything. They were loaded on the vehicles and

22 the vehicles moved away.

Q. [12:24:33] Were people only taken from the room in which you were, or werepeople taken from any other room?

25 A. [12:24:51] They took people from the place where I was imprisoned, from the

same prison where I was, and from another prison. Q. [12:25:04] And how can you -- how do you know that people were taken, not just from your room, but from another room? A. [12:25:22] I was in the same room as these people. So when they called names of people and they took them out, of course, I could see that they were leaving. There were some names that were called and there were names that were not called. Q. [12:25:40] Right. But I'm not talking about the room in which you were. I'm talking -- you have said that people were also taken from another room. Is that something you saw? A. [12:25:58] I saw this with my own eyes. Q. [12:26:07] When all the prisoners that you saw were loaded, what happened then? When everyone was loaded into the vehicles. A. [12:26:21] They moved towards Garsila after having been loaded on the vehicles. Q. [12:26:31] When the vehicles were moving, what was Ali Kushayb doing? A. [12:26:44] He got into a car and left as well. [12:26:53] And is this something you saw with your own eyes, or not? Q. A. [12:27:02] You mean when he got into the car? Q. [12:27:05] Yes. A. [12:27:11] I could see him getting into the car. [12:27:17] And at the time that Ali Kushayb was getting into the car, what was Q. Torshein doing? A. [12:27:36] I don't know. So after I saw him at the prison door, I don't know what happened after that. Q. [12:27:49] Did he leave with the other vehicles, or did he not leave with the other

- 1 vehicles? That's what I'm trying to find out.
- 2 A. [12:28:03] Whom do you mean? Torshein?

- 4 A. [12:28:13] No, he -- he stayed in -- in Mukjar. He did not leave.

5 Q. [12:28:19] And how do you know that? How do you know that Torshein

- 6 stayed and did not leave?
- 7 A. [12:28:33] He is a responsible man in Mukjar, so he did not leave.
- 8 Q. [12:28:48] Mr Witness, when the names of people were being called out and

9 people were walking -- being taken out of the prison, how long did that take, roughly

10 speaking? Five minutes, 10 minutes? If you can just estimate for us.

11 A. [12:29:15] I cannot really give you an accurate estimate because I did not have

12 a watch, so I could not really specify how many minutes that took.

13 Q. [12:29:30] I understand. Thank you, Mr Witness.

14 I hear -- I'm told that the image is now available to the court officer. For the record,

15 this is annex 15 to the Prosecution trial brief with all Prosecution annotations

16 removed so as to not lead the witness.

- 10 MR SACHITHANANDAN: [12:31:48] Yes, yes.
- 11 Q. [12:31:49] Mr Witness --
- 12 PRESIDING JUDGE KORNER: [12:31:50] (Microphone not activated)
- 13 I'm sorry. My microphone.
- 14 MR SACHITHANANDAN: [12:31:53] Yes.
- 15 Q. [12:31:54] Mr Witness, the court officer is going to help you mark this photo.
- 16 So if you can just circle which building you were in.
- 17 A. [12:32:03] (No interpretation)
- 18 MR SACHITHANANDAN: [12:32:52] It's fine, your Honour. I'll try to clarify
- 19 using -- using questions. It looks like the pen isn't working.
- 20 PRESIDING JUDGE KORNER: [12:32:59] (Microphone not activated) I'm sorry. I
- 21 keep forgetting.
- 22 What's the problem? He can't -- he can't do it?
- 23 THE COURT OFFICER: [12:33:06] Madam President, it's technologically possible,

10 Q. [12:36:22] Mr Witness, can you repeat for us the name of the *khor* you

15 A. [12:36:45] No, the only name is *khor* Talaba, but now it is called *khor* Kushef

16 (phon). Now they call -- they name it now *khor* Kushef after the people were killed.

17 Q. [12:37:03] I'm not entirely sure whether the transcript reflects the answer.

18 Mr Witness, what is the other name? Could you repeat slowly.

19 A. [12:37:15] Khor Kushef.

20 Q. [12:37:21] Do you know why it's called *khor* Kushef?

A. [12:37:34] After the people were killed in that *khor*, the name was changed. It

22 was *khor* Talaba before.

23 Q. [12:37:46] Sorry, one final question on that. Why was the name changed after

24 those people were killed?

A. [12:37:58] Because the people were killed in that *khor*.

1 Q. [12:38:06] How do you know that people were killed at that *khor*?

2 A. [12:38:14] After the people were killed, and maybe after a month or over

3 a month, I went to this *khor* myself and I saw the corpses.

A. [12:41:10] About 10 minutes, 10 minutes maximum. Maybe five even. Veryclose.

25 You know that, right?

- 5 Q. [14:42:15] Mr Witness, I want to go to your statement that you gave to
- 6 the Office of the Prosecutor.
- 7 And for the record, the statement is DAR-OTP-0221 at -- sorry, 0221-0436. And I
- 8 want to go to paragraph 45.
- 9 Mr Witness, I'm going to read a part of your statement. I quote: "After less than an
- 10 hour, I saw the above convoy returning to the courtyard of the police headquarters,
- 11 without prisoners."
- 12 Does that help you remember, Mr Witness?
- 13 A. [14:43:11] The vehicles that went, they were loaded with vehicles. But then
- 14 they came back with no people loaded on them. There were no people in
- 15 the vehicles when they came back.
- 16 Q. [14:43:30] Thank you, Mr Witness. I'm going to move on.
- 17 Mr Witness, earlier today you said that you had seen Ali Kushayb at a hospital once.
- 18 Please tell the Court about seeing him at the hospital.
- 19 A. [14:44:07] I saw him at the Garsila hospital wearing a *jalabya* and a turban.
- 20 Q. [14:44:19] Do you remember roughly when this was?
- 21 A. [14:44:28] Roughly, roughly the distance or what exactly?
- 22 Q. [14:44:35] Do you remember which year you saw Ali Kushayb in the hospital?
- A. [14:44:43] I saw him wearing a *jalabya* and a turban at the Garsila hospital in
- 24 2010.
- 25 Q. [14:44:58] Now again using this courtroom as a way of measuring distance,

- 1 when you saw Ali Kushayb, was he closer than, for example, the judges, or beyond
- 2 the judges, or at the same distance as the judges?

3 A. [14:45:22] He was very close, five or six metres away.

4 Q. [14:45:34] Right. And when you saw him at the hospital, what was

5 Ali Kushayb doing?

6 A. [14:45:45] I don't know exactly. He might have been sick. He might have

7 been visiting someone sick. I don't know. I just saw him there. He recognised

8 someone called Abu Helwa (phon), but I don't know what the motive of his visit is.

9 Q. [14:46:03] Sorry, you said he recognised someone. Can you tell us the name of

- 10 that person again.
- 11 A. [14:46:18] You mean at the hospital?

12 Q. [14:46:21] Yes. I thought you said Ali Kushayb recognised someone. Can you13 please explain what you mean.

14 A. [14:46:34] I saw him talking to someone. He called him

15 Abu Hawa -- Abu Helwa. And they greeted each other and they had a talk. But

- 16 I didn't stay there long, I left a little while afterwards.
- 17 Q. [14:46:56] Mr Witness, does Ali Kushayb have any other names?
- 18 A. [14:47:06] Ali Muhammad Abd-al-Rahman.

19 Q. [14:47:14] And how do you know that that is his full name?

- 20 A. [14:47:22] He is an official in Garsila. He has a drugstore and he was
- 21 coordinating the Popular Defence Forces. Given that he is an official, everyone

22 knows him.

- 23 Q. [14:47:41] How do you know that he was coordinating
- 24 the Popular Defence Forces?
- A. [14:47:49] I heard that from people. People were saying that he is

- 1 the coordinator of the Popular Defence Forces in Garsila.
- 2 Q. [14:48:00] How do you know he has -- or he has a drugstore in Garsila?
- 3 A. [14:48:09] I heard that from people as well. They said he has a drugstore in
- 4 Garsila. I did not see that drugstore myself.
- 5 Q. [14:48:40] My apologies, Mr Witness. I wanted to go back to one thing related
- 6 to your time in Mukjar prison.
- 7 Your Honour, I know this is not your favourite thing, but could we go into private
- 8 session for a few minutes. For the benefit of the audience, it will be perhaps five,
- 9 five minutes.

- 2 Q. [14:52:52] Have you ever seen Minister Ahmad Harun in public or not?
- 3 A. [14:53:03] I saw him on the same day he arrived in Mukjar.
- 4 Q. [14:53:10] Do you remember which year he arrived in Mukjar?
- 5 A. [14:53:20] I can't be sure precisely, but approximately in 2003, roughly speaking.
- 6 But I can't be certain about that.
- 7 MR SACHITHANANDAN: [14:53:31] Your Honour, may I refresh from
- 8 the statement?
- 9 PRESIDING JUDGE KORNER: [14:53:36] (Microphone not activated)

- 11 Q. [14:53:38] Making reference to the statement you gave to the
- 12 Office of the Prosecutor, the details of which I already gave on the record, if we can

4 Q. [14:55:34] Do you remember anything else that Minister Ahmad Harun said?

5 A. [14:55:38] He said the Fur and the money of the Fur are booties and you may

6 target anything you want in -- on their land, including trees.

7 Q. [14:55:54] Now when Minister Ahmad Harun was making this speech, were

8 you - using this courtroom again - closer than you are to the judges, further than

9 you are to the judges, or the same distance?

10 A. [14:56:13] Longer than this distance. And when I heard what he said, I didn't

11 stay there, I left immediately. I rode my donkey and left immediately.

12 Q. [14:56:26] Why did you leave immediately when you heard this?

13 A. [14:56:35] Because what he said is dangerous and I was afraid, and so I left.

14 Q. [14:56:51] Mr Witness, I'm almost at the end of your examination. I just have

15 a few questions related to an earlier time. You remember this morning you

16 mentioned the first attack on Tendy in 2003. Do you remember that?

17 A. [14:57:13] I remember that.

18 Q. [14:57:23] Do you remember having heard of an attack on Kodoom or Bindisi19 around this time?

20 A. [14:57:36] I heard about it around the same time, in August of 2003.

21 Q. [14:57:43] Please tell this Court what you heard about Kodoom and Bindisi.

22 A. [14:57:55] Regarding Kodoom and Bindisi, after our attack -- the attack on us,

23 we went to the mountains and we met people who had fled Kodoom and Bindisi.

24 One person I met told me about what happened regarding the attacks on Kodoom

and Bindisi.

- 2 A. [14:58:29] The person is called Omar Mohamed Saleh and he is from Kodoom.

- 4 A. [14:58:46] I met him in Tendy and we got to talk and he told me about
- 5 the burning of Kodoom and Bindisi. He told me that people came in vehicles and
- 6 told the citizens no one leaves home because the *zakat* office folks are coming to -- for
- 7 that purpose and therefore no one should leave home. And so people stayed home,
- 8 in their homes. No longer than five minutes afterwards did the attack happen.

[15:20:38] All homes in the village of Tendy, they were all burned and destroyed. 3 Not a single home was left standing. 4 Q. [15:20:50] Can you tell us if the attackers took away property? Was there 5 looting? Is this something you saw? 6 A. [15:21:07] They took away everything. There was looting, pillaging, burning, 7 rape, and so forth. They did not leave anything that they did not target. 8 Q. [15:21:25] Can you tell us what happened to the animals. 9 A. [15:21:32] Regarding the animals, they were all pillaged. Not one was left. 10 They were all taken away. 11 Q. [15:21:46] You have described to us, Mr Witness, the conditions of detention at 12 the police headquarters prison in Mukjar, the prison that we have just seen on 13 the screen a minute ago, and you have described to the judges that you have been 14 mistreated by police officers and you said that they cut your hands and your right leg 15 and that hot plastic was thrown at you. 16 Can you tell us if you received any medical care or treatment after this happened to 17 you? 18 A. [15:22:39] I had some -- my own treatment, basic treatment that I managed to get 19 myself when I went home. But there was no medication. There was no 20 transportation to get anything moved --21 THE COURT OFFICER: [15:22:55] Excuse me, could --22 THE WITNESS: [15:22:55](Interpretation) -- from one place to the other. 23 THE COURT OFFICER: [15:22:59] -- counsel please turn off her microphone. 24 Thank you. 25 MS VON WISTINGHAUSEN: [15:23:05]

- 1 Q. [15:23:06] We have seen today pictures of -- of the scars that you have from this
- 2 mistreatment. Can you tell us if these injuries still cause any discomfort today.
- 3 A. [15:23:28] Nothing to report. It's fine.
- 4 Q. [15:23:34] That's good to hear.
