It is anticipated that the International Criminal Court (ICC) located in The Hague, The Netherlands, will shortly be issuing a solicitation on the provision of a **Pharmaceutical Supplies**. In this connection, the ICC is requesting expression of interest from qualified firms.

The ICC will tender for **Pharmaceutical Supplies** for 3 years starting in 2013.

Health and Welfare Unit scope of work for Medical Supplies.

The Medical Office of the Health and Welfare Unit provides Occupational Healthcare, First Aid, ad-hoc (emergency) medical care and Travel Health Services to all staff, including Field mission travellers at the ICC in The Hague (HQ) and in the Field.

The approx. 270 field mission travellers require individual Travel medical kits, anti-Malaria prevention with DEET spray, impregnated bed nets and malaria prophylaxis such as Atovaquon/ Proguanil (Malarone) and Doxycycline.

For the Field paramedics and, for Security transport operations the Medical Office also maintains and provides (a small quantity) of emergency prescription drugs and pharmaceutical supplies, Malaria prophylaxis and emergency medical equipment such as reanimation equipment and AED's and, it provides and re-stocks the Team kits for the Field Offices in various locations in Africa.

The vendor will be required to:

- ❑ Supply the ICC Medical office at the Court **in The Hague** with pharmaceutical supplies (stock and refills), medical equipment, (pre-packed) individual Travel medical kits and medical Team Kits ('Pax'-bags). See attached lists for details.
- ❑ Ensure delivery to the Court in The Hague of Last minute orders for pharmaceutical and medical supplies, (pre-filled) Travel medical kits and (pre-filled) Team kits ('Pax'-bags) if necessary within a 24-36hrs time frame.
- ❑ Provide the Medical office in The Hague with pre-packed pharmaceuticals for stock and refill of individual Travel medical kits in re-closable mini plastic bags with pharmaceutical content description and instruction labels with English and French.
- ❑ A yearly supply of approx. 7500 tablets of Malarone will be required.

- Be accredited in The Netherlands for (international) delivery and supply of prescription drugs, pharmaceuticals and emergency medical equipment for off shore operations and seafaring ships' dispensaries ('Scheepsapotheek).
