# How to complete the application form for participation and/or for reparations before the Court

These guidelines **pertain to the application form which is designed for organizations or institutions**. It does not refer to the form for individual victims. Please complete this application form if you are acting on behalf an Organization or Institution which has suffered direct harm to any of its property which is dedicated to religion, education, art or science or charitable purposes, historic monuments, hospitals or other places or objects dedicated to humanitarian purposes, as a result of a crime under the jurisdiction of the International Criminal Court (ICC or Court), and wish to participate in proceedings before the ICC. The form has been designed to obtain the information needed for your application.

**Before completing the form please read the following instructions carefully.** They will help you fill out the form correctly. For a better understanding of the ICC and the victim participation process in general, please refer to the ICC Victims Participation and Reparations Section (VPRS) information [booklet](#) on the ICC website.

**Every organization or institution** applying to participate and/or claim reparations in ICC proceedings must complete its own **separate application form**. When filling in the application form:

- Please answer all questions as completely as possible. If some questions are not answered, or are only partially answered, the form may be considered by the ICC as incomplete.
- Please note the space limitations of this form. If more space is needed to answer certain questions, please continue on a separate sheet of paper and attach it to the application form. The victim's name and signature should be indicated on each sheet of paper attached to the application form.
- Please write clearly, so that the Court can understand everything that is included in the application. Please use a pen (black ink) rather than a pencil, since pencil can more easily be erased.

The ICC Judges will decide whether the organization/institution is a victim of a crime under the jurisdiction of the ICC, whether the organization/institution is entitled to participate in the proceedings and, in the event of a conviction, whether the organization/institution is entitled to reparations. Applications which are not transmitted to the judges remain in the custody of the Registry of the ICC and are kept confidential.

The judges decide whether the information contained in the form, including the name of the organization/institution and the person acting on behalf of the organization/institution's identity, will be forwarded to the Prosecutor and to the Defence. **Please note that some of the information provided may be made available to the public in the course of judicial proceedings.**

If the person acting on behalf of the organization/institution has security concerns regarding their engagement with the ICC or relating to any information contained in the application form, these concerns should be written down in response to Question 9. Please be aware that, **despite raising security concerns, information recorded in the application may still be shared with the judges and/or the parties during the course of proceedings.**

## Are you acting on behalf of an organization or institution that has sustained direct harm to any of their property?

Throughout the application form, the organization or institution that suffered the harm is referred to as the **organization/institution**. Please note the difference between the organization/institution and the person acting on behalf of the organization/institution for the purposes of the ICC:

*An **organization/institution** victim is: an organization/institution that has sustained direct harm to any of their property which is dedicated to religion, education, art or science or charitable purposes, and to their historic monuments, hospitals and other places and objects for humanitarian purposes.*

*A **person acting on behalf of an organization/institution** is: an individual who represents the organization/institution in some capacity and presents an application to the ICC **on behalf of the organization/institution**.*

**A** Please provide the full name of the organization/ institution, if possible as it appears on documentation of registration, not just an acronym. The document should help to prove the existence of the organization/institution, in particular at the time of the crime alleged (for example: official registration, dated and signed statutes, public statements from the organization/institution, cadastral parcels registration/fees receipts under the name of the organization/institution. If the person acting on behalf of the organization/institution is unable to obtain or produce documents of the type referred to above, he/she can present a declaration signed by two persons (the declarants) who know the organization/institution and can attest to its identity. The declaration must be accompanied by proof of the identity of these two declarants.

**B** A copy of proof of identity of the person(s) submitting the application on behalf of the organization/institution should be submitted with the form ((for example, a national identity card, birth certificate, voting card, passport, driver's license, student or employment card, letter from a local authority, camp registration card, card from a humanitarian agency or a tax document). If the person acting on behalf of the organization/institution is unable to obtain or produce documents of the type referred to above, he/she can present a declaration signed by two

persons (the declarants) who know the applicant and can attest to his/her identity. The declaration must be accompanied by proof of the identity of these two declarants. **Only attach copies of documents, not originals.**

- C If any information in the form is different from the information on the organization/institution or identity document provided (for example, name spelling, date of birth, date of registration), please explain the reason for the difference next to the answer, or on a separate sheet **clearly referencing the error/discrepancy.**
- D Please provide documentation proving the capacity/authority of the person to act on behalf of the organization/institution (nomination of the person as director, president, power/letter of attorney, etc.). If representing the organization/institution as a Legal Representative, please provide a Power of Attorney signed by an authorized representative of the organization/institution (please also provide document(s) proving the identity and the authority of the authorized representative of the organization/institution).

1. What process is being applied for?

Please tick both boxes if the organization/institution wants to participate in the proceedings as well as request reparations in case of a conviction

PARTICIPATION

REPARATIONS *(in case of a conviction)*

Organizations/institutions may choose to participate in judicial proceedings before the ICC against one or more accused persons and request reparations using this form. If the organization/institution would like to apply for both participation and reparations, the person acting on behalf of the organization/institution should tick both the "PARTICIPATION" and "REPARATIONS" boxes.

Should the organization/institution **only wish to participate in judicial proceedings**, meaning, providing its views and concerns about the court proceedings through a lawyer who represents the organization/institution in the courtroom, the organization/institution should only tick the "Participation" box. **If the organization/institution only wishes to participate in the proceedings, the person acting on its behalf may leave question 7 blank.** Please consult the [VPRS information booklet](#) for more information about participation in ICC proceedings.

Should the organization/institution **only wish to request reparations**, the person acting on its behalf should only tick the "Reparations" box.

Please note the important points below:

- i. Reparations will only be awarded in the event of a conviction at the close of criminal proceedings against one or more individuals;
- ii. Relevant judicial proceedings may last several years before a final judgment is pronounced;
- iii. Supporting information related to reparations will be asked for at the appropriate time;
- iv. The available resources for reparations may be limited and less than expected.

**If the organization/institution only wishes to claim reparations, the person acting on its behalf still needs to complete all four pages of the application form.**

Please note that documents related specifically to verifying or supporting reparation claims (that are not immediately available at no cost to the victim at the time the victim completes the form) need not be included at this time for the validity of the form.

Please also consult the [VPRS information booklet](#) for more general information about reparations.

2. What happened to the organization/institution? Describe the events in as much detail as possible

If you do not have enough space to fully describe what happened to the organization/institution, you may use a separate piece of paper to complete your description on which you shall also append your name and signature.

Please be as specific as possible about **what happened to the organization/institution**. It is important to provide a clear description of the facts and details. It is in the interest of the organization/institution to provide a clear and factual account of the events that happened.

If different events took place at different date(s) and/or place(s), please clearly explain each relevant event and record the date when it occurred.

3. When did these event(s) occur? .....

**Please be specific.** If possible, provide the exact date on which the incident(s) occurred (day/month/year). If the date of the events is unknown, please give an approximate the date of events (for example, proximity to major, known events, like a religious holiday, elections, any public memorial, publicly reported armed attacks, as the case may be).

If possible, provide name of a town or city where or near to the place where the incidents occurred.

5. Who, in the view of the organization/institution, is responsible for these events?

If the person acting on behalf of the organization/institution does not know who the person(s) allegedly responsible for these events are, it is sufficient to provide some information that would identify the group to which the individuals belong (for example, a description of the uniforms worn by alleged perpetrators or language spoken by alleged perpetrators, etc.).

If the organization/institution does not know who is responsible for the events, the person acting on behalf can simply reply "not known" in the box provided.

6. What type of direct harm did the events cause to the organization/institution?

Please provide a **detailed description of the loss or damage suffered as a result of the alleged crime(s)**. If a box is ticked, the corresponding harm should be detailed in the description. You may tick more than one box. If you do not have enough space to fully describe the harm, you may use a separate piece of paper to complete your description on which you shall also append your name and signature.

In order to be authorized to participate to judicial proceedings before ICC and/or benefit from reparations, the organization/institution in question **must have sustained direct harm to any of its property (that was damaged, stolen or destroyed) dedicated to religion, education, art or science or charitable purposes, or which is an historic monument, hospital or other place or object dedicated to a humanitarian purpose.**

Thus, information should be provided about the exact nature of the loss or damage to property sustained by the organization/institution has directly experienced as a result of the actions or events described in Question 2.

Please tick the box or boxes that correspond to the type(s) of harm that the organization/institution suffered as a result of the crimes allegedly committed and described in Question 2. Please note that multiple boxes may be ticked, and that the examples provided under each tick box are not exhaustive. Please tick the box “Other” if the person acting on behalf of the organization/institution would like to describe another type of harm suffered. **Once a box is ticked, the person acting on behalf of the organization/institution should add some details in the free text space provided next to the box(es) ticked.**

Please describe any ongoing impact of the harm. If the harm has affected the wider community, please give some details.

If you have documentation detailing the purposes of the property damaged and detailing the harm inflicted on the organization/institution, please attach copies of these documents to this application. For example this could include proof of economic loss, proof of damage to property or any other document proving the harm caused as described. If the person acting on behalf of the organization/institution is unable to obtain or produce documents of the type referred to above, he/she can present a declaration signed by two persons (the declarants) who know the organization/institution at the date on which the incident(s) occurred and can attest of the property loss/damage. The declaration must be accompanied by proof of the identity of these two declarants.

## Page 2 of the form:

7. In the event of a conviction (and if resources are available), what form of reparations would the organization/institution like to claim?

<input type="checkbox"/> <b>REHABILITATION</b> <i>Refers to awards that seek to rehabilitate the persons who suffered harm as a result of the crimes perpetrated against the organization/institution. Depending on the type of organization/institution, this may include psychological or social support.</i>	
<input type="checkbox"/> <b>OTHER FORM OF REPARATIONS</b> <i>May include any type of award the organization/institution considers most appropriate to address and repair the harm suffered. This may include: establishment of the truth, apologies, judicial and legal reforms, commemoration ceremonies, monuments, guarantees of non-repetition (of crimes), peace initiatives, etc.</i>	

For question 7, the person acting on behalf of the organization/institution is invited to tick the box or boxes that correspond with **the type(s) of reparations that the organization/institution wishes to claim.**

Reparations can be anything that can help the victim to redress the harm suffered. This can include compensation, various forms of assistance, restitution, and/or symbolic or moral measures such as apologies and monuments commemorating victims.

It should also be noted that the ICC judges will ultimately decide on how and what type of reparations will be awarded including whether they will be individual, collective or both. Thus, the organization/institution, as a victim, may not necessarily receive the reparation award requested.

In relation to the specific options presented in Question 7 (above), the option for compensation should be ticked if the organization/institution considers financial compensation as the most appropriate award for the harm suffered. It may also be ticked if property that was lost cannot be replaced and only compensation can contribute to repairing the harm.

The restitution box should be ticked if the organization/institution alleged property loss as a form of harm suffered and the specific property lost cannot be replaced or compensated for and is still thought to remain in the possession of the accused person. The restitution box may also be ticked if the restoration of legal right is sought.

The rehabilitation box should be ticked if persons suffered harm as a result of the crimes perpetrated against the organization/institution. Depending on the type of organization/institution, this may include psychological or social support. Finally the rehabilitation box should be ticked if the organization/institution has lost access to certain legal or social services as a result of the crimes committed. If none of the above options corresponds with the type of award that the organization/institution considers most appropriate to address and redress the harm suffered, the person acting on behalf of the organization/institution can tick “Other form of reparations”, and specify in the space provided what type of reparations award would be most appropriate to them.

The Court may order the implementation of reparation measures by the Trust Fund for Victims (TFV)

Please note that by ticking the “Yes” box, the information provided in this form may be transmitted to the ICC’s Trust Fund for Victims so that they may consider how best to use their resources to conduct assistance-related activities or facilitate reparations awards in the event of a conviction. The Trust Fund for Victims is also bound by duties of confidentiality.

### **Trust Fund For Victims**

To complement the Court’s work on reparation, an independent Trust Fund for Victims was established. The ICC judges may ask the Trust Fund to help to carry out its orders of reparations against a convicted person. In addition, the Fund can use the contributions it receives to finance projects for the benefit of victims and their family members.

**SIGNATURES:** It is very important that this form is signed in the signature box on the bottom of Page 2 by the person acting on behalf of the organization/institution.

By signing the form, the person acting on behalf of the organization/institution is verifying the authenticity of the application. This serves to demonstrate that the organization/institution is taking responsibility for the content of the information given in the form and its accuracy, even if someone else has actually written it down. By signing, the organization/institution, through the person acting on behalf, also confirms its intention to submit an application to participate in judicial proceedings before the ICC and/or request reparations.

**Before signing the form**, the person acting on behalf of the organization/institution should either read the form in its entirety/ or have the person assisting in filling in the form read it back to him/her to ensure the accuracy of the information provided.

**After the form is signed by the person acting on behalf of the organization/institution, the form should not be altered in any way** (for example, by adding or removing information). If the organization/institution wishes to modify its declaration, the person acting on its behalf should contact the VPRS which will provide specific guidance to that effect.

Photocopies of documents not specifically requested, but that might be relevant to the application such as police or court records, photographs, films, etc. could also be attached to the application if these documents are immediately available to the organization/institution and at no cost to the victim, but this is not essential for participation in the proceedings.

**All documentation provided** (including the pictures of documents) **should be readable.**

Names and contacts of individuals who could corroborate the reparations claims should be provided if available. Those names should be listed, together with the relevant contact details. **Please note that this information should only be provided with the consent of the individual(s) concerned.**
