Decision to be notified in accordance with regulation 31 of the Regulations of the Court to:

PRE-TRIAL CHAMBER II of the International Criminal Court issues this Decision designating a Single Judge.

1. On 2 March 2022, following the Prosecution's 'Notice pursuant to regulation 45 of the Regulations of the Court' informing the Presidency of its intention to request authorisation from a Pre-Trial Chamber to open an investigation into the situation in Ukraine, the Presidency assigned that situation to Pre-Trial Chamber II.¹

2. On 7 March 2022, the Prosecution informed the Chamber that it received referrals pursuant to articles 13(a) and 14(1) of the Rome Statute (the 'Statute') from 40 States Parties with respect to the situation in Ukraine and that, since a request for authorisation to open an investigation under article 15 of the Statute was no longer required, it decided to open an investigation in the present situation.²

3. The Chamber notes articles 39(2)(b)(iii) and 57(2)(b) of the Statute, rule 7(1) of the Rules of Procedure and Evidence and regulation 47 of the Regulations of the Court.

4. In light of the criteria contained in the aforementioned provisions and, in particular, the need to ensure the proper management, expeditiousness and efficiency of the proceedings, the Chamber considers it appropriate to designate Judge Rosario Salvatore Aitala as Single Judge responsible for carrying out the functions of the Chamber, subject to article 57(2)(a) of the Statute, in this situation for the period from 23 July 2022 to 22 August 2022 (inclusive).
