## I. PROCEDURAL HISTORY

1. On 18 January 2021, the Single Judge, acting on behalf of Pre-Trial Chamber II (the "Chamber") issued the "Decision establishing the principles applicable to victims' participation and representation during the Confirmation Hearing" (the "First Decision"),<sup>1</sup> *inter alia*, instructing the Registry and the parties on the modalities for victims' admission and participation process in the case and appointing Counsel from the Office of Public Counsel for Victims (the "OPCV" or the "Office") to represent applicant victims in the context of the confirmation proceedings.

2. On 5 February 2021, the Single Judge issued the "Decision supplementing the Chamber's first decision on victims' participation and representation and providing additional guidance" (the "Second Decision"),<sup>2</sup> clarifying certain aspects of the First Decision.

3. On 19 March 2021, the Single Judge issued the "Decision regarding the Registry's First Assessment Report, legal representation, and the victims' procedural position" (the "19 March Decision"),<sup>3</sup> appointing Mr Nasser Mohamed Amin Abdalla and Ms Amal Clooney as the joint legal representatives of victims admitted to participate in the proceedings and providing further guidance on the modalities of victims' participation, including at the confirmation hearing.

4. On 19 April 2021, by e-mail, the Chamber instructed the parties, the participants and the OPCV to submit their observations on the organisation of the confirmation of charges hearing by 23 April 2021.<sup>4</sup> On 20 April 2021, by e-mail, the Chamber clarified

that two teams of lawyers representing victims will be authorised at the confirmation hearing.<sup>5</sup>

## II. JOINT SUBMISSIONS ON THE CONDUCT OF THE CONFIRMATION OF CHARGES HEARING

5. The Legal Representatives of the Victims and Counsel from the OPCV (jointly "Counsel") hereby file the following joint submissions on the organisation of the confirmation of charges hearing.

6. In accordance with paragraph 36 of the 19 March 2021 Decision<sup>6</sup> – authorising, *inter alia*, the Legal Representatives to make opening and closing statements at the confirmation hearing in accordance with rule 89(1) of the Rules of Procedure and Evidence (the "Rules") – Counsel request two hours *per* team to cover both the opening and the closing statements.

7. Pursuant to paragraph 37 of the 19 March 2021 Decision<sup>7</sup> – granting the Legal Representatives the possibility to make submissions on the admissibility and/or relevance of any item of evidence – Counsel reserve their right to intervene on this issue, if necessary, to protect the interests of the victims, and subject to the Prosecution's and Defence's evidentiary submissions.

8. Lastly, following the consistent practice of the Court,<sup>8</sup> and pursuant to paragraph 36 of the 19 March 2021 Decision,<sup>9</sup> Counsel request 30 minutes *per* team to
